BANKRUPTCY ORDER

ON THE APPLICATION of Rentals 24/7 (London) Inc. a creditor, having a head office in the City of London, in the Province of Ontario, issued on [July 18th, 2022](#);

AND UPON reading the material filed by counsel for the Applicant and upon being advised that Robson Restoration Inc. does not oppose the Application, although duly served, the Notice of Hearing and Affidavit of David Machado sworn on June 9, 2022 as appears from the affidavit of service, filed,

AND IT APPEARING to the Court that the following acts of bankruptcy have been committed:


Robson Restoration Inc. has within the six (6) months next preceding the 1st day of July, 2022 has ceased to meet its liabilities generally as they become due.

THE COURT HEREBY ORDERS that Robson Restoration Inc. which at some time in the six (6) months next preceding the 1st day of July, 2022 carried on business in the City of London, in the Province of Ontario, be and it is hereby adjudged bankrupt and a Bankruptcy Order is hereby made against the said Robson Restoration Inc. on this date.

THE COURT FURTHER ORDERS that MNP Ltd., having an office in the City of London, in the Province of Ontario, be appointed as Trustee of the estate of the bankrupt.

THE COURT FURTHER ORDERS that the Trustee give security in cash or by bond or suretyship without delay, in accordance with subsection 16(1) of the *Bankruptcy Act*.

THE COURT FURTHER ORDERS the costs of and incidental to this Application for Bankruptcy Order be paid to the Applicant Creditor out of the assets of the Estate upon taxation thereof.
