MINUTES OF THE JUNE 8, 2021 MEETING OF CREDITORS IN THE MATTER OF THE BANKRUPTCY OF TERRA FIRMA DEVELOPMENT CORPORATION LIMITED (ORDINARY ADMINISTRATION)

THE MEETING was called to order at 14:05 Atlantic Standard Time (AST), on June 8, 2021.

ATTENDANCE The meeting was conducted via Microsoft Teams due to the COVID-19 pandemic. The Trustee sent notice of the meeting to all creditors who had submitted a claim as at the date of the notice, whether proven or not. Invitees were asked to respond to the invitation by requesting a link to the Microsoft Teams Meeting. The attendance list has been extracted from Microsoft Teams and is attached hereto as **Appendix A**.

Mr. J. Eric Findlay, CIRP, LIT, CPA chaired the meeting pursuant to subsections 105(1) and 105(2) of the *Bankruptcy and Insolvency Act* (BIA):

The trustee shall be the chair of all meetings subsequent to the first meeting and has the authority to decide any question or disputes arising at the meeting. Creditors may appeal any decision made by the chair to the court.

THE CHAIR introduced themselves and declared the meeting properly called and a quorum duly present.

THE PURPOSE OF THE MEETING was to vote on the appointment of inspectors to fill the vacancies on the Board of Inspectors.

THE CHAIR discussed the voting process and the details surrounding those who are eligible to vote, which included the following:

- Only creditors with claims proven before the meeting were entitled to bring Motions and vote at the meeting.
- Proven creditors who were not dealing with Terra Firma Development Corporation Limited ("TFDC") at arms length within one year prior to the bankruptcy were restricted from voting.
- Votes were based on the dollar amount of the creditor's unsecured proven claim.
- Secured creditors could only vote the amount of their anticipated deficiency.
- A simple majority vote is required to pass Motions.

BACKGROUND the Chair provided those in attendance with a summary of events with respect to the establishment of the Board of Inspectors (the "Board") to-date being:





- At the First Meeting of Creditors ("FMOC"), three (3) inspectors were elected:
 - Gavin MacDonald, a lawyer from Cox & Palmer representing Project Forest Lakes
 Pte Ltd. and a number of Singapore investors.
 - Peter Hutchinson of AV Corporate Services representing the Delaware LLC's.
 - Chadi Charara, a creditor of TFDC.
- Since the FMOC, there had been inquiries from several parties asking if they could be added to the Board.
- There is room for only five (5) members on the Board, and only proven creditors may appoint inspectors at a properly called meeting of creditors.
- MNP issued a call for expressions of interest on March 9, 2021, with a deadline for candidate submissions of March 31, 2021. The responses that were received prior to the deadline were as follows:
 - Ahmad Durani Razad Khan, nominated by My Premier Trustee (Malaysia) Berhad.
 - Michael Blades of Pink Larkin, nominated by S+C Treuhandgellschaft mbH and Steiner & Company GmbH & Co KG.
 - Gerhard Dubois, a Delaware LLC member, nominated by Peter Marr.
 - Eric Tierling, a Delaware LLC member, nominated himself.
- The following list of individuals expressed interest after the set deadline:
 - Mohamed Amozlouf, a TFDC creditor, nominated himself.
 - Tan Jui Chai, a TFDC creditor, nominated by Gavin MacDonald.
 - Yong Yoke Chuang, a Delaware LLC member, nominated by Gavin MacDonald.
- The Chair provided background on the eligibility of an individual to act as an Inspector, noting that no person is eligible to be appointed or act as an inspector who is a party to any contested action or proceedings by or against the estate of the bankrupt, pursuant to subsection 116(2) of the BIA.
- The Chair announced the resignation of Gavin MacDonald, who was originally appointed an inspector, due to a conflict of interest.
- The Chair also announced that Chadi Charara has a possible conflict, and while Mr. Charara had been asked for his resignation, he has not tendered such.

MOTION TO REMOVE MR. CHARARA FROM THE BOARD OF INSPECTORS

The Chair called for a motion to remove Mr. Charara from the Board of Inspectors. The motion was moved by Marcus Huth, representing himself and was seconded by Awsam El Faramawy, representing himself. The Chair asked those in attendance with proven claims if there were any objections to the removal of Mr. Charara from the Board of Inspectors; there were no such objections. The motion was carried, and Mr. Charara was announced as being removed from the Board.

THE CHAIR announced that, as a result of the above-noted resignations, there were four (4) positions to fill on the Board of Inspectors. Awsam El Faramawy asked the Chair why the three (3) replacements that were elected in the first meeting of creditors are not being considered and inquired why those nominees



are not replacing the resigned board members. The Chair indicated that there were no elected replacements, and clarified the meaning of "seconding" in moving a motion, which Mr. El Faramawy may have confused as being a second option or replacement for a Board member.

Another creditor then asked if the Inspector candidates could give the creditors some background on themselves. The four (4) inspector candidates and the three (3) candidates who expressed interest after the deadline all introduced themselves individually and provided brief personal backgrounds and qualifications.

MR. AMOZLOUF suggested that the other candidates were better-suited for the inspector role than he. As such, the Chair asked Mr. Amozlouf to clarify if he was standing-down from his potential candidacy, which was confirmed by Mr. Amozlouf.

MR. HUTCHINSON the only Inspector now remaining on the Board, resigned his position citing his desire to allow an additional Delaware LLC member to act in his place.

THE CHAIR announced that as a result of the resignation of Mr. Hutchinson, there were now five (5) positions available on the Board. The Chair suggested moving forward with the voting if there were no other questions or comments from those in attendance.

MOTION TO ALLOW LATE NOMINATIONS TO BE ELIGIBLE CANDIDATES

The Chair called for a motion to allow the late nominations to be considered as eligible candidates. The motion was moved by Gavin MacDonald, representing various Singapore investors and was seconded by Mohamed Amozlouf, representing himself. The chair asked those in attendance with proven claims if there were any objections to the said motion. No objections were raised. The motion was carried, and the Chair announced that there was now officially six (6) candidates.

The Chair directed a question to the six (6) candidates, asking if any of the candidates wanted to stand-down to simplify the voting and election process. None of the candidates were willing to do so, and thus six (6) candidates remained in the election to fill the vacant positions on the Board.

A MEETING ATTENDEE asked for clarification on how many votes each creditor is entitled to. The Chair confirmed that each proven creditor can vote in favour of up to five (5) candidates. The Chair asked the creditors for suggestions regarding the voting process. Gavin MacDonald suggested allowing Peter Hutchinson of AVCS, representing the Delaware LLC's and Michael Blades of Pink Larkin, representing S+C Treuhandgellschaft mbH and Steiner & Company GmbH & Co KG to cast their votes first since they owned the majority of the total votes — therefore, if both voted in the same direction, the process could move along quickly.

MR. HUTCHINSON requested that the creditors vote on the three (3) Delaware LLC member candidates first – Gerhard Dubois, Eric Tierling and Yong Yoke Chuang.

MOTION TO APPOINT GERHARD DUBOIS TO THE BOARD OF INSPECTORS

The Chair called for a motion to appoint Gerhard Dubois to the Board of Inspectors. The motion was moved by Peter Hutchinson and was seconded by Dr. Rupert Poeschl. Votes in favour were cast by Peter Hutchinson and Michael Blades. The Chair announced that Mr. Dubois had been elected as an inspector.

MOTION TO APPOINT ERIC TIERLING TO THE BOARD OF INSPECTORS



The Chair called for a motion to appoint Eric Tierling to the Board of Inspectors. The motion was moved by Peter Marr and was seconded by Lothar Holland-Nell. Votes in favour were cast by Peter Hutchinson and Michael Blades. The Chair announced that Mr. Tierling had been elected as an inspector.

MOTION TO APPOINT YONG YOKE CHUANG TO THE BOARD OF INSPECTORS

The Chair called for a motion to appoint Yong Yoke Chuang to the Board of Inspectors. The motion was moved by Peter Marr and was seconded by Gavin MacDonald. Votes in favour were cast by Peter Hutchinson and Michael Blades. The Chair announced that Mr. Chuang had been elected as an inspector.

MOTION TO APPOINT MICHAEL BLADES TO THE BOARD OF INSPECTORS

The Chair called for a motion to appoint Michael Blades to the Board of Inspectors. The motion was moved by Michael Blades and was seconded by Dr. Rupert Poeschl. Votes in favour were cast by Peter Hutchinson and Michael Blades. The Chair announced that Mr. Blades had been elected as an inspector.

MOTION TO APPOINT TAN JUI CHAI TO THE BOARD OF INSPECTORS

The Chair called for a motion to appoint Tan Jui Chai to the Board of Inspectors. The motion was moved by Peter Marr and was seconded by Lothar Holland-Nell. Both Peter Hutchinson and Michael Blades abstained from voting, therefore the other creditors were called upon. Votes in favour included Gavin MacDonald, Peter Marr and Holger Bach. There were no votes against. The resolution was suspended temporarily in order to gather votes on the remaining candidate.

MOTION TO APPOINT AHMAD DURANI RAZAD KHAN TO THE BOARD OF INSPECTORS

The Chair called for a motion to appoint Ahmad Durani Razad Khan to the Board of Inspectors. The motion was moved by Peter Marr and was seconded by Mohamed Amozlouf. Both Peter Hutchinson and Michael Blades abstained from voting, therefore the other creditors were called upon. Votes in favour included Awsam El Faramawy and Mohamed Amozlouf. There were no votes against.

REVIEW OF THE VOTES In Favour of Tan Jui Chai: 7,294,477.71. In Favour of Ahmad Durani Razad Khan: 285,191.05. Result: Tan Jui Chai appointed as inspector.

QUESTIONS There were a number of general questions brought by the floor to the Chair during the course of the meeting which were addressed and discussed throughout the meeting. There were no additional Motions brought forward outside of the Motions noted herein.
