#### **Introduction and Purpose of the Report**

- 1. MNP Ltd. was appointed Receiver of 1287839 Alberta Ltd. ("Kopala"), Pricope Matwychuk Holdings Ltd. ("PM Holdings"), Fehr Quality Contracting Inc. ("Fehr") and 101279740 Saskatchewan Ltd. ("101") (collectively referred to herein as the "Company") pursuant to an March 29, 2018 Court of Queen's Bench of Alberta (the "Court") Order (the "Receivership Order").
- 2. The Company operated an oilfield services company with locations in Bonnyville, Alberta and Conklin, Alberta. The Company provided water/waste management services primarily to the oil and gas industry.
- 3. The principal Shareholders and Directors of the Company are Alex Pricope and Christina Matwychuk (the "Directors").
- 4. This is the Receiver's Second Report to Court (the "Second Report") and it should be read in conjunction with the Receiver's First Report to Court (the "First Report") dated April 13, 2018. The purpose of the Second Report is to advise the Court with respect to the following matters:
  - Initial Activities of the Receiver;
  - Employees;
  - Assets:
  - Solicitation of Auction Proposals:
  - Priority Creditors and Secured Creditors;
  - Interim Statement of Receipts and Disbursements; and,
  - Professional Fees.

#### **Initial Activities of Receiver**

- 5. On March 29, 2018 the Receiver (and its agent) attended to the Company premises in Bonnyville, Alberta (the "Bonnyville Premises") and Conklin, Alberta (the "Conklin Premises") to take possession and secure the assets. The Receiver met with the employees on site as well as the Directors. As the Receivership Order was granted by consent, the Directors had already substantially halted business operations and taken steps to relocate the offsite assets to the Bonnyville Premises for safekeeping and security.
- 6. The Receiver met with the employees of the Company and explained the receivership process and the administration of the Wage Earner Protection Program Act ("WEPPA").
- 7. The Directors and employees of the Company assisted the Receiver with the collection of all pieces of equipment (with the exception of a small number of assets located on customer sites) in order to relocate the equipment to the yard at the Bonnyville Premises.
- 8. The Receiver changed locks at each of the Bonnyville Premises and the Conklin Premises and engaged local agents to regularly monitor the properties.
- 9. With the assistance of the Directors, the Receiver took steps to winterize certain pieces of equipment located at the Bonnyville Premises.
- 10. During the process of taking possession of the property of the Company the Receiver has also:
  - Re-directed the mail;
  - Ensured continuity of utilities to the properties;
  - Secured the internal accounting information:
  - Collected relevant books and records:
  - Recorded an inventory of the assets: and
  - Contacted the financial institution to freeze bank accounts.
- 11. The Receiver confirmed that the current insurance policy of the Company was severely in arrears and that the insurer no longer wished to continue the policy. The Receiver contacted its own insurance agent and placed insurance coverage over the equipment and real property.
- 12. As detailed in the First Report, the Receiver obtained an insurance policy through its own insurer, AON Parizeau Inc., on April 6 2018 and notified the existing insurance Broker, MHK Insurance Inc. on the same date that existing insurance policy was no longer required.
- 13. As a precaution, the Receiver was advised that the property at the Conklin Premises was at high risk of vandalism if left vacant, so the Receiver retained and posted security guards at this location.
- 14. The Directors are monitoring the Bonnyville Premises in order to conform with the vacant-property insurance requirement and to deter potential theft or vandalism.
- 15. The Receiver reconciled the inventory of equipment as against the Personal Property Registry ("PPR") and Company books and records. No equipment has been unaccounted for as a result of the reconciliation.
- 16. The Receiver released one (1) truck secured to Daimler Truck Financial ("DTF") to a bailiff who attended the Bonnyville Premises on its behalf.

**Employees** 

- 17. Subsequent to the initial possession taking and termination of the employees, the Receiver administered WEPPA providing each of the employees with a copy of the required documentation to file a claim for unpaid wages, vacation and termination pay.
- 18. In accordance with the books and records of the Company, twenty-four (24) employees were eligible to file claims under WEPPA. Twenty-one (21) were employed by Kopala and three (3) were employed by Fehr.
- 19. Records of Employment have been issued to each of the employees of the Company based upon the information available within the Company books and records. The Receiver, with the assistance of the Company's payroll service provider, Ceridian, is in the process of preparing the 2018 T4's.
- 20. The Receiver retained certain of the Company's employees (on a contract basis) for a 1-2 day period immediately following the Receivership to assist with the relocation and securing of the assets.

#### **Assets**

- 21. The Company assets are comprised of the following:
  - a. Real property located in Conklin, Alberta (commercial) and two parcels of real property in Bonnyville, Alberta (residential and commercial);
  - b. Equipment, Chattels, and Inventory;
  - c. Accounts Receivable;
  - d. Funds on Deposit; and,
  - e. Potential refund of balance of unearned insurance premium.

#### Real Property

- 22. In accordance with a May 3, 2018 Land Title Search of the Bonnyville Premises, the real property (legally described as Ptn NE 10-61-6-W4 Plan 0622913 Block 1, Lot 1) is registered in the name of PM Holdings. The Bonnyville Premises consists of approximately 6.75 acres located within the Municipal District of Bonnyville, AB and includes a large combined office and shop space, a secondary wood frame building and second office structure. A copy of the May 3, 2018 Land Title search for the Bonnyville Premises is attached as **Schedule A**.
- 23. An appraisal of the Bonnyville Property was completed in November 2015 by Atlas Appraisals. The Receiver retained Atlas Appraisals to commission an updated appraisal on the Bonnyville Premises in April, 2018 (the "Updated Atlas Appraisal"). A copy of the Updated Atlas Appraisal is attached as **Schedule A** to the Confidential Addendum to the Receiver's Second Report (the "Confidential Addendum").
- 24. The Receiver has issued a Request for Listing Proposals (the "Listing RFP") to commercial realtors in both the local Bonnyville market and larger surrounding centres (e,g. Edmonton). The Listing RFP process expires on May 11, 2018.
- 25. In accordance with a May 3, 2018 Land Title Search of the Conklin Premises, the real property (legally described as Plan 1021643, Block 1, Lot 156) is registered in the name of PM Holdings. The Conklin property consists of approximately 6.84 acres located within the Regional Municipality of Wood Buffalo and includes a newer residential manufactured home.

a secondary residential building and a workshop building. A copy of the May 3, 2018 Land Title search for the Conklin Premises is attached as **Schedule B.** 

- 26. Prior to the granting of the Receivership Order, the second position mortgagor of the Conklin Premises had initiated foreclosure proceedings and listed the property for sale with a local realtor. The listing agreement for the sale of the Conklin Premises had expired around or shortly before the granting of the Receivership Order.
- 27. The realtor involved in the foreclosure listing has advised the Receiver that there was little to no interest in the Conklin Premises while it was listed. At the Receiver's request, the realtor has revisited the property and provided the Receiver with a reduced recommended listing price that would likely see the Conklin Premises sell in a timelier fashion. Details on the reduced recommended listing price are outlined in the Confidential Addendum.
- 28. In accordance with a May 3, 2018 Land Title Search, the residential property (legally described as Plan 0622762, Block 1, Lot 1) (the "Residential Property") is registered in the name of PM Holdings. The Residential Property is a duplex located within the town of Bonnyville, AB. A copy of the May 3, 2018 Land Title search of the Residential Property is attached as **Schedule C.**
- 29. An appraisal of the Residential Premises was conducted by Atlas Appraisal Services in November 2015. The Receiver is in the process of having multiple realtors walk the property and submit proposals to list the Residential Premises for sale as well as offer recommendations on listing prices in line with current estimated market values.

#### Equipment and Chattels

- 30. Equipment and chattels are comprised primarily of rolling stock (truck and trailer units), pick up trucks, tanks, shop supplies and other miscellaneous equipment.
- 31. An equipment appraisal was completed in April 2018 at the request of the Receiver by Mirterra Corp. (the "Miterra Appraisal"). The Miterra Appraisal is attached as **Schedule B** to the Confidential Addendum.

#### Accounts Receivable

- 32. In accordance with the books and records of the Company, the accounts receivable of Kopala (the "Kopala AR") was listed at approximately \$1.6 million and the accounts receivable of Fehr (the "Fehr AR") (collectively as "Total AR") was listed at approximately \$70,500 as of the date of Receivership. The Receiver engaged the existing book keeper to assist with completing the final invoices and submitting the invoices to the various customers. Based upon the Receiver's investigation and information provided by management:
  - A majority of the outstanding invoices were issued in late 2017/early 2018; and
  - A majority of the outstanding AR is considered collectible.
- 33. As of May 3, 2018 the Receiver has collected a sum of approximately \$169,825 of the Total AR (\$29,609 of which is in the process of being transferred into the Receiver's trust account).

### Funds on Deposit

34. The Company held operating bank accounts with Toronto Dominion Bank ("TD Bank") as at the date of Receivership. Deposits (mainly consisting of AR collections subsequent to the

- Receiver's appointment) totaling \$93,783.46 have been transferred from the TD Bank account to the Receiver's newly established trust account.
- 35. The Receiver has kept the Company's existing TD Bank account open, on a deposit only status, so as to cause no disruption in the collection of AR from who pay by way of electronic funds transfer or otherwise.

#### **Solicitation of Auction Proposals**

- 36. Prior to the Receivership appointment and with the consent of the Directors, the equipment lender requested that two (2) auction companies review the Company's assets with a view of providing a proposal.
- 37. Immediately upon appointment, the Receiver invited two additional auction companies to participate in the proposal process and made the assets available for inspection with the assistance of the Directors.
- 38. As a result of the auction proposal process, the Receiver received bids from each of the four (4) separate auction entities. Further detail and an analysis of the various auction proposals is described in the Confidential Addendum.
- 39. The Receiver has accepted the Guaranteed Minimum Auction Proposal submitted by Century Services Corp (the "Century Proposal") subject to the Court's approval.
- 40. Business Development Bank of Canada, the Company's primary equipment lender, TD Bank and the Directors have each expressed support to the Receiver of the acceptance of the Century Proposal.
- 41. The Receiver is seeking the Court's approval to accept the Century Proposal.

#### **Priority Creditors and Secured Creditors**

- 42. Based on statements from Canada Revenue Agency ("CRA"), Kopala was indebted on their Goods and Services Tax ("GST") account as of April 11, 2018 in the sum of approximately \$5,240. The Directors are in the process of filing the requisite GST return for March, 2018 wherein the final balance owing (or refund) will be known.
- 43. CRA has contacted the Receiver in order to perform a trust examination of the payroll source deduction account of Kopala and Fehr. The Receiver has gathered the required information and is in the process of scheduling the trust exam.
- 44. Service Canada will have a priority claim under Section 81.4 of the *Bankruptcy and Insolvency Act* to the current assets of Kopala and Fehr for distributions to the employees through the WEPP program. As there are 24 employees eligible for the program and as the priority claims are limited to \$2,000 per employee, the maximum priority claim of Service Canada is estimated to be \$48,000.
- 45. A letter received from Workers' Compensation Board ("WCB") indicated a balance owing on the Kopala account of \$75,565. Based on discussions with the Directors, it is believed that the balance owing may be significantly reduced once WCB has been provided with accurate payroll balances from the 2018 year. The Receiver is contacting WCB to confirm what additional information it requires.

- 46. In the event that the WCB debt is not significantly reduced or remains unchanged, or that the GST debt is substantial after the filing of the March 2018 GST return, the Receiver is seeking advice and direction from the Court with respect to assigning Kopala into bankruptcy.
- 47. TD Bank holds various security agreements including a General Security Agreement ("GSA") and mortgage security in relation to the Conklin Premises and Bonnyville Premises, detailed as follows:
  - a. A March 27, 2018 PPR search for PM Holdings confirms that TD Bank registered a GSA on October 26, 2010;
  - b. A March 27, 2018 PPR search for Kopala confirms that TD Bank registered a GSA on March 27, 2008;
  - c. A March 27, 2018 PPR search for 101 confirms that TD Bank registered a GSA on August 15, 2016;
  - d. A May 3, 2018 PPR search for Fehr confirms that TD Bank registered a GSA on May 30, 2014;
  - e. A May 3, 2018 Land Title search of the Conklin Premises confirm a mortgage registered on June 6, 2014; and,
  - f. A May 3, 2018 Land Title search of the Bonnyville Premises confirm a mortgage registered on June 6, 2014;
- 48. Business Development Bank of Canada ("BDC") holds security by way of specific serial numbered registrations and a GSA, detailed as follows:
  - a. A March 27, 2018 PPR search for Kopala confirms that BDC registered a GSA on August 11, 2016;
  - b. A March 27, 2018 PPR search for 101 confirms that BDC registered a GSA on August 11, 2016;
  - c. An May 3, 2018, 2018 PPR search for Fehr confirms that BDC registered a GSA on August 11, 2016; and,
  - d. A March 27, 2018 PPR search for PM Holdings confirms that BDC registered a GSA on August 11, 2016;
- 49. BDC refinanced the Company's equipment in 2016 and a subordination of security interest in the equipment, in favour of BDC, was entered into by TD Bank and BDC. The Receiver's counsel is reviewing the various loan agreements to confirm the validity, enforceability and priority status of the lenders' agreements.
- 50. Donald Glenn Fehr and Laurie Ann Fehr have a writ of enforcement registered against the Residential Premises in the sum of \$1,145,166 as well as mortgage for \$1,250,000, registered against the Conklin Premises.
- 51. MHK registered a security interest in all unearned insurance premium funds arising from the financing of insurance policy to Kopala. As detailed in the First Report, creditors other than MHK may have an interest in the unearned insurance premium in accordance with the various registered GSA's. By way of consent between the various interested parties, the monies in relation to the unearned insurance premium have been (or will be) placed into trust with MHK's counsel, pending a resolution as to priority to the funds or further order of the Court.
- 52. Paccar Financial Ltd. has security registered over five (5) of Kopala's Peterbuilt trucks (the "Paccar Trucks"). The Receiver's counsel has reviewed the security agreements and determined that the security is valid and enforceable. The Receiver is reviewing the pay out

valuations in respect of the Paccar Trucks in comparison with the appraised values to determine whether any equity is available for the Receivership estate.

- 53. DTF has security over one (1) 2015 Freightliner financed through Kopala (the "DTF Vehicle"). DTF seized the vehicle immediately upon the Receiver's appointment in accordance with a Court Order granted on March 29, 2018. The DTF Vehicle is currently in the possession of DTF until a decision is made as between DTF and the Receiver respecting the method of disposition.
- 54. TNT Tank & Trailer Repair LP/Servus Credit Union Ltd. ("TNT") has security registered against two (2) of Kopala's trailers. The Receiver has not yet received or reviewed the security of TNT to determine the validity and enforceability.
- 55. Writs of enforcement against the Kopala assets are registered by MJ's Water Hauling Co Ltd. and Ken Chaulk Contracting Corp.
- 56. First Truck Centre Lloydminster ("First Truck") registered a Garage Keepers' Lien against a 2012 Western Star and a 2007 Freightliner financed through Kopala. The Receiver is contacting First Truck to obtain detail on the and to determine its validity.
- 57. Two (2) of Kopala's vehicles are in the possession of Bonnyville Dodge who are owed monies for repairs done to the respective vehicles. The Receiver is reviewing the supporting documentation provided by Bonnyville Dodge to determine whether the liens are valid and, if so, whether it makes economical sense to pay the value of the liens so the vehicles can be released and sold.
- 58. Copies of the previously referenced PPR Searches for Kopala, Fehr, 101 and PM Holdings is attached as **Schedule D**.

### **Interim Statement of Receipts and Disbursements**

59. Attached as **Schedule E** is the Receiver's Interim Statement of Receipts and Disbursements for the period ending May 4, 2018.

#### **Professional Fees**

- 60. Attached as **Schedule F** is a summary of the Receiver's Fees and Disbursements as at May 4, 2018.
- 61. The Receiver has tracked its fees in accordance with activities related to three separate categories:
  - General Receivership;
  - Equipment and Chattels; and
  - AR and Real Property
- 62. Allocation of the costs of the Receivership (fees and disbursements) is expected to be completed with the Receiver's application for interim distribution of proceeds. This application is expected after the receipt of funds from the Century Proposal.
- 63. Attached as **Schedule G** is a summary of the legal fees and disbursements of the Receiver's counsel. The Receiver has reviewed the detailed billing of its counsel and is of the opinion that the fees and disbursements are fair and reasonable.

#### Conclusion

- 64. The Receiver respectfully submits this Second Report in support of an application for the following:
  - Approval of the Receiver's Activities to date as outlined in the First Report;
  - Authorization to accept the Century Proposal;
  - Authorization to list the Conklin Premises for a reduced value as detailed in the Confidential Addendum; and,
  - Assessment of the Receiver's fees and disbursements and the fees and disbursements of the Receiver's counsel.
