THE RECEIVER GIVES NOTICE AND DECLARES THAT:

On February 9, 2024, upon the application of Canadian Imperial Bank of Commerce ("**CIBC**"), the Court of King's Bench of Alberta granted an Order authorizing CIBC's agent to enter the property located at 4901 49th Street, Athabasca, Alberta for the purposes of inspecting and carrying out such measures as CIBC deemed necessary for the interim preservation and maintenance of the Property.

Also, on February 9, 2024, CIBC appointed MNP Ltd. as its agent (the "**Agent**") to realize on the assets, undertakings and properties of 793085 Alberta Ltd. ("**793 AB**" or the "**Company**") secured by CIBC (as further described below).

BACKGROUND

793 AB was incorporated in the Province of Alberta in July 1998 with Shauna Milner being listed as the sole director and shareholder. The Company operated a restaurant known as the 49th Street Grill out of the Property until its operations were discontinued on or about January 31, 2024.

ASSETS

Following its appointment, the Agent has taken steps to protect and preserve the Property, including retaining Veranova Properties to provide property management services, changing the locks, ensuring the Property is winterized and utility service is in place and arranging for go-forward insurance coverage. The Receiver is in the process of completing an inventory of the assets held at the Property, which includes various restaurant equipment.

To date, the Agent has been provided with only selected of the books and records of 793 AB.

CREDITORS

CIBC is currently owed approximately \$530,200 pursuant to various credit facilities. As noted above, CIBC holds a mortgage on the Property as well as a general security agreement over all of the Company's present and after-acquired property.

Canada Revenue Agency is currently estimated to have a claim of approximately \$251,500 for payroll source deductions and a claim of approximately \$20,500 for GST. In addition, based on the available books and records of the Company, the Company has unsecured creditors with claims totaling approximately \$51,200.

The list of the Company's known creditors is attached hereto as "Schedule 1".

PLAN OF ACTION

The Agent will be working with CIBC to assess various realization alternatives.
