UPON THE APPLICATION of the Bank of Nova Scotia ("BNS"), a creditor of B. Kennedy Architecture Inc. (the "**Debtor**"), a body corporate which carried on business in the City of Edmonton, in the Province of Alberta with a registered office located at 2610, 10111 – 104 Avenue N.W., Edmonton, Alberta, filed September 16, 2019 (the "**Application**"); AND UPON HAVING read the Application, the Affidavit of Verification of Statements in Application for Bankruptcy Order of Vernon Lewis sworn September 12, 2019, the Consent to

Act as Trustee of MNP Ltd. (the "**Trustee**") dated September 12, 2019, the Affidavit of Service of Lorraine Chanasyk sworn September 18, 2019, all filed; **AND UPON HEARING** from counsel for BNS and all other interested parties present;

**IT IS HEREBY ORDERED THAT:**

1. The time of service of the Application and all materials in support thereof on the Debtor, the Trustee, and the Division Office of the Office of Superintendent of Bankruptcy Canada is hereby abridged pursuant to Rule 70(1) of the *Bankruptcy and Insolvency General Rules*, C.R.C 1978, c. 368 to the date actually given and service of the Application and all materials in support thereof is hereby declared good and sufficient.
2. B. Kennedy Architecture Inc., a corporation registered in the Province of Alberta, is adjudged bankrupt by virtue of this bankruptcy order hereby made on this date.
