TRUSTEE'S PRELIMINARY REPORT

SECTION A - Background

Cirvis Consulting Inc. (the "**Company**") was incorporated on November 26, 2019. The Directors of the Company are Christoph Glaessel, Hendrik Peter Desch and Andreas Bremke.

The Company was a leading provider of business and management consulting services for travel, tourism and hospitality industry operating from Toronto Ontario. They offered various services in planning, research, development and operations. The Company was shut down at the outset of the pandemic, along with most of the travel industry, and it tried to pivot to sell specialty air filters. The Company built up an inventory of the air filters; however, sales were significantly lower than expected, which Managements believes was due to the high price of the units. It took the Company almost two years to sell 10% of the initial inventory purchased. Due to the ongoing financial struggles the Company made an assignment in bankruptcy on March 03, 2022 and MNP Ltd. Was appointed as trustee (the "T**rustee**").

CLASS I - Stocks of merchandise

There is an inventory of about 180 air filters. The inventory is in possession of MR Jutzi & Co. to be liquidated pending approval of inspectors appointed at today's meeting.

CLASS II - Plant, machinery, equipment, and office

The Company did not have any machinery or equipment.

CLASS III - Buildings and real estate

The Company did not own real estate.

CLASS IV - Books and records

The Trustee has taken possession of the books and records required to administer the bankruptcy.

CLASS V - Other assets

None known.
