It is not necessary for you to attend the FMOC to participate in the bankruptcy proceedings. If you do wish to attend, creditors are required to email the Trustee at epicure@mnp.ca with the subject line “FMOC Registration” by no later than **11:00am (PST) on February 19, 2025**. Information on how to attend the FMOC will then be provided.

In order to be eligible to vote at the FMOC, creditors must have completed and submitted a properly executed POC prior to the start of the meeting. Please submit your POC to epicure@mnp.ca. 




