**BANKRUPTCY ORDER**

Upon reading the application of Royal Bank of Canada, a creditor, of Interactive Vacation Rentals Inc., of the County of Bruce, in the Province of Ontario, filed October 9, 2024 and the Affidavit of Candida Hoyland sworn September 24, 2024;

And upon hearing submissions of counsel for Royal Bank of Canada;

And it appearing to the Court that the following act of bankruptcy has been committed:

- a) Interactive Vacation Rentals Inc. has ceased to meet its liabilities generally as they have become due in that among other things, it has failed to pay his obligations to the Applicant.

1. IT IS ORDERED that the said Interactive Vacation Rentals Inc. of the County of Bruce, in the Province of Ontario is hereby adjudged bankrupt and a bankruptcy order is hereby made against the said Interactive Vacation Rentals Inc.
2. IT IS FURTHER ORDERED that MNP Ltd. of the City of Toronto, in the Province of Ontario be and is hereby appointed trustee, without security, of the estate of the said bankrupt.

3. IT IS FURTHER ORDERED that the costs of the applicant creditor shall be paid out of the estate of the bankrupt upon taxation thereof.
