INTRODUCTION

- On December 4, 2019, Siksika Energy Resources Corporation ("SERC") and Siksika Energy
 Limited Partnership ("SELP") made assignments in bankruptcy pursuant to the *Bankruptcy and Insolvency Act*, RSC 1985, c B-3 (as amended) (the "BIA") and MNP Ltd. (the "Trustee") was
 appointed as trustee of the bankrupt estates of SERC and SELP (collectively, the "Bankrupt
 Estates").
- 2. On January 14, 2020, the first meetings of creditors for both SERC and SELP were held. There was no quorum present at the first meeting of creditors for SELP. There was a quorum present at the first meeting of creditors for SERC (the "SERC Meeting"). At the SERC Meeting, two inspectors were appointed (the "Inspectors").
- 3. On July 20, 2020, a Court Order (the "Consolidation Order") was granted that administratively and procedurally consolidated the proceedings for the bankrupt estates of SERP (action 25-2592139) and SELC (action no. 25-095053) such that all subsequent filings would occur under the SERC estate and action no. 25-095053 using the style of cause that appears on the face of this report (the "Second Report").

NOTICE TO READER

- 4. In preparing this report and making comments herein, the Trustee has relied upon certain unaudited, draft or internal financial information, including the Bankrupt Estates' books and records, and information from other third-party sources (collectively, the "Information"). The Trustee has not audited, reviewed or otherwise attempted to verify the accuracy of the Information in a manner that would wholly or partially comply with generally accepted assurance standards or other standards established by the Chartered Professional Accountants of Canada (the "Standards"). Additionally, none of the Trustee's procedures were intended to disclose defalcations or other irregularities. If the Trustee were to perform additional procedures or to undertake an audit examination of the Information in accordance with the Standards, additional matters may come to the Trustee's attention. Accordingly, the Trustee does not express an opinion, nor does it provide any other form of assurance on the financial or other information presented herein. The Trustee may refine or alter its observations as further information is obtained or brought to its attention after the date of this report.
- 5. The Trustee assumes no responsibility or liability for any loss or damage occasioned by any party as a result of the use of this Report. Any use which any party makes of this Report or any reliance or decision to be made based on the Report is the sole responsibility of such party.

PURPOSE OF THE REPORT

- 6. The Second Report is being filed in support of the Trustee's Application, scheduled to be made at a hearing on May 3, 2022 (the "May 3 Hearing"), at which the Trustee will be seeking the following relief:
 - 6.1. Approval to distribute the proceeds in the Bankrupt Estates (net of administrative fees and disbursements required to complete the administration of the Bankrupt Estates) to the Alberta Energy Regulator (the "AER") in partial satisfaction of their priority claim (the "AER Claim"); and
 - 6.2. Approval of the reported actions of the Trustee in administering these bankruptcy proceedings provided that only the Trustee, in its personal capacity and with respect to its own personal liability, shall be entitled to rely upon or utilize in any way such approvals.

BACKGROUND

- 7. SERC was incorporated in Alberta on December 18, 1995, for the purpose of having a Siksika Nation owned and managed oil and gas company. In March 2003, pursuant to a Limited Partnership Agreement (the "LP Agreement"), and as reflected in the results of an Alberta Partnership search, SELP was formed and duly registered. Siksika Energy Resources Trust ("SERT"), by its Trustee 1036258 Alberta Ltd. is the sole limited partner of SELP. The one and only general partner of SELP was, at all material times, SERC.
- 8. SERT is not bankrupt and its property has not vested in the Trustee being only a limited partner of SELP.
- 9. At the date of bankruptcy, SERC was listed as the operator of one well in southern Alberta (the "Well"), which was abandoned in March 2017. The Well was beneficially owned by SELP. In addition to their interest in the Well, the Bankrupt Estates had working interests in various oil and gas properties in Alberta (the "Working Interests"). Sproule Asset Management Limited ("Sproule") completed a review of the Well and the Working Interests and determined that they did not have any realizable value and would have significant end-of-life obligations associated with them.

ACTIVITIES OF THE TRUSTEE

- 10. Since the date of the First Report, the Trustee has undertaken a number of activities including, but not limited to, the following:
 - 10.1. Collecting accounts receivable;
 - 10.2. Negotiating a settlement (the "SRDL Settlement") with respect to amounts allegedly owed from Siksika Resource Developments Ltd. ("SRDL");

- 10.3. Chairing four inspectors' meetings;
- 10.4. Communicating with stakeholders, including the Alberta Energy Regulator;
- 10.5. Quitclaiming the Working Interests and communicating with operators and working interest partners with respect to same; and
- 10.6. Updating and maintaining the Trustee's website.
- 11. Upon the SRDL Settlement being finalized and the net realizations in the estate being distributed as set out below, the administration of the Bankrupt Estates will be complete and the Trustee will be seeking their discharge.

ABANDONMENT AND RECLAMATION OBLIGATIONS

- 12. The Alberta Energy Regulator (the "AER") has indicated that the consolidated Bankrupt Estates have a deemed liability for abandonment and reclamation obligations ("AROs") totalling up to approximately \$3.94 million. Attached as "Schedule 1" is a summary provided by the AER to the Trustee detailing the potential claims of operators for SERC's working interest portion of the AROs.
- 13. As set out in various recent Court decisions of the Supreme Court of Canada and the Alberta Court of Appeal, AROs are a continuing obligation of a bankrupt corporation and, although not provable in bankruptcy, to the extent there are assets in the estates, they effectively rank in priority to all other creditor claims. The Trustee has consulted with its independent legal counsel, who has advised that, based on the current case law and legislative authorities, the AER is in the superior position with respect to the disposition of the remaining assets of the estates (subject to withholdings for administrative fees and disbursements required to complete the administration of the Bankrupt Estates) and that direction from this Court should be sought to approve payment thereof to the AER. The authorities upon which independent legal counsel have relied upon in coming to this conclusion are set out in the concurrently filed Bench Brief in support of the Trustee's Application and may be discussed further at the May 3 Hearing
- 14. The AER has asserted a priority with respect to the net realizations in the Bankrupt Estates, the Trustee has entered into an agreement with the AER confirming that they will not object to the reasonable and appropriate fees of the Trustee and the Trustee's legal counsel relating to the administration of the Bankrupt Estates.
- 15. The Trustee is seeking, on notice to stakeholders, this Court's direction to distribute the net proceeds in the Bankrupt Estates, after the payment of all professional fees of the Trustee and its legal counsel, to the AER in partial satisfaction of the AER Claim (the "AER Distribution").

16. The AER has indicated to the Trustee that any distribution received from the SERC estate will be held in a "licensee-specific" account and that applicants who have completed closure and incurred associated costs on behalf of SERC (a working interest participant) may apply to the AER for Orphan Well Association reimbursement of SERC's proportionate working interest share of AROs. The Trustee is of the view that this proposal by the AER is appropriate and reasonable.

STATEMENT OF RECEIPTS AND DISBURSEMENTS

- 17. The Trustee has prepared an Interim Statement of Receipts and Disbursements for the Bankrupt Estates up to the April 25, 2022 (the "Interim R&D"). A copy of the Interim R&D is attached hereto as "Schedule 2". As reflected in the Interim R&D, as at April 15, 2022, approximately \$389,100 is being held in trust by the Trustee.
- 18. As noted above, the Trustee is currently finalizing the SRDL Settlement. Following completing the SRDL Settlement and the AER Distribution, the administration of the bankrupt estates will be complete and the Trustee will be seeking their discharge. The Trustee notes the following professional fees and disbursements, which have been paid or are estimated to complete the administration of the Bankrupt Estates:
 - 18.1. The Trustee's fees and disbursements total approximately \$120,500 plus GST for the period ended January 15, 2022. The Trustee estimates that professional fees of up to approximately \$20,000 plus GST will be required to complete the administration of the Bankrupt Estates.
 - 18.2. The Trustee's legal counsel's fees and disbursements total approximately \$24,600 plus GST for the period ended December 31, 2021. The Trustee's legal counsel estimates that professional fees of up to approximately \$10,000 plus GST will be required to complete the administration of the Bankrupt Estate.

RECOMMENDATION OF THE TRUSTEE

- 19. The Second Report has been prepared to provide the Court with information on the Trustee's application seeking the following relief:
 - 19.1. Approval of the AER Distribution, as further detailed above; and

19.2. Approval of the reported actions of the Trustee in administering these bankruptcy proceedings provided that only the Trustee, in its personal capacity and with respect to its own personal liability, shall be entitled to rely upon or utilize in any way such approvals.
