Notice to Creditors

Re: 1456982 Alberta Ltd. – in Bankruptcy ("1456982")

On November 29, 2019, an Initial Order was granted by the Court of Queen's Bench of Alberta under the *Companies' Creditors Arrangement Act, R.S.C. 1985 c. C-36, as amended* (the "CCAA") in respect of Tlicho Landtran Transport Ltd., 1456982, 1456998 Alberta Ltd. and Ventures West Transport Limited Partnership (collectively, the "Companies"). MNP Ltd. was appointed as Monitor (the "Monitor") in the CCAA proceedings.

Pursuant to a Court Order granted on September 9, 2020, the Court approved the Monitor making voluntary assignments in bankruptcy for the Companies pursuant to Section 49 of the *Bankruptcy and Insolvency Act*. The assignments were filed with the Official Receiver on October 2, 2020.
