THIS COURT ORDERS AND DECLARES THAT:

- The stay of proceedings against the directors of the Petitioners pursuant to the initial order pronounced in these proceedings on April 1, 2022, as amended and extended (the "Initial Order"), is hereby lifted and is of no force and effect against the Applicant in relation to claims set out in the Notice of Civil Claim filed September 13, 2021 in Action No. S-218110, Vancouver Registry (the "Claim").
- 2. This Order does not preclude or otherwise prejudice the Applicant's right to apply to lift the stay of proceedings as against the Petitioners for the purpose of allowing the Applicant to prosecute the Claim against the Petitioners to final judgment, including any appeals in relation thereto, provided that no enforcement steps shall be permitted

- against the Petitioners so long as the stay of proceedings in the Initial Order remains extant, or with further leave of this Court.
- 3. Endorsement of this Order by counsel appearing on this application other than counsel for the Petitioners and the Applicant is hereby dispensed with.
