
ON THE APPLICATION OF MNP Ltd. ("MNP Ltd") (formerly The Bowra Group Inc. ("TBGI")) in its capacity as Monitor of the Petitioners coming on for hearing at Vancouver, British Columbia on this date; AND ON HEARING Mishaal Gill, counsel for the Monitor, and NO ONE ELSE APPEARING; AND UPON READING the materials filed, including Affidavit #1 of Kevin Koo, made October 20, 2023; AND PURSUANT to the *Companies' Creditors Arrangement Act*, R.S.C. 1985 c. C-36, as amended (the "CCAA") and the inherent jurisdiction of this Honourable Court;

THIS COURT ORDERS AND DECLARES THAT:

1. The time for service of the Monitor's Notice of Application dated October 20, 2023, is abridged such that it is properly returnable today.

2. MNP Ltd. is hereby substituted as court-appointed monitor (in such capacity, the "Monitor") of 0989705 B.C. Ltd. (the "Company") under section 11.7 of the CCAA in place of TBGI effective as of February 14, 2023.
3. MNP shall be subject to all obligations, and is vested with all rights, powers and protections, granted under the Second Amended and Restated Initial Order made by the Honourable Madam Justice Fitzpatrick on August 11, 2022, all other orders of the Court made in these proceedings and the CCAA, *nunc pro tunc*.
4. TBGI is hereby discharged as monitor of the Company.
5. Endorsement of this order by counsel appearing on this application, other than counsel for the Monitor, is hereby dispensed with.
