UPON the application of Tłıcho Investment Corporation; AND UPON reviewing the order of the Honourable Justice Mah, granted February 28, 2020 (the "Auction Services Approval and Vesting Order"); AND UPON reviewing the order of the Honourable Justice Mah, granted March 6, 2020 (the "First Varying Order"); AND UPON reviewing the order of the Honourable Justice Renke, granted May 15, 2020 (the "Second Varying Order"); AND UPON reviewing the Fourth Report of the Monitor, dated May 19, 2020 (the "Fourth Report"), AND UPON noting the consent of the Applicant, the Monitor, and Canadian Imperial Bank of Commerce ("CIBC"); AND UPON being advised that no objections were received from the service list created in the within proceedings;

#### IT IS HEREBY ORDERED AND DECLARED THAT:

### **SERVICE**

1. Service of notice of this application and supporting materials is hereby declared to be good and sufficient, no other person is required to have been served with notice of this application and time for service of this application is abridged to that actually given.

### **DISTRIBUTIONS TO CIBC**

- 2. The Monitor, its counsel, or the Applicant are each hereby authorized to pay from time to time to CIBC such distributions from the net proceeds of the sale of Assets (as defined in the Auction Services Approval and Vesting Order) including any deposits paid in connection therewith, as are required to repay amounts owing by the Companies to CIBC under their secured credit facilities upon the filing date (the "Secured Indebtedness"), subject to such reasonable reserves of funds as the Monitor deems necessary:
  - (a) for the administration of these proceedings, and
  - (b) to satisfy applicable priority clams, including but not limited to the Lien Claims (as defined in the Third Report).
- 3. The reserve of funds for the Lien Claims (as defined in the Fourth Report) shall be no less than \$435,514 (the "Lien Claim Reserve").
- 4. The Lien Claim Reserve shall held in trust by the Monitor or its counsel pending a determination of the Lien Claims (as defined in the Fourth Report).

- 5. The Garage Keepers' liens described in Schedule "A" are hereby declared to be valid to the extent of the amounts described in Schedule "A" (the "Valid Lien Claims").
- 6. The Valid Lien Claims rank senior in priority to the security interests granted by the Companies in favour of CIBC.
- 7. The Monitor or its counsel are hereby authorized and directed to make distributions from the Lien Claim Reserve to satisfy the Valid Lien Claims.
- 8. The Monitor, its counsel, or the Applicant are each hereby authorized to make further payments to CIBC from available cash in the within proceedings other than the Lien Claim Reserve, in such amounts as are determined by the Monitor up to the amount of the Secured Indebtedness.
- 9. Service of this Order shall be deemed good and sufficient by:
  - (a) Serving the same on the persons listed on the service list created in these proceedings;
  - (b) Posting a copy of this Order on the Monitor's website at: https://mnpdebt.ca/en/corporate/Engagements/ventures-west-transport-limited-partnership

and service on any other person is hereby dispensed with.
