#### Email Endorsement

1. This is a motion MNP Ltd. ("MNP" or the "Liquidator"), in its capacity as Liquidator of the Applicants, First Hamilton Holdings Inc., First Hamilton Financial Services Inc., First Hamilton General Partner 2 Inc., First Hamilton Capital Inc., First Hamilton Mortgage Brokers Inc. (collectively the "First Hamilton").
2. On the motion, MNP seeks orders approving its activities, approving its fees and disbursements and approving a claims procedure. The motion is unopposed. I am satisfied that the relief sought should be granted.
3. This matter is related to two other motions I heard today involving Pace Securities under court file number CV-2000641059-00CL.

4. The matters are related in that First Hamilton sold many of the investments that were subject to the Pace Securities matters through its accounts at Pace Securities Corporation.
5. One of the hurdles facing a claims process was the large number of claims by investors against First Hamilton. That hurdle has now been removed by virtue of a settlement that will generate approximately \$40 million for the investors outside of the claims process.
6. As a result, MNP believes it is now appropriate to address the remaining outstanding claims of creditors of First Hamilton. MNP proposes to conduct the sales process in tandem with the Pace claims process with the claims bar date for both proceedings being January 14, 2022. That provides ample time for creditors to file claims.
7. Counsel can send the form of orders agreed upon directly to me for signing.
