Affidavit of Robert Corey

I, Robert Corey, of Brookside, Nova Scotia, make oath and say as follows:

1. I am the President of Blue Rose Gardening Inc. operating as The Gardener Halifax (the "Company").
2. I have personal knowledge of the evidence sworn to in this affidavit except where otherwise stated to be based on information and belief.
3. I state, in this affidavit, the source of any information that is not based on my own personal knowledge and I state my belief of the source.
4. The Company has been in business since 2018 and provides landscaping and yard maintenance services to residential and commercial customers throughout Halifax Regional Municipality including grass cutting, garden maintenance, lawn care, yard clean-ups, irrigation services, snow plowing and salting/sanding.
5. On July 20, 2023, the Company filed a Notice of Intention to Make a Proposal (the "NOI").
6. MNP Ltd. ("MNP") consented to act as trustee for the proposal and I have been working with MNP throughout the proposal process.
7. The need to file the NOI was necessitated by the Company's rapid growth together with labour shortages during the COVID-19 pandemic and poor financial management.
8. The NOI shows total claims of \$2,518,011.
9. The Company's largest creditors are:
 - Canada Revenue Agency (\$1,169,257);
 - Jim Pattison Industries Inc. (\$292,366);

- Business Development Bank of Canada (\$235,608);
- O'Regan's National Leasing (\$225,700);
- Kubota Canada Ltd. (\$165,300; and
- Mortley Investments Inc. (\$108,976).


10. Attached as Exhibit "A" is a summary of the Company's secured creditors which was prepared by my solicitor, Marc Dunning. I am informed by Mr. Dunning and do verily believe that this list accurately depicts the secured creditors of the Company.
11. Attached as Exhibit "B" is a PPRS Search Results Report dated August 2, 2023 showing each registered security interest attaching to the Company's personal property.
12. The Company owns no real property.
13. The Company has made changes to reduce overhead and improve margins on quotes and has engaged a firm to provide accounting and comptroller services, all of which have improved and will continue to improve the Company's financial position.
14. Since filing the NOI, the Company has actively been involved in:
 - a) developing an ongoing cash flow summary;
 - b) filing a cash flow statement and complying with its other obligations under s. 50.4(2) of the *Bankruptcy and Insolvency Act*;
 - c) discussions with MNP on what the terms of a proposal may include;
 - d) preliminary discussions with key creditors;
 - e) discussions with critical suppliers whose continuing supply is essential to the ability of the Company to continue operations; and
 - f) continuing to operate, seek out new work and new customers.
15. The Company needs to more fully organize and update its financial information and engage in more fulsome discussions with its key creditors before it will be in a position to put forward a viable proposal.
16. The Company will not be in a position to put forward a viable proposal by August 19, 2023 and is requesting an extension to the time to file a proposal for 45 days until October 3, 2023.
17. The Company has acted and continues to act in good faith and with due diligence in its efforts to develop a viable proposal.

18. I believe that the Company will be able to make a viable proposal if the extension is granted.


19. The Company anticipates the proposal to involve a settlement offer to unsecured creditors, terminating certain leases and a payment plan to address the CRA arrears.

20. I am not aware of any creditor that will be materially prejudiced if the extension is granted.




