

Upon the application by Mike Russell, counsel on behalf of MNP Ltd., the proposal trustee (the "**Proposal Trustee**") of 1143402 Alberta Ltd. ("**114**"), Canadian Development Strategies Inc., Crossroads One Inc., Oak and Ash Farm Ltd., ("**Oak and Ash**"), 1216699 Alberta Ltd., 2061778 Alberta Ltd. ("**206**"), Dean Runzer and Lori Runzer (collectively, the "**FireSong Group**"), and upon hearing from Mike Russell on behalf of the Proposal Trustee, and upon hearing from Lori Runzer, on behalf of the FireSong Group, and upon hearing from counsel on behalf of any other parties present, and upon reading the Notice of Application returnable on March 3, 2023, the Seventh Report of the Proposal Trustee, the Eighth Report of the Proposal Trustee, the Ninth Report of the Proposal Trustee, the Affidavit of Lori Runzer dated March 20, 2023, the Fiat of the Honourable Mr. Justice N. Bardai dated March 3, 2023, and the draft Order, all filed; and the pleadings and proceedings herein;

The Court orders:

SERVICE AND RULE 10-4(2)

1. Service of this Order may be effected electronically in accordance with the Service List established in these proceedings.
2. Pursuant to Rule 10-4(2) of the *Queen's Bench Rules* and the inherent jurisdiction of this Honourable Court, the requirements of Rule 10-4(2) shall be and are hereby waived.

APPROVAL OF FEES

3. The fees and disbursements (the "**Professional Fees**") of the Proposal Trustee and Trustee's Counsel, W Law LLP, described in and attached to the Seventh Report of the Proposal Trustee shall be and are hereby approved.


APPROVAL OF INCREASE TO ADMINISTRATION CHARGE

4. Pursuant to section 64.1 of the BIA and paragraph 2 of the December 13, 2021, Order, the Administration Charge (as that term is defined in the December 13, 2021, Order and as amended by the July 14, 2022, Order) shall be and is hereby increased from \$275,000.00 to \$400,000.00, both before and after the making of this Order. The Administration Charge is further hereby amended to exclude the assets of 206 and Oak and Ash.

DATE OF BANKRUPTCY

5. The date of Bankruptcy for each of 1143402 Alberta Ltd., Canadian Development Strategies Inc., Lori Runzer and Dean Runzer is hereby declared to be April 19, 2023.
