
ORDER

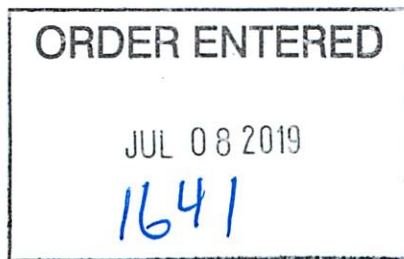
ON READING the Affidavit of Thomas William Downing, sworn June 24, 2019 and the First Report to the Court submitted by MNP Ltd. in its capacity as Trustee under the Notice of Intention ("MNP" or the "Trustee") dated June 24, 2019 (the "First Report"), and on hearing the submissions of counsel for CPC, and on being advised that the Bank of Montreal consents to the within Motion, no one else appearing on the Motion although properly served as appears from the Affidavit of Service of Cory Wood sworn June 25, 2019, filed:

1. **THIS COURT ORDERS** that the time for service, filing and confirmation of the Notice of Motion, Motion Record, and First Report be and is hereby abridged, if necessary, such that this Motion is properly returnable today and further service thereof is hereby dispensed with.

2. **THIS COURT ORDERS** that CPC be and is hereby granted an extension of an additional forty-five days in order to file a Proposal or seek a further extension such that a Proposal must be filed, or a further extension of time obtained, on or before August 25, 2019.
