This hearing was held in accordance with: (a) the Notice to the Profession issued by Chief Justice Morawetz on March 15, 2020 and the Update dated April 2, 2020; and (b) the "Changes to Commercial List operations in light of COVID-19" developed by the Commercial List judges in consultation with the Commercial List Users Committee. Box 95 <u>mfleming@foglers.com</u> The company seeks (i) an extension of the time to file a proposal (to June 18, 2020), (ii) approval to conduct a sale process and (iii) approval of the first report of the Proposal Trustee. This motion is unopposed. Specifically, it is not opposed by 1199541 Ontario Inc. (Secured Creditor) or by Micro Fines Recycling Oswego LLC (as confirmed by its counsel Mr. Ilchenko to Mr. Armagon). It is supported by the Proposal Trustee, for the reasons set out in paragraph 35 of its first report. I am satisfied that Ferrex is acting in good faith and with due diligence, that the extension should not adversely affect or materially prejudice creditors and that the sale process could position the company to make a viable proposal. I therefore consider it appropriate to grant the order, subject to the revisions I required made to the draft order – in particular, that paragraph 3 is subject to the provisions of the BIA. Mr. Armagon has amended the order accordingly.
