# IN THE MATTER OF THE NOTICE OF INTENTION TO MAKE A PROPOSAL OF FHC ENTERPRISES LTD. 


#### Abstract

AFFIDAVIT

I, Jason W. McDougall, businessman, of Delta, British Columbia, SWEAR THAT: 1. I am the sole director and officer of FHC Enterprises Ltd. ("Enterprises") and as such I have personal knowledge of the facts and matters deposed to in this affidavit, except where stated to be made on information and belief, in which case I verily believe those facts to be true.


## Background

2. Enterprises carries on business as the operating company for the Fields department store chain, which has been a fixture of the Western Canadian economy since 1948. Enterprises was incorporated on March 2, 2012 to acquire the Fields assets in an asset purchase sale from the previous owner, and has been operating the Fields business since that time.
3. Enterprises currently carries on business at 63 Fields stores and 1 McFrugals ' store in rural communities spanning the four western provinces and the Northwest Territories. Fields stores tend to operate in smaller communities and provide those towns' citizens with access to all manner of everyday products that might not otherwise be available locally.
4. Enterprises currently employs approximately 400 full- and part-time employees.
5. A company related to Enterprises, FHC Leasing Ltd. ("Leasing"), holds all of the leases for the locations out of which Enterprises operates its Fields stores. Pursuant to subleases between

Leasing and Enterprises, Enterprises pays the rent for all of the Fields store leases directly to the respective landlords.

## Causes of Financial Difficulties

6. The Fields business has been challenged by declining sales at a number of its locations, which can in turn be traced back to economic decline or disruption in the communities served by those locations, such as mill closures or the ongoing difficulties in Alberta's oil and gas industries. Declining revenue led to impending shortfalls in operating capital and, earlier this year, new financing to address this shortfall collapsed at the last minute.
7. It is management's view that some Fields locations are no longer viable, and that other locations can be returned to viability only if significant rent reductions, along with other costsavings, can be achieved.
8. The current COVID-19 crisis adds additional uncertainty to the outlook for Fields.

## Notice of intention to file a proposal

9. As a result of the foregoing challenges, Enterprises filed a Notice of Intention to Make a Proposal (the "Notice") under the Bankruptcy and Insolvency Act ("BIA") on March 6, 2020. MNP Ltd. was appointed as the Trustee under the Notice.
10. The gist of Enterprises' planned restructuring is to return the Fields business to profitability by eliminating non-viable locations and renegotiating rent terms for other marginal locations, if possible. Cost-cutting measures are being undertaken to reduce overhead and improve overall profitability. Compromises in the outstanding amounts owing to the Enterprises unsecured creditors will also be necessary. It is Enterprises' intention to file a formal proposal under the BIA which will provide for its continued operations and which will pay to its present creditors more than if Enterprises were to cease operations and liquidate.

## Assets of Enterprises

11. As previously mentioned, Enterprises does not own any of its locations. Its assets consist primarily of inventory along with tenants' improvements, computers, electronic equipment and software used in running the Fields stores, and intellectual property including trademarks interests.
12. Enterprises' single biggest asset group is its inventory. Inventory levels are used to determine the extent of its available borrowing facilities with its primary secured creditor, Royal Bank of Canada ("RBC"). As at the date of the filing of the Notice, Enterprises had inventory worth approximately $\$ 15,000,000$ at cost.
13. On January 28, 2020, an appraisal of Enterprises' inventory assets was performed by Tiger Valuations Services, LLC, setting out valuations in a liquidation scenario. This appraisal has been made available to MNP Ltd., the Trustee under the NOI. Management does not wish to publicly disclose this appraisal at the present time, but the values indicated are considerably lower than the above cost valuation.
14. It is difficult to estimate what values the other assets of Enterprises, such as intellectual property, might be worth in the present market conditions, or if Enterprises were to become bankrupt.

## Creditors of Enterprises

15. Attached as exhibit "A" to this affidavit is a copy of the list of creditors of Enterprises as at the date of the filing of the Notice. As indicated in the list of creditors, I estimated that the total amount owing by Enterprises to all its creditors as at the date of the Notice was about $\$ 17,518,731.35$, comprising $\$ 12,209,919.61$ owing to secured creditors, and $\$ 5,308,811.74$ owing to unsecured creditors.
16. Attached as exhibits " $B$ " to " $F$ " to this affidavit are copies of the search results, as at March 27, 2020, for the Personal Property Registries in the four western provinces and the Northwest Territories in which Enterprises operates, disclosing the parties with registered financing statements against Enterprises in those Registries.
17. Many of the security registrations in these Registries, for example by CWB National Leasing Inc. (formerly National Leasing Group Inc.), De Lage Landon Financial Services Canada Inc., Excel Leasing Inc., Gould Leasing Inc., and Zeemac Vehicle Lease Ltd., relate to specific equipment financings. In this affidavit I will focus on the secured creditors who have registered general security interests over all the assets of Enterprises.
18. The first secured creditor of Enterprises, in all jurisdictions in which it operates, is RBC, either by virtue of its timing of registration in the relevant Personal Property Registry, or by virtue of priority agreements entered into with other secured creditors. As at the date of the filing of the Notice, the amount owing to RBC was approximately $\$ 8,941,000$.
19. Although First West Credit Union appears as a secured creditor of Enterprises, they have in fact been paid in full, other than a prepayment penalty of about $\$ 30,000$.
20. Another secured creditor of Enterprises is Radco Ventures Inc., which holds a secured convertible debenture in Enterprises for the principal amount of $\$ 687,500$.
21. Also holding security are two creditors related to Enterprises, 1007070 B.C. Ltd. and 0988474 B.C. Ltd. 1007070 B.C. Ltd. has been advancing funds to Enterprises pursuant to a revolving credit facility and general security agreement, and is owed about $\$ 1,768,919.61$ as at the date of the filing of the Notice.
22. 0988474 B.C. Ltd. holds a secured convertible debenture in Enterprises for the principal amount of $\$ 250,000$.
23. Another secured creditor appearing in the British Columbia Personal Property Registry is Her Majesty the Queen in Right of the Province of British Columbia, which registered a general security interest in that Registry on March 10, 2020 over all of the personal property of Enterprises pursuant to the Miscellaneous Registrations Act for unremitted Provincial Sales Tax. PST of about $\$ 112,952$ was owing by Enterprises as at the date of the filing of the Notice
24. Kry Innovations Inc. also holds a secured convertible debenture in Enterprises for the principal amount of $\$ 500,000$. As of March 27, 2020, Kry Innovations Inc. had not registered a
security interest in any of the above Personal Property Registries.
25. M \& M Footwear Inc. also holds a secured convertible debenture in Enterprises and is owed a principal amount of $\$ 62,500$. As of March 27, 2020, M \& M Footwear Inc. had not registered a security interest in any of the above Personal Property Registries.
26. To the best of my knowledge, Enterprises has since the date of the Notice made all payments when due to all statutory creditors including PST and CRA on account of remittances for source deductions under the Income Tax Act and GST under the Excise Tax Act.

## Extension for filing of the Proposal

27. Enterprises and Leasing are in discussions with various landlords of the non-viable Fields stores for a solution that would enable Enterprises to become profitable again, whether by a reduction in rent or a disclaimer of the respective leases, as the case may be.
28. It is anticipated that within a further 45 -day time period, Enterprises will have made significant progress in its discussions with various of the landlords and will be able to formulate a proposal to put to its creditors, although a further extension may also be necessary.
29. Since the filing and delivery to creditors of the Notice, I have had numerous conversations with Enterprises' creditors. None of those creditors, including the secured creditors, have raised with us any objection to the extension now being requested by Enterprises. In particular, RBC, which is represented by Vancouver counsel, has advised that it is not opposed to the requested extension.
30. To the best of my information and belief:
a) Enterprises is acting in good faith and due diligence in pursuing a restructuring that will avoid its liquidation;
b) Enterprises will likely be able to make a viable proposal if the requested extension is granted; and
c) No creditor will be materially prejudiced if the requested extension is granted.

## Payment to MNP

31. I have been provided with a copy of the Trustee's invoice, dated March 26, 2020, for services rendered to March 20, 2020 in the amount of $\$ 60,847.35$. I consent to the Trustee being paid out of trust as requested, subject to approval of the Court.
