Remedy Claimed or Sought:

- 1. An Order, substantially in the form attached herein as Schedule "A" sealing the Confidential Supplement to the Fourth Report of the Proposal Trustee dated July 7, 2022 (the "Confidential Supplement") until further order of the Court.
- 2. Such further and other relief as may be sought by the Proposal Trustee and this Honourable Court may deem appropriate.

Grounds for Making this Application:

- 3. On February 4, 2022, Vertex Downhole Ltd. ("**Vertex**") commenced the within proceedings (the "**NOI Proceedings**") by filing a Notice of Intention to Make a Proposal (the "**NOI**") pursuant to section 50.4(1) of the *BIA* with the Office of the Superintendent of Bankruptcy. MNP Ltd. is the proposal trustee of Vertex (in such capacity, the "**Proposal Trustee**" or "**MNP**").
- 4. A Sales and Investment Solicitation Process ("SISP") was ordered by the Court on March 4, 2022. The Phase II Bid Deadline for Phase 2 bidders to submit Definitive Agreements in order to become Qualified Phase 2 Bidders (each as defined in the SISP) was June 29, 2022.
- 5. The Proposal Trustee has reviewed and analyzed all of the Qualified Phase 2 Bids and has made a recommendation to Vertex and HSBC Bank of Canada ("**HSBC**"), Vertex's senior secured lender, which Qualified Phase 2 Bid should be the "Successful Bid" as defined under the SISP. All of the Qualified Phase 2 Bids are attached as appendices to the Confidential Supplement.
- 6. HSBC has brought a concurrent application with this application to appoint MNP as the receiver-manager of Vertex and for a sale approval and vesting order of the Qualified Phase 2 Bid MNP has recommended as the Successful Bid. This Qualified Phase 2 Bid has been revised by MNP and the purchaser to reflect that a receiver will be entering into the transaction and not Vertex. The revised agreement has been attached as an appendix to the Confidential Supplement.
- 7. The Confidential Supplement includes all of the Qualified Phase 2 Bids and the bid recommended by MNP as the Successful Bid arising from the SISP which, if MNP is appointed as receiver of Vertex, will be entered into by MNP as receiver and the purchaser.
- 8. There exists an important commercial interest to ensure that the Qualified Phase 2 Bids and the Successful Bid remain sealed until 30 days following the closing of a transaction to ensure the purchase price and terms for the bids remain confidential in the event the transaction does not close between MNP as receiver of Vertex and the purchaser.
- 9. The Court also previously granted a Sealing Order dated May 27, 2022 sealing the Confidential Supplement to the Third Report of the Proposal Trustee dated May 18, 2022, which enclosed prior Phase I Letters of Intent filed in the SISP by the Qualified Phase 2 Bidders. The Court provided a

sealing order until August 4, 2022, or until further order of the Court. In order to continue to protect the commercial interests of the stakeholders, the Proposal Trustee is also seeking a continuation of the prior Sealing Order so to continue to seal the Confidential Supplement to the Third Report until 30 days after the closing of the transaction or until further order of the Court.
