2. That on the 13th day of November 2020, we gave notice to the debtor, to the division office and to every known creditor affected by the proposal, whose names and addresses are shown in Exhibit "B" to this report, of the calling of a meeting of creditors to be held on the 4th day of December 2020 to consider the proposal.
3. That with the notice was included a condensed statement of the assets and liabilities of the debtor, a list of the creditors affected by the proposal who have claims of \$250 or more and showing the amounts of their claims, a copy of the proposal, a form of proof of claim and proxy in blank and a voting letter. 9. That we are also of the opinion that:

(a) the causes of the insolvency of the debtor are as follows:

due to the catastrophic collapse of world oil prices in spring of 2020 and the dramatic drop in oil and gas demand as a result of the COVID-19 pandemic. This resulted in all but two wells (the "Little Bow Wells") being shut in by Zargon in the spring of 2020. In November 2020, one of the Little Bow Wells was also shut in and 02/11/32/14/W4 is the loan well that remains in production.

(b) the conduct of the debtor is subject to censure in the following respects:

(c) the following facts, mentioned in section 173 of the Act, may be proved against the debtor:

The assets of the bankrupt are not of a value equal to fifty cents on the dollar on the amount of the bankrupt's unsecured liabilities, unless the bankrupt satisfies the court that the fact that the assets are not of a value equal to fifty cents on the dollar on the amount of the bankrupt's unsecured liabilities has arisen from circumstances for which the bankrupt cannot justly be held responsible;

10. That we are further of the opinion that the debtor's proposal is an advantageous one for the creditors, for the following reasons:

The Trustee is of the opinion that, in a bankruptcy, the unsecured creditors would not receive a dividend as the properties are not saleable and would become the responsibility of the Orphan Well Association. The wells that have been shut in would require significant investments to bring them back into production, if in fact, bringing them back into production would be even economic. In addition, the claims of the counties for unpaid property taxes and the abandonment and reclamation obligations would have to be addressed.

The Zargon Proposal allows unsecured creditors, including counties with non-linear property tax claims, to receive a pro rata distribution from the Proposal Fund and a potential further distribution from the Contingent Value Note.
