  - (d) accepting an offer to purchase the property of the Debtor submitted by the Klair Group Industries Inc. (the "**Purchaser**") as described in the First Report and as more particularly set out in the Confidential Addendum;
  - (e) temporarily sealing the Confidential Addendum attached to the First Report in a Restricted Court Access Order;

- (f) declaring that the rights of 1643434 Alberta Ltd. in a patented design used to construct property owned by the Debtor have been exhausted and vesting title to the property in the Purchaser, including the patented design existing in the building, free and clear of 1643434 Alberta Ltd.'s interests as set out in the First Report; or,
- (g) if necessary, authorizing the Receiver to assign a license agreement to the Purchaser, or, in the alternative, authorizing the Receiver to assign the Debtor into bankruptcy and authorizing the trustee in bankruptcy to assign the License Agreement to the Purchaser; and

## 2. The First Report.

We will upload the Application and First Report to the CCM system once they have been filed as we are unable to upload unfiled copies. In addition, we intend to file a brief of law in support of the Receiver's Application tomorrow and are requesting leave from the Court to do so. We are agreeable to permitting a respondent to file a late brief in the event that more time is required. We note that this will still leave six days to review and consider our brief prior to the Application being heard.
