1. The applicant, MNP Ltd. (the “**Monitor**”), in its capacity as the court-appointed monitor of Abbey Resources Corp. (the “**Company**”), seeks an order:
 - (a) abridging the time for service of this Notice of Application and deeming the Notice of Application and all other materials filed in support of the same on the parties listed in the Service List established in these proceedings to be good, valid, timely, and sufficient; and
 - (b) sealing the Confidential Supplement to the Fifth Report of the Monitor (the “**Confidential Supplement**”) until further Order of the Court; and
 - (c) granting such further and other relief as counsel may request and this Honourable Court may allow.

Grounds for making this application:

2. The Confidential Supplement contains Sproule Asset Management Ltd.’s cost estimates for the reclamation, abandonment, and pipeline remediation work in respect of the Company’s pipeline.
3. These estimates constitute commercially sensitive information that could affect the integrity of a future sales process for the Company’s assets.


