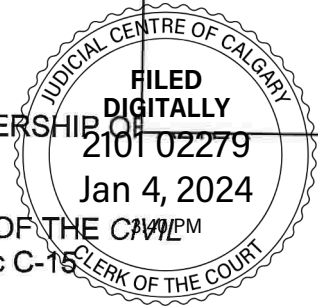

1. I am a Senior Vice President with the Corporate Recovery group of MNP Ltd. (the "Receiver" or "MNP") and as such, I have personal knowledge of the facts and matters deposed to in this Affidavit, except where stated to be based upon information, in which case I believe the same to be true.
2. I am authorized to make this Affidavit on behalf of the Receiver.

3. On April 29, 2021, pursuant to the Order of the Honourable Justice K.M Eidsvik, the Receiver was appointed over all of the assets, undertakings, and properties of Alter NRG Corp. (“Alter”).
4. On September 1, 2023, pursuant to the Order of the Honourable Justice J.G. Nielsen, the Receiver obtained its discharge order (the “Discharge Order”).
5. In accordance with the Discharge Order, I hereby confirm that the estate of Alter has been fully administered and all monies have been distributed, including all matters set out in the Fourth Report of the Receiver, dated August 25, 2023 (the “Fourth Report”) and those items in paragraph 31 of the Fourth Report, in accordance with paragraph 7 of the Discharge Order.
