- I, Eric Sirrs, of the City of Edmonton, Province of Alberta, Licensed Insolvency Trustee, MAKE OATH AND SAY THAT:
- 1) I am a Senior Vice President and Licensed Insolvency Trustee at MNP Ltd., the Court Appointed Receiver of Chateau Inn Ltd. (referred to herein as the "Company") (hereinafter the "Receiver") and as such I have personal knowledge of the matters hereinafter deposed to except where stated to be based upon information and belief.
- 2) On February 7, 2024 Justice T. Neilson granted an Order for, *inter alia*, final distribution and discharge of the Receiver (hereinafter the "Discharge Order") which provided, among other things, that the Receiver is authorized and directed to make a distribution of the final funds available in the Receivership estate, inclusive of final professional fees.
- 3) I confirm that the items outlined in the Discharge Order have been completed and that the available funds have been distributed in accordance with paragraph 7 of the Discharge Order.

- 4) I am of the opinion that the administration of the Receivership of the Company has been completed. A copy of the Receiver's Final Report and Final Statement of Receipts and Disbursements is attached to this Affidavit as **Exhibit A**.
- 5) I make this Affidavit in support of the discharge of the Receiver, pursuant to paragraph 10 of the Discharge Order granted by Justice T. Neilson on February 7, 2024.
