**FIRST REPORT OF RECEIVER WITH RESPECT TO THE RECEIVERSHIP OF
DDK VENTILATION PRODUCTS LTD.**

**DATED FOR REFERENCE MAY 12, 2020
("RECEIVER'S FIRST REPORT")**

BACKGROUND AND PURPOSE

1. Pursuant to an Order pronounced by the Honorable Madam Justice Marzari of the Supreme Court of British Columbia (the “**Court**”) on March 2, 2020 (the “**Receivership Order**”), MNP Ltd. was appointed as Receiver and Manager (the “**Receiver**”) of all of the assets, undertakings and property (collectively, the “**Property**”) of DDK Ventilation Products Ltd. (“**DDK**”, or the “**Company**”).
2. DDK operated as a distributor of ventilation equipment, parts, and components to mechanical, sheet metal, and air conditioning contractors servicing commercial, light industrial and residential construction industries. DDK’s head office is located in Coquitlam, BC and is comprised of a leased office and warehouse facilities. There are two (2) additional leased warehouse and storage facilities located near the head office.
3. A search of the British Columbia Registry dated February 18, 2020 indicates that David Jagger and Andrew Mindell are directors of DDK.
4. DDK owns personal property consisting of accounts receivable, inventory for resale, warehouse equipment, pallet racking and warehouse shelving, and office furniture and equipment.
5. In preparing the Receiver’s First Report and making comments herein, the Receiver has been provided with, and has relied upon, certain unaudited, draft and/or internal financial information of the Company, the Company’s books and records, and information from other third-party sources (collectively, the “**Information**”). The Receiver has not audited, reviewed or otherwise attempted to verify the accuracy or completeness of the Information in a manner that would wholly or partially comply with generally accepted assurance standards or other standards established by the Chartered Professional Accountants of Canada.
6. The purpose of the Receiver’s First Report is to advise the Court with respect to the following matters:
 - Outline of Receiver’s administration to date;
 - Sales process undertaken by the Receiver;
 - Outline of potential claims;
 - Receiver’s Statement of Receipts and Disbursements;
 - Distribution of Proceeds; and
 - Court approval sought.

OUTLINE OF RECEIVER’S ADMINISTRATION TO DATE

7. On March 2, 2020, the Receiver took possession of the Property over which it was appointed, undertook various conservatory and protective measures and prepared an

inventory of the Property. The Receiver has taken possession of various books and records of DDK.

8. The Receiver took possession of approximately \$1,300 cash on hand which has been deposited to the receivership trust account.
9. The Company had ceased operations just prior to the date of receivership, and the Receiver did not carry on any operations on behalf of DDK after the date of receivership.
10. The Company's personal property is located at DDK's various leased premises, and the Receiver has continued to occupy these premises to conduct an inventory and carry out a sales process. The Receiver has paid occupation rent to the landlord and has arranged for continued utilities.
11. The Receiver confirmed that there was adequate insurance coverage in place at the date of receivership and directed the insurance provider to add the Receiver as a named insured/loss payee. The insurance policy was subsequently renewed on March 9, 2020.
12. The Receiver maintained and updated the Service List and the Receiver's website for the receivership proceedings at <https://mnpdebt.ca/en/corporate/engagements/ddk-ventilation-products-ltd>
13. The Receiver attended to various statutory duties including filing a notice of appointment of receiver pursuant to the *Business Corporations Act* (British Columbia), posting a notice of the receivership in the Vancouver Sun newspaper as required by the *Personal Property Security Act* (British Columbia), preparing a Notice and Statement of Receiver which was sent to all known creditors of the Company as required by the *Bankruptcy and Insolvency Act*, and attending to filing requirements pursuant to the *Wage Earner Protection Program Act*.
14. The Receivership Order allowed for Receiver's Borrowings, however, there has not been a need to secure any borrowings to date.
15. To date the Receiver has collected approximately \$300,000 of outstanding accounts receivable.
16. The Receiver received and responded to various creditor inquiries throughout the receivership proceedings.
17. The Receiver was presented with numerous written demands by unpaid suppliers for repossession of goods supplied within the thirty (30) days preceding the date of receivership, pursuant to Section 81.1 of the *Bankruptcy and Insolvency Act*. The Receiver investigated each demand and arranged for the return of inventory in respect of valid claims.

Employees

18. The Company had ceased operating on or about February 28, 2020 and the Receiver did not operate DDK's business after the pronouncement of the Receivership Order.
19. The Receiver advised fourteen (14) employees of their termination of employment and arranged for Records of Employment and T4 slips to be issued.

Accounts Receivable

20. The Company's books and records indicated trade accounts receivable at the date of receivership of approximately \$1,835,000.
21. The Receiver reviewed accounting reports in relation to the outstanding accounts receivable as well as various documents which support the individual customer account balances reported. The Receiver also discussed the collectability of each outstanding account with the Company's accounting staff. Given the age and status of various accounts, the Receiver estimates total collectable accounts receivable to range between \$450,000 and \$750,000.
22. The Receiver wrote to each account advising of the receivership proceedings and directing all payments to the Receiver. To date, the Receiver has collected approximately \$300,000 which has been deposited to the receivership trust account.

Tangible Personal Property

23. The Company's tangible personal property includes inventory for resale, forklifts and warehouse handling equipment, pallet racking and shelving, and office furniture and equipment (collectively, the "**Tangible Assets**"). The Receiver has secured, confirmed or arranged for insurance, and commissioned an appraisal of the Tangible Assets.
24. DDK's inventory consisted of approximately 250,000 products for resale. The main product types include slab duct products, sheet metal components and fittings, forms and ventilation equipment, and air distribution equipment and components.
25. As reported earlier, the Receiver was presented with numerous written demands by unpaid suppliers for repossession of goods supplied within the thirty (30) days preceding the date of receivership, pursuant to Section 81.1 of the *Bankruptcy and Insolvency Act*. The Receiver investigated each demand and arranged for the return of inventory in respect of four (4) valid claims.

SALES PROCESS UNDERTAKEN AND PROPOSED SALE

Sales Process Undertaken

26. The Receiver offered the Tangible Assets for sale and prepared an Invitation for Offers to Purchase and Invitation for Auction Proposals (“**Invitation for Offers**”). The Receiver requested that interested parties provide an outright purchase offer and/or an auction proposal that included a net minimum guarantee. The offers were due on May 4, 2020.
27. The Receiver is of the view that an en bloc sale of the Tangible Assets will achieve the highest net realization, and as such, the terms contained in the Invitation for Offers required interested parties to submit offers for all the Tangible Assets.
28. The Receiver carried out various marketing and advertising activities in relation to the proposed sale of the Tangible Assets. Specifically, the Receiver:
 - a) placed an online posting of the sales process with downloadable Invitation for Offers on MNP’s national website,
 - b) conducted research of companies that were customers or competitors of DDK in Western Canada to determine prospective purchasers of the Tangible Assets; and
 - c) sent the Invitation for Offers directly to thirty-six (36) parties, including those in related industries as well as appraisers and liquidators, all of whom were identified as possibly having an interest in acquiring the Tangible Assets.
29. On April 28, 2020 the Receiver prepared an Addendum to the Invitation for Offers and notified interested parties.
30. The Receiver participated in discussions and exchanged correspondence with various interested parties including those conducting due diligence and arranged for the supervised inspections by four (4) parties of the Tangible Assets at the Company’s premises.

Proposed Sale

31. The Receiver received a total of four (4) Offers to Purchase or Auction Proposals. The highest and best offer was submitted by Pitt Meadows Plumbing & Mechanical Systems Ltd. (the “**Purchaser**”) who submitted an outright purchase offer in the amount of \$402,000 which was accepted by the Receiver, subject to the Court’s approval.
32. The Receiver and the Purchaser executed an Asset Purchase Agreement, a copy of which is attached to the Receiver’s First Report as Appendix “**A**”.

33. The Purchaser paid the Receiver a deposit toward the purchase price in the amount of \$45,024 representing 10% of the purchase price plus applicable taxes, which has been deposited to the Receiver's trust account.
34. The material terms of the proposed transaction are as follows:
 - a) Purchase Price: \$402,000 (plus applicable taxes);
 - b) Conditions Precedent: Court Approval only; and
 - c) Closing and payment of Purchase Price: On or before the 7th day following the issuance of the Vesting Order
35. The amount offered by the Purchaser is favourable, taking into account the appraised value of the Tangible Assets (on a forced liquidation basis after deducting estimated commissions and other selling costs), and the Receiver is satisfied that the proposed sale represents the present market value of the Tangible Assets. The Receiver does not expect that a better price could be obtained by extending the sale process.
36. The Receiver recommends that the Court approve the proposed sale to the Purchaser. It is our understanding that TD, the senior secured creditor in these proceedings, also recommends approval of the sale.

OUTLINE OF PRIORITY CLAIMS

Statutory Priority Claims

37. The Receiver filed documents in accordance with the *Wage Earner Protection Program Act* with Service Canada pertaining to wage arrears owing to fourteen (14) employees of DDK. The maximum amount payable to Service Canada under Section 81.4 of the *Bankruptcy and Insolvency Act* is approximately \$15,750, the priority for which ranks ahead of all registered security interests in relation to the Company's current assets.
38. The Receiver is gathering information with respect to the Company's liabilities that are not the subject of registered charges. Specifically, the claims of the Canada Revenue Agency ("CRA") pertaining to unremitted payroll source deductions and Goods and Service Tax/Harmonized Sales Tax ("GST"), the claim of Ministry of Provincial Revenue (the "**Ministry**") pertaining to unremitted provincial sales tax, and Worksafe BC pertaining to unremitted assessments due under the *Workers' Compensation Act*.
39. While amounts owing to the CRA are still being investigated by the Receiver, DDK used ADP as its payroll service provider and ADP remitted payroll withholdings directly to the CRA on the Company's behalf. Based on the Receiver's review of the Company's books and records, the Receiver does not anticipate that there is a debt

owing to the CRA in relation to unremitted payroll withholdings. The CRA has not yet submitted a claim with respect to the amount which has the benefit of a deemed trust.

40. The CRA has also not yet submitted a claim on account of unremitted GST. Based on the Receiver's review of the Company's books and records, the Receiver does not anticipate that there is any material debt owing in relation to unremitted GST.
41. The Ministry has not yet submitted a claim to the Receiver. Based on the Receiver's review of the Company's books and records, the Receiver does not anticipate there is any material debt owing on account of unremitted provincial sales tax.
42. The Receiver has not yet received the determination of unremitted assessments due under the *Workers' Compensation Act*. The amount estimated based on the Company's books and records is approximately \$1,270.
43. As the Receiver is waiting for further information to be received from the various statutory claimants, the Receiver proposes to address distribution to these claimants at a further application to Court.

The Toronto-Dominion Bank ("TD") Claim and Security

44. The Plaintiff TD previously filed an affidavit of Joe Seidel, an Associate Vice President of TD, being an affidavit sworn on February 27, 2020 (the "**Seidel Affidavit**") and filed in this proceeding. In the Seidel Affidavit, Mr. Seidel deposed as to:
 - a) the indebtedness of the Company to TD and exhibited the applicable loan documentation; and
 - b) the security held by TD with respect to the Company's obligations to TD and exhibited copies of the security held by TD in that regard.
45. The Receiver obtained a legal opinion from its independent legal counsel with respect to the security granted by DDK to TD. In particular, the review included:
 - a) Credit Facility Agreement from TD to 1155729 B.C. Ltd. dated March 14, 2018;
 - b) Certificate of Amalgamation dated April 1, 2018;
 - c) Certificate of Change of Name dated April 1, 2018;
 - d) General Security Agreement from TD to DDK dated April 20, 2018; and
 - e) Amended Credit Facility Agreement from TD to DDK dated January 8, 2020.(collectively, the "**Security**").

46. The legal opinion indicated that, based on a review of the Security and searches conducted, that the Security constitutes a legal, valid and binding obligation on DDK, and that TD holds a valid and perfected security interest in all of DDK's present and after acquired personal property.
47. The Receiver has reviewed the British Columbia Personal Property Registry searches for DDK. TD was the first in time to register a financing statement in the registry to perfect its security interest in DDK's property, and the Receiver is unaware of any other creditors having a security interest in the assets by virtue of a security agreement which ranks in priority ahead of TD.
48. The outstanding balance of TD's indebtedness as at February 25, 2020 was \$1,747,710.05 and US\$34,349.68 and interest and expenses, including legal costs continue to accrue.

The Roger Sjodin Family Trust and The Carmen Sjodin Family Trust

49. Roger Sjodin, as Trustee of The Roger Sjodin Family Trust, and Carmen Sjodin, as Trustee of The Carmen Sjodin Family Trust (the "**Sjodin Parties**") registered notice of security interests in the Personal Property Registry, notice of which was registered on April 5, 2018.
50. The Seidel Affidavit exhibited a Subordination and Standstill Agreement dated April 20, 2018 and entered into between TD and the Sjodin Parties, whereby the Sjodin Parties postponed and subordinated their security to the security held by TD.

RECEIVER'S STATEMENT OF RECEIPTS AND DISBURSEMENTS

51. Attached as Appendix "**B**" to this report is the Receiver's Statement of Receipts and Disbursements for the period ending May 8, 2020. The Receiver held a balance of \$220,710.93 in the Receivership trust account at that time.

DISTRIBUTION OF PROCEEDS

52. As claims against DDK are still being investigated by the Receiver, the Receiver seeks approval of an interim distribution of the funds on hand to TD, following the receipt from the Purchaser of the proceeds of sale from the Tangible Assets, in an amount that the Receiver determines is advisable based on the funds available and the potential priority claims.

COURT APPROVAL SOUGHT


53. Based on the foregoing, the Receiver seeks a Court Order for the following relief:
- a) approving the Receiver's activities to-date;
 - b) approving the sale and vesting the Tangible Assets in the Purchaser; and
 - c) authorizing the Receiver to make an interim distribution to TD in such amounts as the Receiver determines advisable.

ASSET PURCHASE AGREEMENT

Made the 8th day of May, 2020.

BETWEEN:

MNP Ltd. in its capacity as
Court appointed receiver and not in its personal or corporate capacity of DDK
Ventilation Products Ltd. (the "**Company**")

(the "**Seller**")

AND:

Pitt Meadows Plumbing & Mechanical Systems Ltd.
a corporation incorporated pursuant to the laws of Canada, and
having an office at 20142 113B Avenue, Maple Ridge,
BC, Canada, V2X 0Y9

(the "**Purchaser**")

WHEREAS pursuant to an order (the "**Receivership Order**") pronounced March 2, 2020, the Seller was appointed as receiver of, among other things, the property, assets and undertakings of the Company.

WHEREAS the Seller has agreed to sell and the Purchaser has agreed to buy, subject to the approval of the Supreme Court of British Columbia (the "**Court**"), the Seller's interest in and to the assets and property listed on **Schedule "A"** hereto (the "**Assets**"), on the terms contained in this Asset Purchase Agreement (the "**Agreement**").

NOW THEREFORE, in consideration of the premises, covenants and agreements set out in this Agreement, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, each of the parties hereto agrees as follows:

1. The Purchaser shall pay to the Seller the balance of the purchase price of \$402,000 (the "**Purchase Price**") plus applicable taxes, less the deposit received in the amount of \$45,024 (the "**Deposit**"), for a total payment of **\$405,216**, by way of bank draft or certified funds, within seven (7) days of the Seller providing the Purchaser with a copy of an order of the Supreme Court of British Columbia (the "**Court**") approving this sale.
2. Subject to the approval of the Court and payment of the Purchase Price plus applicable tax, and the other terms contained herein, the Seller hereby bargains, sells, assigns, transfers and sets over unto the Purchaser, all of the Seller's rights, title, and interest in and to the Assets and every part therein.

3. This Agreement is subject to approval by the Court. This condition is for the sole benefit of the Seller. The Seller shall, subject to the other terms of this Agreement, present this Agreement to the Court for approval and in so doing is not contractually or otherwise liable to any party in any way.
4. Upon payment of the balance of the Purchase Price in accordance with Section 1, the Purchaser shall be responsible to take possession of the Assets at the premises of the Company located at 1540, 1560, and 1590 Booth Avenue, Coquitlam, BC (the “Premises”) and remove them at its sole risk and cost. The Purchaser shall cause no damage to the Premises and shall leave the Premises in a “broom swept” condition, to the satisfaction of the Seller, acting reasonably. If the Purchaser has not removed the Assets from the Premises by June 5, 2020, the Purchaser shall pay to the Seller the amount of \$600 per day on account of additional rent incurred for the Premises. The Purchaser shall, in any and all circumstances, remove the Assets from the Premises and fulfil its obligations under this Agreement before 5 p.m. on June 30, 2020.
5. This Agreement may be terminated at the Seller’s sole option if at any time prior to Court approval:
 - (a) the Court varies or vacates the Receivership Order to remove or impede the Seller’s ability to market or sell the Assets;
 - (b) the Assets are redeemed by the Company or any other person, through private sale or otherwise, prior to Court approval of this Agreement; or
 - (c) The Seller determines it is inadvisable to present this Agreement to the Court,and in any such event the Seller shall return the Deposit to the Purchaser and then have no further obligations or liability to the Purchaser under this Agreement or otherwise. This condition is for the sole benefit of the Seller.
6. If the Purchaser fails to complete the purchase of the Assets in accordance with its obligations under this Agreement, then the Seller shall be entitled to retain the Deposit as liquidated damages without limiting the Seller’s other remedies.
7. The Purchase Price does not include Goods and Services Tax or Provincial Sales Tax, if any, which shall be payable by the Purchaser in addition to the Purchase Price as shown on the executed Offer to Purchase document attached hereto as **Schedule “B”**.
8. The Purchaser acknowledges that the Assets are sold on an “as-is, where-is” basis and without limiting the generality of the foregoing, there are no collateral agreements, conditions, representations or warranties made by the Seller, express or implied, arising at law, by statute or in equity or otherwise with respect to the Assets, and without limiting the generality of the foregoing, including as to title, state of title, description, fitness, suitability for any particular purpose, merchantability, operating condition or value of the Assets, or the future cash flows from the Assets. The Purchaser further acknowledges that it has relied entirely on its own judgment and investigation with respect to the purchase of the Assets and is satisfied in all respects with the due diligence and investigations it has conducted.

9. This Agreement shall be governed by and construed in accordance with the laws of British Columbia and the federal laws of Canada applicable therein. The Purchaser and Seller hereby attorn to the jurisdiction of the courts of British Columbia.
10. The Agreement shall enure to and be binding upon the Purchaser and Seller and their respective successors, trustees and assigns, as the case may be.
11. This Agreement constitutes the entire agreement between the parties and, except as stated, contains all of the covenants, representations and warranties of the parties. There are no verbal statements, covenants, representations, warranties, undertakings or agreements between the parties. This Agreement may not be amended or modified in any respect, except by written instrument executed by the parties.
12. The parties shall execute and deliver such further documents and instruments and do all such acts and things as may be reasonably necessary or required to carry out the full intent and meaning of this Agreement and to effect the transactions contemplated by this Agreement.
13. The Agreement may be executed in any number of counterparts, when all taken together, shall constitute a fully executed agreement that shall be binding upon all parties, with the same force and effect as if all parties had signed the same document. Any party to this agreement may effect delivery of its respective execution by counterpart *via* telecopy or other electronic transmission to any other party to this agreement and, in such case, shall provide an originally executed version of its execution upon request of any other party to this agreement.

IN WITNESS WHEREOF the Purchaser and Seller have executed this Asset Purchase Agreement by the properly authorized representatives on the date first above written.
