UPON THE APPLICATION of MNP Ltd., the Licensed Insolvency Trustee (the “Trustee”) of Sarah Moe aka Sahar Muhamad and Sarah Moe Professional Corporation (the “Bankrupts”); AND UPON HAVING READ the Application of the Trustee, the Affidavit of Sandra Landry of the Trustee, sworn November 14, 2023, and the Affidavit of Service; AND UPON HEARING FROM Counsel for the Trustee and other interested parties;

IT IS HEREBY ORDERED AND DECLARED THAT:

1. Notwithstanding paragraph 7 of the Receivership Order pronounced September 16, 2022, MNP Ltd. as the Receiver of Faissal Mouhamad Professional Corporation, 52 Dental Corporation, and Delta Dental Corp. (the “Companies”) is authorized and directed to provide to Counsel for the Trustee lists of patients of the clinics operated by the Companies around the time of granting of the Interim Receivership Order in respect of the Companies on August 23, 2022 and the Receiver shall have no liability to any person for so doing.
