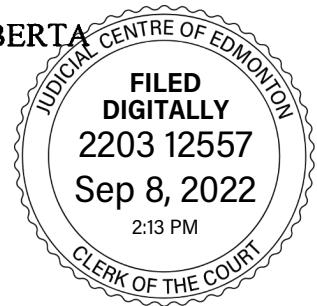

AFFIDAVIT OF Faissal Mouhamad

Sworn on September 8, 2022

I, FAISSAL MOUHAMAD, of Red Deer County, in the Province of Alberta, Businessman, MAKE OATH AND SAY AS FOLLOWS:

Introduction:

1. I have personal knowledge of the matters hereinafter deposed to, except where stated to be based on information and belief, in which case I verily believe the same to be true.
2. I am one of the defendants named in this action.
3. Unless otherwise indicated, capitalized terms used in this affidavit shall have the meanings given to them in the affidavit sworn by Jocelyn Beriault in this action on August 19, 2022 (the “**Beriault Affidavit**”) and in my affidavit sworn on August 23, 2022 (the “**First Faissal Affidavit**”).
4. I am the sole director and voting shareholder of FMPC, McIvor, 985, Paradise McIvor, Michael Dave Ltd. and 52 Wellness.
5. FMPC is a professional corporation through which, at times, I have operated my dental practices.
6. Michael Dave Ltd. is an Alberta corporation. I am its sole director and voting shareholder.
7. Michael Dave Ltd. is the registered owner of real property located at 7151-50 Avenue, Red Deer, Alberta (the “**MDM Real Property**”), from which the Red Deer Dental Clinic operates. Marked as **Exhibit “A”** and attached hereto is a printout of a Land Title Certificate for the MDM Real Property as of September 7, 2022.
8. Michael Dave Ltd. is the owner of the tenant improvements made to the MDM Real Property (the “**Tenant Improvements**”), as well as the equipment used by the Red

Deer Dental Clinic in its business operations (the “**Red Deer Dental Clinic Equipment**”).

9. Jovica Property Management Ltd. (“**Jovica**”) and Solar Star Holdings Inc. (“**Solar Star**”) hold a security interest in Michael Dave Ltd.’s present and after-acquired personal property, including the Tenant Improvements and the Red Deer Dental Clinic Equipment. In that regard, marked as **Exhibit “B”** and attached hereto is a true copy of the said security agreement.
10. Additionally, Jovica and Solar Star. hold a first-charge mortgage against title to the MDM Real Property in the registered principal amount of \$2,200,000.00.
11. The defendant 52 Wellness Centre Inc. (“**52 Wellness**”) is an Alberta corporation which was incorporated in September, 2020 for the purpose of acquiring the real property from which the Calgary Clinic operates, namely Suite 100-3505 52 Street SE, Calgary, Alberta (the “**52 Wellness Building**”).
12. 52 Wellness’ sole asset is the 52 Wellness Building.
13. 985 is an Alberta corporation.
14. 985 is the registered owner of a commercial building in Drayton Valley (the “**Drayton Valley Building**”), from which I once operated Valley Dental (as defined below).
15. Previously, 985 was the registered owner of a commercial building located in Red Deer, Alberta (the “**Red Deer Building**”) from which the Associate Dental Clinic (as hereinafter defined) once operated.

16. 985 sold the Red Deer Building in early 2020. Its sole remaining asset is the Drayton Valley Building. At no time has 985 owned or had an interest in any tangible real property.

Relationship with RBC:

17. Many years ago, me and some of the corporate entities I controlled were RBC commercial banking customers. I was also an RBC Wealth Management client.
18. Although my commercial banking relationship (both personally and through my corporations) with RBC eventually came to an end, I continued to be an RBC Wealth Management client.
19. In late 2015 or early 2016, RBC contacted me in an effort to re-establish a commercial banking relationship with me and my companies. At the time, my commercial ventures, both personally and through corporations I controlled, were as follows:
 - a) 985 was the registered owner of the Drayton Valley Building, from which I operated a dental clinic (“**Valley Dental**”).
 - b) 985 was the registered owner of the Red Deer Building, from which FMPC operated a dental clinic (the “**Associate Dental Clinic**”).
 - c) McIvor owned the McIvor Lands.
20. As of the date on which RBC initiated the contact referenced at paragraph 19 above:
 - a) FMPC was the owner of various pieces of dental equipment, which were used in the Associate Dental Clinic business operations (the “**Associate Clinic Dental**”).

Equipment”). All or substantially all of that equipment was purchased through financing provided by Toronto-Dominion Bank (the “**TD Equipment Loan**”) and Toronto-Dominion Bank (“**TD Bank**”) had a first-charge security interest in the Associate Clinic Dental Equipment (the “**TD Security Interest**”).

b) Title to the McIvor Lands was encumbered with a first-charge mortgage in favour of TD Bank (the “**TD Mortgage**”).

21. By way of offer of financing dated August 4, 2016 (the “**FMPC Financing Offer**”), RBC offered to extend the following credit facilities to FMPC:

a) an operating line-of-credit in the amount of \$500,000.00 (the “**FMPC Operating LOC**”);

b) a fixed-rate term loan in the principal amount of \$2,600,000.00 (the “**FRT Loan**”); and

c) a VISA credit card with a limit of \$150,000.00 (the “**VISA Facility**”).

(collectively the “**Faissal PC Credit Facilities**”).

22. The purpose of the FRT Loan was to pay out the TD Equipment Loan.

23. The security sought by RBC for repayment of the FMPC Credit Facilities included the following:

a) A first-charge security interest in all of FMPC’s present and after-acquired personal property;

b) A guarantee and postponement of claim from me;

- c) A guarantee and postponement of claim from 985, supported by a first-charge security interest in all of 985's present and after-acquired personal property; and
 - d) A guarantee and postponement of claim from McIvor (the "**McIvor Guarantee**"), supported by a first-charge security interest in all of McIvor's present and after-acquired personal property.
24. The FMPC Financing Offer was accepted by FMPC (as borrower), 985 (as guarantor), McIvor (as guarantor) and me (as guarantor) on August 9, 2016.
25. The financing made available to FMPC by way of the FRT Loan was used to repay the TD Equipment Loan in full.
26. Various amendments were made to the terms of the FMPC Credit Facilities, which are particularized at paragraph 21 of the Beriault Affidavit and in the records marked as Exhibits D-J of that affidavit. Those amendments included an amendment to specifically charge the McIvor Lands (by way of the RBC Mortgage, as hereinafter defined) as collateral for repayment of any amounts payable under the McIvor Guarantee.
27. By way of offer of financing dated August 2, 2016 (the "**McIvor Financing Offer**"), RBC offered to provide to McIvor a revolving demand loan facility in the principal amount of \$2,500,000.00 (the "**RBP Loan**").
28. The purpose of the RBP Loan was to pay out the TD Mortgage.
29. The security sought by RBC for repayment of the RBP Loan included the following:
- a) A first-charge security interest in all of McIvor's present and after-acquired personal property;

- b) A first-charge collateral mortgage to be registered against title to the McIvor Lands (the “**RBC Mortgage**”);
 - c) A guarantee and postponement of claim from me;
 - d) A guarantee and postponement of claim from 985, supported by a first-charge security interest in all of 985’s present and after-acquired personal property; and
 - e) A guarantee and postponement of claim from FMPC, supported by a first-charge security interest in all of McIvor’s present and after-acquired personal property.
30. The McIvor Financing Offer was accepted by McIvor (as borrower), 985 (as guarantor), FMPC (as guarantor) and me (as guarantor) on August 9, 2016.
31. The financing made available to McIvor by way of the RBP Loan was used to repay the TD Mortgage in full.
32. Although the purpose of the RBP Loan was to pay out the TD Mortgage, I note that the RBC Mortgage specifically provides that it is intended to secure the repayment of all present and future indebtedness owed by McIvor to RBC, including any indebtedness incurred by way of guarantee.
33. Various amendments were made to the terms of the McIvor Financing Offer, including an amendment to add Paradise McIvor as a guarantor, with such guarantee to be supported by a first-charge security interest in all of Paradise McIvor’s present and after-acquired personal property.

Sale of the Drayton Valley Clinic and the Associate Dental Clinic:

34. By way of asset purchase agreement dated July 27, 2018, I sold the Valley Dental practice. That sale closed on August 31, 2018.

35. By way of asset purchase agreement dated effective January 18, 2019, FMPC sold the Associate Dental Clinic practice, including the Associate Clinic Dental Equipment. That sale closed on January 18, 2019 and the FRT Loan was repaid in full from the sale proceeds.
36. Notwithstanding the sale of the Valley Dental practice and the Associate Dental Clinic practice, RBC did not require repayment of the FMPC Operating Line or the VISA Facility.
37. At no time did the Associate Dental Clinic operate under the tradename "Delta Dental".

The Red Deer Dental Clinic:

38. Currently, I practice dentistry at two Alberta clinics, one of which is the Red Deer Dental Clinic, which operates from the MDM Real Property.
39. The Red Deer Dental Clinic operates under the trade name "Delta Dental", which FMPC and I own.
40. Originally, I planned to manage the Red Deer Dental Clinic through Delta Corp. and that was the reason for which that company was incorporated. However, I eventually decided to operate the Red Deer Dental Clinic through FMPC under the Delta Dental tradename.
41. The Red Deer Dental Clinic opened on January 2, 2018, long before the sale of the Associate Dental Clinic.
42. At all times, RBC was aware that the Red Deer Dental Clinic and the Associate Dental Clinic operated concurrently and that the Red Deer Dental Clinic continued to operate following the sale of the Associate Dental Clinic.

43. None of the equipment that was used at the Associate Dental Clinic was ever used at the Red Deer Dental Clinic. That equipment remained at the Associate Dental Clinic following the sale of that business, as did the tenant and leasehold improvements.
44. At no time did any of the Defendants seek financing from RBC to purchase any of the Tenant Improvements or the Red Deer Dental Clinic Equipment.
45. At no time did I represent to RBC that FMPC was the owner of any of the Tenant Improvements or the Red Deer Dental Clinic Equipment.
46. Michael Dave Ltd. leases the MDM Real Property to FMPC and I. In that regard, marked as **Exhibit "C"** and attached hereto is a true copy of the written lease agreement entered into by Michael Dave Ltd., FMPC and I (the "**Written Lease**").
47. Prior to the execution of the Written Lease, FMPC and I leased the MDM Real Property from Michael Dave Ltd. pursuant to the terms of a verbal lease, the material provisions of which were substantially the same as the material provisions of the written lease. The lease was unwritten because FMPC and Michael Dave Ltd. are corporations which I control. Given the sale of the Red Deer Dental Clinic to Hadi Pc (as particularized below), I felt it prudent to have the Written Lease prepared.
48. Although the written lease does not formally address this, it is understood by the relevant parties that the rent payable under that lease includes the use of the Tenant Improvements and the Red Deer Dental Clinic Equipment.
49. When the Red Deer Dental Clinic commenced operations, it was managed through FMPC, in the sense that all billing occurred through that professional corporation, and it paid all clinic-related expenses.
50. In or late 2021, the management structure of the Red Deer Dental Clinic changed somewhat, such that Delta Corp. assumed responsibility for paying many of the clinic's business-related expenses, including remuneration to Fetoun for the management functions she exercised on behalf of Delta Corp. (the "**Structural Change**").

51. Until mid-July, 2022, and as is reflected in the FMPC Deposit Account statements that are exhibited to the Beriault Affidavit, all or substantially all of the revenue generated by the Red Deer Dental Clinic operations was deposited to the FMPC Deposit Account.
52. In the fall of 2021, I met with Karen Herbst (the “**Fall Meeting**”). At the time, Ms. Herbst was an RBC employee and, more specifically, was FMPC’s account manager. The Fall Meeting took place at the MDM Real Property and was also attended by the Red Deer Dental Clinic’s office manager, Sheena Price.
53. My purpose in calling the Fall Meeting was to determine if RBC would agree to the Structural Change. I specifically advised Ms. Herbst that FMPC wished to transfer some of the Red Deer Dental Clinic managerial functions, as particularized at paragraph 50 above, to Delta Corp. I further informed Ms. Herbst that Delta Corp. was a corporation which would be controlled by Fetoun.
54. Ms. Herbst advised Sheena and I that RBC would agree to the Structural Change, provided that FMPC continued to comply with its payment obligations under the FMPC Credit Facilities and continued to deposit its receivables to the FMPC Deposit Account.
55. My primary reason for undertaking the Structural Change was to shift my focus away from the day-to-day management of the Red Deer Dental Clinic’s operations so that I could concentrate my attention on servicing patients.
56. Furthermore, Fetoun wished to have more involvement in the operation of the Red Deer Dental Clinic and Fetoun and I envisioned the possibility of Fetoun carrying on other business ventures unrelated to the Red Deer Dental Clinic through Delta Corp.
57. Fetoun is not a dentist, licensed or otherwise. However, as far as I am aware, the ownership of dental clinics in Alberta is not limited to licensed dentists. Rather, the Alberta Dental Association and College (the “**College**”) requires a licensed dentist to have care and control over patient files/charts and over any drugs, medications and controlled substances. At all times, I have complied with the College’s requirements in that regard.

The Calgary Dental Clinic:

58. In addition to the Red Deer Clinic, I provide dental services to the Calgary Dental Clinic.
59. The Calgary Dental Clinic opened in June, 2022. As noted above, it operates from the 52 Wellness Building, which 52 Dental leases from 52 Wellness. In that regard, marked as **Exhibit “D”** and attached hereto is a true copy of the lease agreement entered into between 52 Dental and 52 Wellness.
60. The equipment used in the Calgary Dental Clinic is all owned or leased by 52 Dental. Some of the equipment purchased by 52 Dental was financed by Bank of Nova Scotia and Paterson Dental Canada Inc.
61. 52 Dental also manages the Calgary Dental Clinic, in the sense that all of the clinic’s billing occurs through 52 Dental, and it pays all of the clinic-related business expenses.
62. The Red Deer Dental Clinic and the Calgary Dental Clinic are separate and distinct operations. They overlap only in the sense that Dr. Ghalib Hadi and I provide services to both clinics. Additionally, the Red Deer Dental Clinic has always treated patients who live at or near Calgary. Some of those patients now attend the Calgary Dental Clinic instead.
63. At no time has any equipment or inventory used in the operation of the Red Deer Dental Clinic been used in the operation of the Calgary Dental Clinic.
64. Given its large Arabic community, for many years, I have had an interest in providing dental services in Calgary.
65. At all times, RBC was aware of my intention to provide dental services in Calgary. In particular:

- a) In 2017, RBC financed the purchase of a building in Calgary, from which I intended to operate a dental practice. At all times, RBC was aware of the reason for which this building was purchased.
- b) As part of the process for this financing, RBC prepared a business plan and projections for the contemplated practice. In that regard, marked as **Exhibit “E”** and attached hereto is a printout of email correspondence sent to me on September 15, 2017 by Angy Porteous, who was an RBC Commercial Account Manager.

Sale of the Red Deer Clinic:

- 66. An unconditional agreement has been entered into to sell the Red Deer Dental Clinic to Ghalib Hadi Professional Corporation (the “**Asset Purchase Agreement**”), the principal of which is Dr. Hadi, with whom I have practiced dentistry for many years.
- 67. The purchase price payable by Ghalib Hadi Professional Corporation (“**Hadi PC**”) under the Asset Purchase Agreement is \$2,115,000.00 (the “**Clinic Purchase Price**”), which includes an allocation of \$915,000.00 for technical and professional goodwill.
- 68. The Clinic Purchase Price is payable by Hadi PC as follows:
 - a) An initial deposit of \$100,000.00, which is non-negotiable, non-refundable and fully releasable at the time of payment (the “**Initial Deposit**”).
 - b) A lump sum payment of \$475,000.00, which is due on or before September 30, 2022 and which is non-negotiable, non-refundable and fully releasable at the time of payment (the “**Lump Sum Payment**”).
 - c) A final payment of \$1,540,000.00, which is due on or before December 21, 2022.
- 69. The Initial Deposit has been made by Hadi PC.

70. With respect to some of the concerns raised at paragraph 98 of the Beriault Affidavit:

- a) As noted above, Dr. Hadi provides dental services to both the Red Deer Dental Clinic and the Calgary Dental Clinic. Those services are invoiced through Hadi PC, which is why the FMPC Deposit Account statements reference payments to that professional corporation.
- b) Dr. Hadi lent funds to 52 Wellness in respect of its purchase of the Calgary Building. The Hadi Caveat relates to that loan.
- c) If time was not a constraint, I suspect that the Red Deer Dental Clinic might realize a sale price beyond the Clinic Purchase Price, at least on a voluntary sale basis. However, given the demand for payment made by RBC in respect of the FMPC Direct Indebtedness, a protracted marketing process was not an option.
- d) The payment structure of the Asset Purchase Agreement was designed to ensure payment of the FMPC Direct Indebtedness in as timely a way as possible.
- e) Upon receiving a fully executed copy of the Asset Purchase Agreement, RBC advised that it would not support the Hadi PC offer, in part because the amount offered was insufficient to pay the Indebtedness, including the McIvor Guaranteed Indebtedness, in full. At the time RBC took that position, it had not made a demand for payment under the FMPC Guarantees.
- f) The non-negotiable, non-refundable and fully releasable nature of the Initial Deposit and the Lump Sum Payment is a concession by Hadi PC that is meant to reflect that it may have needed to pay more than the Clinic Purchase Price to acquire the Red Deer Dental Clinic had an imminent sale not been necessary to satisfy the FMPC Direct Indebtedness. The same holds true concerning the absence of a non-competition provision in the Asset Purchase Agreement.

- g) As I mentioned, Dr. Hadi and I have practiced dentistry together for several years and plan to continue to do so. Assuming the Asset Purchase Agreement closes, Dr. Hadi and I will continue to provide dental services at both the Red Deer Dental Clinic and the Calgary Dental Clinic, although I will focus most of my attention on the Calgary Dental Clinic.
- h) As noted above, Michael Dave Ltd. is the owner of the Tenant Improvements and the Red Deer Dental Clinic Equipment, which is why that corporation is a party to the Asset Purchase Agreement.
- i) Jovica and Solar Star hold a security interest in the Tenant Improvements and the Red Deer Dental Clinic Equipment. Those corporations are prepared to support the sale of the Red Deer Dental Clinic to Hadi PC on the condition that they receive the sum of \$1,000,000.00 from the proceeds of the sale of that clinic. In that regard, marked as **Exhibit "F"** and attached hereto is a printout of email correspondence sent to me by Ellis Jovica, a representative of Jovica and Solar Star, on September 7, 2022.

Sale of the Dewinton Property:

71. As noted in both the First Faissal Affidavit and the Beriault Affidavit, McIvor has entered into an unconditional agreement to sell the McIvor Lands. The specifics of the sale are set out in the Beriault Affidavit and the First Faissal Affidavit.

72. With respect to some of the concerns raised at paragraphs 100-113 of the Beriault Affidavit:

- a) Samer operates a construction business. The payments to Samer referenced at paragraph 110 of the Beriault Affidavit relate to construction services provided by Samer to some of the defendants named in this action. In that regard, marked collectively as **Exhibit "G"** are true copies of relevant invoices issued by Samer to 985 and FMPC.

- b) Steve Seiler has acted as realtor to me and some of my corporations on many transactions. The payment referenced at paragraph 111 of the Beriault Affidavit pertained to consulting and marketing services provided by Mr. Seiler to 985 in respect of a real estate transaction unrelated to the McIvor Lands sale. In that regard, marked as **Exhibit “H”** and attached hereto is a copy of the relevant invoice.
- c) The Dewinton Property was on the market for roughly 14 months before the Altalaj Offer was made.

73. The Discharge Application has been adjourned to October 28, 2022 to allow for questioning on the affidavit filed in support of the Discharge Application.

74. There is a Consent Procedural Order in place to ensure that steps preliminary to the Discharge Application are undertaken in a timely way. Marked as **Exhibit “I”** and attached hereto is a filed copy of that order.

Deposits to the FMPC Deposit Account:

75. With respect to the evidence given at paragraphs 57-60 of the Beriault Affidavit:

- a) On July 14, 2022, I received correspondence from RBC advising that it was terminating its banking relationship with FMPC and that FMPC had until August 15, 2022 to make alternate banking arrangements (the **“July 14 Letter”**). Marked as **Exhibit “J”** and attached hereto is a true copy of the July 14 Letter.
- b) Based on the direction given by RBC in the July 14 Letter, FMPC essentially stopped using the FMPC Deposit Account. That is why deposits to that account were reduced beginning in July, 2022. That is also why RBC observed the noted decrease in FMPC’s payroll liability.

Payments from FMPC to Delta Dental, 52 Dental & and Other Entities:

76. With respect to the evidence given at paragraph 71 of the Beriault Affidavit:

- a) As noted above, in late 2021, Delta Corp. began paying many of the Red Deer Dental Clinic business expenses. Notwithstanding that, all or substantially all of the Red Deer Dental Clinic revenues continued to be deposited to the FMPC Deposit Account in accordance with the terms of the FMPC Credit Facilities. The transfers from FMPC to Delta Corp. were made to allow Delta Corp. to fund payment of the Red Deer Dental Clinic business expenses.
- b) In effect, the transfers from FMPC to 52 Dental were loans made by me to that corporation (the “**Calgary Dental Clinic Loans**”).
- c) The Calgary Dental Clinic Loans were made to assist 52 Dental with various start-up costs. For the sake of convenience, I simply had FMPC issue cheques to 52 Dental in lieu of paying me directly for dental services rendered to the Red Deer Dental Clinic. Marked as **Exhibit “K”** and attached hereto is a summary of the loans I made to 52 Dental between February, 2022 and June, 2022. Marked as **Exhibit “L”** and attached hereto is a document which sets out revenues received by the Red Deer Dental Clinic between January 1, 2022 and June 27, 2022. These revenues, which total more than \$1,200,000.00, arose from dental services I provided to the Red Deer Dental Clinic. Marked as **Exhibit “M”** and attached hereto is a true copy of a promissory note given to me by 52 Dental in relation to loans I intended to make to that corporation.

77. With respect to the evidence given at paragraphs 79-81 of the Beriault Affidavit:

- a) As noted above, Michael Dave Ltd. leases the MDM Real Property to FMPC and I. Jovica and Solar Star have a mortgage registered against title to that property, which requires monthly payments to be made;

- b) In some cases, rather than having FMPC pay rent to Michael Dave Ltd., with Michael Dave Ltd. then making mortgage payments to Jovica and Solar Star, FMPC paid Jovica and Solar Star directly in lieu of providing rent to Michael Dave Ltd.

- c) I have a person loan with 1193770 Alberta Ltd. I also have shareholder loans extended to me from FMPC. The payment referenced at paragraph 80 (c) was, in effect, a shareholder loan advance.

Related Party Payments:

78. With respect to the evidence given at paragraph 85 of the Beriault Affidavit:

- a) The transfers from FMPC to 985, McIvor and Paradise McIvor were inter-company/related company loans. In that regard, I note as follows:
 - i. Each year, RBC required FMPC to provide it with annual notice to reader financial statements. Marked collectively as **Exhibit “N”** are the financial statements submitted to RBC for the FMPC 2017, 2019 and 2021 fiscal years (the “**FMPC Financial Statements**”).

 - ii. The FMPC Financial Statements balance sheets each include significant “Due From Related Parties” entries.

 - iii. Outside of the context of this litigation, at no time did RBC ever express any sort of disapproval of the “Due From Related Parties” entries. I note that it was Ms. Beriault who reviewed the 2021 financial statements on behalf of RBC. In that regard, marked as **Exhibit “O”** and attached hereto is a printout of email correspondence sent to me by Ms. Beriault on May 2, 2022.

- iv. Many, if not the majority, of the loans in question did not have the effect of overdrawing the FMPC Deposit Account.

- b) The transfers to Yusuf and Khaled were partial payments of debts owed by me to those individuals. In effect, the transfers from FMPC to these individuals were shareholder loan advances by FMPC to me.

- c) The transfers to Dave and Euro Builders were gifts from me to them. In effect, the transfers from FMPC to these parties were shareholder loan advances by FMPC to me.

- d) I do not recall the specific reason for which the payment to Mahmoud Mohamad was made. However, the nature of that transaction as between FMPC and I was identical in nature to the transactions referenced at paragraphs 78 (b) and (c) above.

- e) The transfers to Fetoun fall into one of the three following categories:
 - i. Compensation for services provided to the Red Deer Dental Clinic. As reflected in the Statements of Business or Professional Activities marked collectively as **Exhibit "P"** and attached hereto, Fetoun has provided services to the Red Deer Dental Clinic since it opened in 2018;

 - ii. Reimbursement for inventory and other items purchased for the Red Deer Dental Clinic. In that regard, marked collectively as **Exhibit "Q"** and attached hereto are copies of the receipts I could locate for expenses paid for by Fetoun and for which she was reimbursed; and

 - iii. Funds provided for the purpose of paying our household expenses. In our household, Fetoun is responsible for doing things like buying groceries. For the sake of convenience, I had FMPC issue cheques to Fetoun for the

payment of those expenses in lieu of paying me directly for dental services provided to the Red Deer Dental Clinic. Receipts I could locate related to these payments are included in Exhibit "Q"

79. At no point did RBC contact me to discuss any of the concerns referenced at paragraphs 76-78 above.

Delta Corp. Bank of Nova Scotia Account:

80. With respect to the evidence given at paragraph 44 of the Beriault Affidavit:

- a) The signature on the cheque that is reproduced at Exhibit "V" to the Beriault Affidavit is mine.
- b) This summer, Fetoun was overseas for several weeks and was out of the country on August 2, 2022. Prior to leaving Canada, Fetoun gave me signing authority over Delta Corp.'s Bank of Nova Scotia deposit account.

CWB Security Agreement:

81. With respect to the evidence given at paragraph 45 of the Beriault Affidavit:

- a) Earlier this year, CWB was approached about the possible lease of equipment to 52 Dental;
- b) A leasing arrangement was not ultimately pursued with CWB and it is unclear to me why CWB registered a security agreement at APPR in April, 2022.

Additional Litigation:

82. With respect to the evidence given at paragraph 115 of the Beriault Affidavit:

- a) I have not been served with a filed copy of the Statement of Claim filed in the Khaled/Yusuf Action. 985 and Paradise were served on or about August 17, 2022.
- b) 985 and Paradise intend to defend the Khaled/Yusuf Action. To the extent I am served with the Statement of Claim filed in that action, I will also defend it.

83. With respect to the evidence given at paragraph 121 of the Beriault Affidavit:

- a) 985 has filed a Statement of Defence in the Investplus Action. Marked as **Exhibit “R”** and attached hereto is a filed copy of that pleading.
- b) 985 has filed an application for summary dismissal of the Investplus Action. Marked as **Exhibit “S”** and attached hereto are copies of the materials filed in support of the application. At the request of counsel to Investplus, the summary dismissal application was adjourned *sine die* to allow for cross-examination on my affidavit sworn in support of that application.

The RBC Seizure:

84. As noted in the Beriault Affidavit, on August 17, 2022, RBC caused all of the personal property located at the MDM Real Property to be seized.

85. Through legal counsel, FMPC informed RBC that the seized inventory was necessary for the operation of the dental practice and sought confirmation from RBC that it could be used in the order course of the clinic’s business. RBC declined to provide that permission. In that regard, marked as **Exhibit “T”** and attached hereto is a printout of email correspondence exchanged by Matthew Park, legal counsel to FMPC and other defendants named in this action, and Susy Trace, legal counsel to RBC, on August 17, 2022.

The Interim Receivership Order:

86. RBC's application for a Receivership Order was originally returnable on August 23, 2022.

87. Unfiled copies of the materials relied upon by RBC in support of the Receivership Application were served on legal counsel to FMPC at approximately 5:30 pm on August 19, 2022.

88. On August 23, 2022, an Interim Receivership Order was granted in this action. RBC's application for a Receivership Order was adjourned to September 14, 2022.

Conclusion:

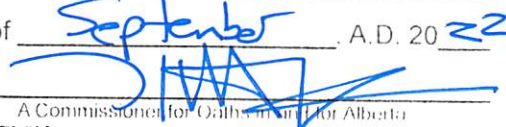

SECURITY AGREEMENT

WHEREAS the Debtor is or will be indebted to the Secured Party from time to time; and

WHEREAS the Debtor has agreed to secure repayment of all amounts from time to time owing by the Debtor to the Secured Party by the granting of this Security Agreement charging the assets herein described of the Debtor to the Secured Party.

1. SECURITY INTEREST

The Debtor hereby grants to the Secured Party by way of mortgage, charge assignment and transfer, a security interest (the "Security Interest") in all of the Debtor's present and after-acquired personal property and any proceeds thereof, including but not limited to those items which are specifically described in Schedule "A" to this Security Agreement also including but not limited to the Debtors present and future goodwill, monies, contracts, agreements, negotiable and non-negotiable instruments, book debts, judgments, securities, materials, stock, supplies, inventories, furniture, implements and equipment (the "Collateral")

The Security Interest created and provided for herein shall attach upon execution of the Security Agreement in respect of all items of collateral herein described in which the Debtor has rights at that moment, and shall attach to all rights of the Debtor acquired hereafter, immediately upon such registration.

2. DEFINITIONS

The terms goods, chattel paper, documents of title, equipment, consumer goods, instrument, intangible, security, proceeds, inventory and accession whenever used herein shall be interpreted pursuant to their respective meanings when used in The Personal Property Security Act of the Province of Alberta, as amended from time to time, which Act, including amendments thereto is herein referred to as the "PPSA". Any reference herein to the Collateral shall, unless the context otherwise requires, be deemed a reference to the Collateral or any part thereof. The term proceeds (the "Proceeds") whenever used herein shall be interpreted as any and all proceeds of every type or kind, both present and after-acquired, and by way of example include trade-ins, equipment, cash,

3. INDEBTEDNESS SECURED

The Security Interest granted hereby secures payment and satisfaction of any and all obligations, indebtedness and liability of the Debtor to the Secured Party (including interest thereon) present or future, direct or indirect, absolute or contingent, matured or not, extended or renewed, wheresoever and howsoever incurred and any ultimate unpaid balance thereof and whether the same is from time to time reduced and thereafter increased or entirely extinguished and thereafter incurred again and whether the Debtor be bound alone or with another or others and whether as principal or surety (the "Indebtedness"). 5. COVENANTS OF THE DEBTOR

So long as this Security Agreement remains in effect the Debtor covenants and agrees to, at its own expense:

- (a) defend the Collateral against the claims and demands of all other parties claiming the same or any interest therein; to keep the Collateral free from all encumbrances, except for the Security Interest and the Existing Encumbrances and to maintain and keep in good standing, free from default, all such Existing Encumbrances and not to sell, exchange, transfer, assign, lease or otherwise dispose of any interest therein without the prior written consent of the Secured Party; provided always that until default, the Debtor may, in the ordinary course of the Debtor's business sell or lease inventory and subject to clause 7 of this Security Agreement, use monies that may become available to the Debtor;
- (b) notify the Secured Party promptly of any event causing loss or depreciation to the Collateral or any change in the information contained in this Security Agreement relating to the Debtor, the Debtor's business or the Collateral;
- (c) keep the Collateral in good order, condition and repair and not to use the Collateral in violation of the provisions of this Security Agreement or any other agreement relating to the Collateral or any policy of insurance with respect to the Collateral or any applicable statute, law, by-law, rule, regulation or ordinance and to permit the Secured Party or its representative, upon request, to enter into or upon any premises or lands where the Collateral may be located for the purpose of examining the condition of the Collateral;

- (d) do, execute, acknowledge and deliver such financing statements and further assignments, transfers, documents, acts, assurances, matters and things (including further schedules hereto) as may be reasonably requested by the Secured Party with respect to the Collateral or otherwise, in order to give effect to these presents and to pay all costs for searches and filings in connection therewith;
- (e) pay all taxes, rates, levies, assessments and other charges of every nature which may be lawfully levied, assessed or imposed against or in respect of the Debtor or the Collateral as and when the same become due and payable;
- (f) insure and keep insured the Collateral for such periods, in such amounts, on such terms and against loss or damage by fire and such other risks as the Secured Party shall reasonably direct and to provide the Secured Party with such evidence of insurance as it may from time to time request with loss payable to the Secured Party and the Debtor, as insures, as their respective interests may appear, and to pay all premiums therefor;
- (g) prevent the Collateral, except the inventory sold or leased as permitted by this Security Agreement, from being or becoming an accession to other property not covered by this Security Agreement;
- (h) continuously carry on and conduct the business of the Debtor in a proper and efficient manner and so as to protect and preserve the Collateral and to keep, in accordance with generally accepting accounting principles, proper books of account for the Debtor's business as well as accurate and complete records concerning the Collateral, and to provide the Secured Party or its representative, upon request, access to all such books of account and records;
- (i) punctually pay all rents, taxes, rates and assessments lawfully assessed or imposed upon any property or income of the Debtor and to punctually pay all debts and obligations to labourers, workmen, employees, contractors, subcontractors, suppliers of materials and other debts which, when unpaid, might under the laws of Canada or any province of Canada have priority over the Security Interest granted by this Security Agreement;
- (j) immediately give notice to the Secured Party of:

- (l) comply with such additional affirmative and negative covenants and restrictions to be performed and observed by the Debtor in respect of provision of financial information, payment of dividends, capital expenditures, incurring additional obligations, reduction of capital, distribution of assets, amalgamation, repayment of loans, lending of money, sale and other disposition of assets and/or such other matters as the Secured Party may advise, and the Debtor agrees to perform and observe such affirmative and negative covenants and restrictions to the same extent and effect as if the same were fully set forth in this Security Agreement;
- (m) not, without first informing the Secured Party in writing, carry on business under or use any name or style other than the name(s) specified in this Security Agreement;
- (n) allow the Secured Party or its representatives the right to inspect the Collateral and review and copy any and all information and data relating to the Collateral or any other transactions between the parties hereto wherever and however such information and data may be stored. In the event that the use of a computer system is required to access such information and data, the Debtor shall allow the Secured Party the use of its computer system for such purpose and shall provide assistance in that regard. If for any reason the information and data cannot be accessed and retrieved at the Debtor's premises the Secured Party may remove the medium in which such information or data is stored from the Debtor's premises to any other place which has a computer system that will give the Secured Party the opportunity to retrieve, record or copy such information and data. 7. COLLECTION OF DEBTS

Before or after default under this Security Agreement, the Secured Party may notify all or any Account Debtors of the Security Interest and may also direct such Account Debtors to pay all payments on the Collateral to the Secured Party. The Debtor acknowledges that any payments on or other Proceeds of the Collateral received by the Debtor from Account Debtors, whether before or after notification of this Security Interest to Account Debtors and whether before or after default under this Security Agreement shall be received and held by the Debtor in trust for the Secured Party and shall be turned over to the Secured Party upon request.

8. EVENTS OF DEFAULT

The happening of any of the following events or conditions shall constitute default hereunder, which is herein referred to as "Default":

- (a) the nonpayment when due, whether by acceleration or otherwise, of any principal, interest or other sums forming part of Indebtedness or the failure of the Debtor to observe or perform any obligation, covenant, term, provision or condition contained in this Security Agreement or any other agreement between the Debtor and the Secured Party;
- (b) the death of or a declaration of incompetency by a court of competent jurisdiction with respect to the Debtor, if any individual;
- (c) the bankruptcy or insolvency of the Debtor; the filing against the Debtor of a petition in bankruptcy; the making of an authorized assignment for the benefit of creditors by the Debtor; the appointment of a receiver or a receiver and manager or trustee for the Debtor or any property of the Debtor, or the institution by or against the debtor of any other type of insolvency proceeding under the Bankruptcy Act or otherwise, or the taking of proceedings under The Companies' Creditors Arrangement Act;
- (d) the institution by or against the Debtor or any formal or informal proceeding for the amalgamation, dissolution, liquidation or winding up of affairs of the Debtor;
- (e) if any encumbrance whether an Existing Encumbrance or otherwise affecting the Collateral becomes enforceable against the Collateral;

- (f) if the Debtor ceases or threatens to cease to carry on business or makes or agrees to make a bulk sale of assets without complying with the applicable law or commits or threatens to commit an act of bankruptcy;
- (g) if any execution, sequestration, extent, distress or any other similar process is levied or enforced against the Debtor or any property of the Debtor;
- (h) if any certificate, statement, representation, warranty or information provided by or on behalf of the Debtor to the Secured Party, whether pursuant to or in connection with this Security Agreement, or otherwise, (including, without limitation, the representations and warranties contained herein) or as an inducement to the Secured Party to extend any credit or to enter into this or any other agreement with the Debtor, proves to have been false or misleading in any material way, or proves to have omitted any contingent or unliquidated liability or claim against the Debtor; or if upon the date of execution of this Security Agreement, there shall have been any material adverse change in any of the facts disclosed by any such certificate, statement, representation, warranty or information, which change shall not have been disclosed to the Secured Party at or prior to the time of such execution;
- (i) if the Debtor fails when due to perform any obligation to any other person, and such failure is not cured within 30 days of the date the Debtor first knew or should have known of such failure;
- (j) if any of the licenses, permits or approvals granted by any government or any governmental authority and essential to the business of the Debtor, is withdrawn cancelled or significantly altered;
- (k) if the Secured Party in good faith believes the prospect of payment or performance of the Debtor's obligations under this Security Agreement is impaired or is likely to be impaired or that the Collateral is or is likely to be placed in jeopardy.

9. ACCELERATION

In the event of default by the Debtor under this Security Agreement the Secured Party, in its sole discretion, may declare all or any part of the Indebtedness which is not by its terms payable on demand, to be immediately due and payable without demand or notice of any kind. The provisions of this clause 9 do not affect or change the demand nature of any portion of the indebtedness which is now or may hereafter be payable on demand.

10. REMEDIES

On default:

- (a) the Secured Party may appoint or reappoint by instrument in writing, any person or persons, whether an officer or officers or an employee or employees of the Secured Party or not, to be a receiver or receivers (hereinafter called the "Receiver", which term when used herein shall include a receiver and manager) of the undertaking of the Debtor and the Collateral (including any interest, income or profits there from) and may remove any Receiver so appointed and appoint another in his stead. Any such Receiver shall, so far as concerns responsibility for his acts, be deemed the agent of the Debtor and not the Secured Party, and the Secured Party shall not in any way be

responsible for any misconduct, negligence or non-feasance on the part of any such Receiver, his servants, agents or employees. Every such Receiver may, in the discretion of the Secured Party, be vested with all or any of the rights and powers of the Secured Party;

- (b) the Secured Party, either directly or through its agents or nominees, may exercise any or all of the powers and rights given to a Receiver by virtue of the foregoing clause 10(a);
- (c) the Secured Party may take possession of, collect, demand, sue on, enforce, recover and receive the Collateral and give valid and binding receipts and discharges therefor and in respect thereof and, the Secured Party may sell, release or otherwise dispose of the Collateral in such manner, at such time or times and place or places, for such consideration and upon such terms and conditions as the Secured Party may deem reasonable;
- (d) in addition to all rights granted by this Security Agreement or otherwise held by the Secured Party, whether in law or in equity, it is specifically acknowledged that, both before and after default, the Secured party shall have all rights and remedies of a secured party under the PPSA. The Secured Party shall not be liable or accountable for any failure to exercise its remedies, take possession of, collect, enforce, realize, sell, lease or otherwise dispose of the Collateral or to institute any proceedings for such purposes and shall have no obligation to take any steps to preserve rights against prior parties to any instrument or chattel paper whether Collateral or Proceeds and whether or not in the Secured Party's possession and shall not be liable or accountable for any failure to do so;
- (e) the Secured Party or any Receiver appointed by it may take possession of the Collateral wherever it may be located by any method permitted by law and the Debtor agrees upon request from the Secured Party or any such Receiver to assemble and deliver possession of the Collateral at such place or places as directed.
- (f) any Receiver will have the power:
 - (i) to take possession of any Collateral and for that purpose to take any proceedings, in the name of the Debtor or otherwise;
 - (ii) to carry on or concur in carrying on the business of the Debtor;
 - (iii) to sell or lease any Collateral by deferred payment or otherwise;
 - (iv) to make any arrangement or compromise which he may think expedient in the interest of the Secured Party;
 - (v) to pay all liabilities and expenses connected with the Collateral, including the cost of insurance and payment of taxes or other charges incurred in obtaining, maintaining possession of and preserving the Collateral, and the same shall be added to the Indebtedness and secured by the Collateral;
 - (vi) to hold as additional security any increase or profits resulting from the Collateral;

- (vii) to exercise all rights the Secured Party has under this Security Agreement, other agreements between the Debtor and Secured Party, or otherwise at law;
- (viii) with the consent of the Secured Party in writing, to borrow money for the purpose of carrying on the business of the Debtor or for the maintenance of the Collateral or any part thereof or for other purposes approved by the Secured Party, and any amount so borrowed together with interest thereon shall form a charge upon the Collateral in priority to the Security Interest created by this Agreement;
- (xi) to enter into and to occupy any premises in which the Debtor has any interest;
- (g) the Debtor hereby appoints each Receiver appointed by the Secured Party to be its attorney to effect transfer, sale, lease or other disposition of any Collateral and any deed, lease, agreement or other document signed by a Receiver under his seal pursuant hereto will have the same effect as if it were under the seal of the Debtor;
- (h) neither the Secured Party, the Receiver or the Sheriff will be required to take any steps to preserve any rights against other parties pursuant to any chattel paper, security, or instrument constituting the Collateral or any part of it;
- (i) neither the Secured Party, the Receiver or the Sheriff is required to keep Collateral identifiable;
- (j) the Secured Party may use the Collateral in any manner as it in its sole discretion deems advisable.

11. SECURITIES

If Collateral at any time includes securities, the Debtor irrevocably authorizes and appoints the Secured Party as its attorney and agent to transfer the same or any part thereof into its own name or that of its nominee so that the Secured Party or its nominee may appear on record as the sole owner thereof; provided that, until Default, the Secured Party shall deliver promptly to the Debtor all notices or other communications received by it or its nominee as such registered owner and, upon demand and receipt of payment of any necessary expenses thereof, shall issue to the Debtor or its order a proxy to vote and take all action with respect to such securities. After default, the Debtor waives all rights to receive any notices or communications received by the Secured Party or its nominee as such registered owner and agrees that no proxy issued by the Secured Party to the Debtor or to its order as aforesaid shall thereafter be effective.

12. COSTS AND EXPENSES

The Debtor agrees to pay all costs, charges and expenses incurred by the Secured Party or any Receiver appointed by it (including, but without restricting the generality of the foregoing, legal fees as between a solicitor and client on a full indemnity basis), in preparing, registering or enforcing this Agreement, taking custody of, preserving, repairing, maintaining, processing, preparing for disposition and disposing of Collateral and in enforcing or collecting the Indebtedness and all such costs, charges and expenses together with any monies owing as a result of any borrowing by the Secured Party or any Receiver appointed by it shall be a first charge on the proceeds of realization,

collection, or disposition of Collateral and shall be secured hereby.

13. MISCELLANEOUS

- (a) The Debtor hereby authorizes the Secured Party to file such financing statements and other documents and do such acts, matters, and things as the Secured Party may deem appropriate to perfect and continue the Security Interest, to protect and preserve the Collateral and to realize upon the Security Interest and the Debtor hereby irrevocably constitutes and appoints the Secured Party or its agent the true and lawful attorney of the Debtor, with the full power of substitution, to do any of the foregoing in the name of the Debtor whenever and where in the sole discretion of the Secured Party it may be deemed necessary or expedient.
- (b) Without limiting any other rights or the Secured Party, whenever the Indebtedness is immediately due and payable or the Secured Party has the right to declare Indebtedness to be immediately due and payable, whether or not it has so declared, the Secured Party may, in its sole discretion, set off the Indebtedness or any portion thereof against any and all monies then owed to the Debtor by the Secured Party in any capacity, whether or not due, and the Secured Party shall be deemed to have exercised such right to set off immediately at the time of making its decision to do so even though such set off may only subsequently entered in the Secured Parties records.
- (c) The Secured Party may grant extensions of time and other indulgences, take and give up security, accept compositions, compound, compromise, settle, grant releases and discharges and otherwise deal with the Debtor, debtors of the Debtor, sureties, guarantors, and others and with the Collateral and other security as the Secured Party may see fit without prejudice to the liability of the Debtor or the Secured Party's rights to hold and realize the Security Interest. Furthermore, the Secured Party may demand, collect and sue on the Collateral in either the Debtor's or the Secured Party's name at the Secured Party's option, and may endorse the Debtor's name or any and all cheques, commercial paper, and other instruments pertaining to or constituting Collateral.
- (d) No delay or omission by the Secured Party in exercising any right or remedy under this Security Agreement or with respect to the Indebtedness or any portion thereof shall operate as a waiver of any of the Secured Party's rights or remedies, and no single or partial exercise thereof shall preclude any other right or remedy. Furthermore, the Secured Party may but is not obligated to remedy any default by the Debtor under this Security Agreement in any reasonable manner without waiving the default remedies and without waiving any other prior or subsequent default by the Debtor. All rights and remedies of the Secured Party granted or recognized herein are cumulative and may be exercised at any time and from time to time independently or in combination.
- (e) This Security Agreement shall enure to the benefit of and be binding upon the parties hereto and their respective heirs, executors, administrators, successors and permitted assigns. In any action brought by an assignee of this Security Agreement and the Security Interest or any part thereof to enforce any rights hereunder, the Debtor shall not assert against the assignee any claim or defence which the Debtor now has or hereafter may have against the Secured Party.

- (f) This Security Agreement shall not be assignable by the Debtor without the prior written consent of the Secured Party, which consent may be arbitrarily withheld.
- (g) Any case where more than one (1) Debtor executes this Security agreement the obligation of such Debtors hereunder shall be joint and several.
- (h) This Security Agreement and the security created hereby is in addition to and not in substitution for any other security now or hereafter held by the Secured Party.
- (i) The headings used in this Security Agreement are for convenience only and are not to be considered a part of the Security Agreement and do not in any way limit or amplify the terms and provisions of this Security Agreement.
- (j) The Security Interest created hereby is intended to attach upon the execution of this Security Agreement, except that, in respect of after-acquired property subject to the Security Interest, attachment shall occur forthwith upon the Debtor acquiring its interest and rights thereto, and the Debtor and the Secured Party agree that value has been given by the Secured Party to the Debtor.
- (k) Whenever the singular number and masculine gender, respectively, are used in this Security Agreement, the same shall be construed as meaning and including the plural and/or feminine or neutral gender, respectively, if the context so requires.
- (l) Any provision of this Security Agreement which is prohibited or unenforceable shall be ineffective only to the extent of such prohibition or unenforceability without invalidating the remaining provisions hereof.
- (m) This Security Agreement contains the entire agreement between the parties relating to the Security Interests granted herein. Any modification of this Security Agreement or waiver of any provision herein contained shall not be binding unless in writing and signed by the Secured Party and the Debtor. This Security Agreement shall continue in effect until the obligations hereunder are satisfied and the indebtedness paid in full.
- (n) Nothing herein shall obligate the Secured Party to make any advance or loan or further advance or extend credit to the Debtor.
- (o) The Secured Party shall be entitled to charge the Debtor a \$100.00 additional charge for every payment made by the Debtor to the Secured Party that is dishonoured.

14. COPY OF AGREEMENT

The Debtor hereby acknowledges receipt of a copy of this Security Agreement.

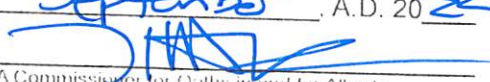

WHEREAS the Landlord is the registered owner of the lands described as:

EXCEPTING THEREOUT ALL MINES AND MINERALS

Herein called the "Lands"

AND THE OWNER OF THE BUILDING LOCATED ON THE SAID LAND herein called the "Building".

AND WHEREAS the parties are entering this lease for the building containing about 3,455 square feet and particularly located at the municipal address: 7151 50 Ave. Red Deer, AB T4N 4E4, and delineated on the plan attached as Schedule "A" herein called the "Premises".

AND WHEREAS the Tenant is desirous of leasing the said premises from the Landlord, and the Landlord is desirous of leasing the said Premises to the Tenant on the terms contained herein.

NOW IN CONSIDERATION of the mutual covenants herein IT IS HEREBY AGREED as follows:

TERMS:

1. The term of the Lease shall be **Ten (10)** years commencing **September 1st, 2022.**

MONTHLY RENT:

2. The Tenant shall pay to the Landlord at the place designated by the Landlord in the advance on the 1st day of each month in each and every year during the term of the Lease the following monthly rent:
 - 2.1 For the period from **September 1st, 2022 to August 31st 2027**, the Tenant agrees to pay the Landlord the sum of **\$19509.41** per month for the Premises (the "Rent"), which shall be payable by electronic fund transfer, or any other method of payment agreed to in writing by the parties, in advance on or before the first day of the month and shall be **exclusive of the Goods and Services Tax**.
 - 2.2 For the period from **September 1st, 2027 to August 31st 2032**, the Tenant agrees to pay the Landlord the sum of **\$19888.85** per month for the Premises (the "Rent"), which shall be payable by electronic fund transfer, or any other method of payment agreed to in writing by the parties, in advance on or before the first day of the month and shall be **exclusive of the Goods and Services Tax**.

If the Term commences on any day other than the first day of the month or ends any day other than the last day of the month, rent for the fractions of a month at the commencement and at the end of the Term shall be calculated on a *pro rata* basis and shall be payable on the first day of the partial month.

Unless otherwise notified in writing, the Tenant will pay the Rent to the party designated in section 27 of this Agreement.

3. OPERATING COSTS RENT.

3.1. In this section, operating costs means the following:

- Property taxes.**
- Exterior Building Maintenance and repairs.**
- Parking lot maintenance and repairs**
- Building Landscaping maintenance and repairs**
- Building Insurance.**
- HVAC maintenance and repair.**
- Management Fees**

And such other reasonable costs, without duplication, payable or incurred by the Landlord with respect to the repair, operation, or maintenance of the Building (collectively, the "Operating Costs"),

The Tenant shall pay monthly **\$2232.88** in advance, at the same time and in the same manner as the Rent, a share of the estimated Operating Costs based upon the proportion of square area of the Premises relative to the total square area of the Building.

3.2. The Landlord shall deliver annually to the Tenant, within a reasonable period of time after the end of the year for which payments for estimated Operating Costs have been made, an audited statement setting out the amount of each type of actual cost to be paid prorated

according to subsection (3.2), and the difference, if any, between the actual Operating Costs and the estimated amount paid by the Tenant. Any overpayment or underpayment shall be paid by the indebted party within sixty (60) days of the Tenant's receipt of the audited statement.

3.3. The Landlord shall maintain complete records of all operating costs and these shall be made available, upon reasonable notice, for audit and inspection by the Tenant.

3.4. Operating Costs shall be determined in accordance with accounting standards in force at the relevant time in Canada, consistently applied, as applicable to the Landlord.

4. OPTION TO RENEW:

Subject to the Tenant not being in material default of this Agreement, the Tenant shall have the option to renew this Agreement for one (1) further term of five (5) years ("Option to renew"). The Tenant shall exercise the Option to renew by providing written notice to the Landlord no earlier than nine (9) months and not later than three (3) months prior to the expiration of the term. The rent shall be a rate agreed to by the parties or at the fair market value for comparable premises in the area at the time the Term is extended.

In the event that the Landlord and the Tenant are unable to agree as to the rent within ninety(90)days of expiration of the lease the determination of the same shall be made by a single arbitrator appointed by the Landlord based on the fair market rent of a premises of the similar age , nature and usage .

UTILITIES:

5. The Tenants shall pay for all utilities separately metered to the Leased Premises.

RULES AND REGULATION:

6. The Tenant, its agents, officers and employees shall observe any reasonable rules and regulations that the Landlord may make for the safety, care and cleanliness of the Building, the comfort and convenience of the Tenant and the preservation of the reputation of good order of the Building, as outlined on the attached Schedule "B" (the "Rules and Regulations"). The Landlord shall advise the Tenant in writing of such rules, regulations and amendments thereto, that may be made by the Landlord from time to time,

GOOD AND SUBSTANTIAL REPAIR:

7. (a) The Tenant shall keep, at the expense of the Tenant, at all times during the said term the Premises in a clean and sanitary condition and in good substantial repair, reasonable wear and tear excepted, and to replace any broken glass windows in the Premises and, without limiting the generality of the forgoing the Tenant will, during the term of the Lease, cause such good management and care to be taken of the Premises and the various parts thereof, both interior and

exterior, that no injury to the same shall occur, and that the pipes, pumps, valves, reservoirs, sinks, plumbing apparatus and fastenings of all kinds on the said premises shall be kept during the said term in a state of efficient and good working order and that all heating apparatus, water closets, sinks and accessories thereto on the Premises shall be protected from frost and kept at all times free from any un-cleanliness or obstruction that would prevent their efficient working and that repairs needful or expedient to keep them in efficient working order during the said term will be borne by the tenant. And the Tenants shall be responsible for all the repairs, maintenance and decoration with respect to the Premises and will promptly, at its expense, carry out any and all repairs thereto. The Tenant shall be responsible for all janitorial services respecting the Premises, including the washing of windows.

(b) The Tenant shall allow the Landlord to enter upon the Premises and view the state of repair and if requires by the Landlord, the Tenant shall maintain or repair as provided in any notice delivered to the Tenant. Nothing herein shall obligate the Tenant to make repairs to concrete foundation of the building. Default by the Tenant in maintaining or repairing as the case may require, shall allow but not to obligate the Landlord to perform the same and to the costs to the Tenant.

DELIVERY AT CONCLUSION:

8. At the expiry or earlier termination of the term or any renewal the Tenant shall deliver up vacant possession of the Premises in a good and substantial state of repair, reasonable wear and tear only excepted. In the event the Tenant holds over at the conclusion of the term or renewal, such holding over shall not be considered as a periodic tenancy by implication, statute or otherwise. The Tenant shall make good any damage caused by removal of its trade fixtures at the conclusion of the lease or any renewal.

USE:

9. The Tenant shall at all times use the Premises for a **Dental Clinic** and will not carry on the activity which shall be regarded as a nuisance to the Landlord, adjoining Land owners or other Tenants in the building.

ASSIGNMENT:

10. The Tenant shall not assign, sublet, or part with the possession of the Premises without prior written consent of the Landlord not to be unreasonably withheld. Upon any assignment or subletting the Tenant shall pay the Landlord reasonable legal fees for reviewing and approving the Lease Assignment or sublease. No Assignment shall relieve or release the Tenant from Liability under this lease.

ALTERATIONS:

11. Except as otherwise stated in this Lease the Tenant shall not make any improvement, alteration or renovation to the said Premises without the prior written consent of the Landlord such consent not to be unreasonably withheld. Any and all such improvements, alterations or renovations shall be at

the sole cost of the Tenant and shall become the property of the Landlord upon becoming affixed to the building.

INTEREST:

9. Any rent not paid when due shall bear interest at the rate of twelve (12%) percent per annum before and after any judgement.

POSTPONEMENT:

10. This Lease shall be subordinate to any method of financing both present and future obtained by the Landlord, its successors, and assigns and in the regard to the Tenant shall upon request execute and deliver a postponement of Lease howsoever registered on title thereby postponing the Tenant's interest to that of any such lenders it being a condition of such postponement that the Landlord shall cause to be delivered to the Tenant a letter of Non-Disturbance executed by the Lender in favour of the Tenant such that the Lease will not be disturbed so long as the Tenant is not in default.

PAYMENT:

11. All rent payments, costs, and **charges** to be paid by the Tenant herein shall be considered rent and collectable as such and shall be paid to the Landlord without abatement, deduction, set-off, or counterclaim of any nature or kind.

DAMAGE TO FLOOR FROM HEAVY WEIGHTS:

12. The Tenants will not bring upon the Premises or the building or any part there of any machinery, equipment, article or thing that by reason of its weight, size, or use might damage the Premises.

IDEMNITY OF LANDLORD:

13. The Tenant hereby indemnifies the Landlord from all liabilities, fines, suits, claims and actions of any kind or nature for which the Landlord shall or may become liable or suffer by reason of any breach, violation, or non-performance by the Tenant covenant or provision hereof, or by reason of any injury or death occasioned to or suffered by any person or persons or any property through the act, neglect or default by the Tenant or any of its agents or employees; such indemnification in respect of any such breach, violation, or non-performance, damage to property, injury or death occurring during the term of the Lease shall survive any termination of this Lease.

EXCLUSION OF LIABILITY:

14. It is agreed between the Landlord and Tenant that:

- (a) The Landlord, its agents, servants and employees, shall not be liable for damage or injury to any property of the Tenant which is entrusted to the care or control of the Landlord, its agents, servants or employees.
- (b) The Landlord, its agents, servants and employees, shall not be liable nor responsible in any way for any personal or consequential injury of any nature whatsoever that may be suffered or sustained by the Tenant or any employees, agent, customer, invitee, or licensee of the Tenant or any other person who may be upon the Premises or for any loss of damage or injury to any property belonging to the Tenant or to its employees or to any other person while such property is on the Premises and, in particular (but without limiting the generality of the foregoing), the Landlord shall not be liable for any damage or damages of any nature whatsoever to any such property caused by the failure, by reason of a breakdown or other cause, to supply adequate drainage, snow or ice removal, or by reason of the interruption of any public utility or service or in the event of the stream, water, rain or snow which may leak into, issue or flow from any part of the building or from the water, steam, sprinkler, or drainage pipes or plumbing works, or from any other place or quarter or for any damage caused by anything one or omitted. The Tenant shall not be entitled to any abatement or rental in respect of any such condition, failure or interruption of service.
- (c) The Landlord, its agents, servants, employees or contractors shall not be liable for any damage suffered to the Premises or the contents thereof by reason of the Landlord, its agents, servants, employees or contractors, entering upon the Premises as herein provided to undertake any examination thereof.

INSURANCE:

15. Tenant Insurance: The Tenant throughout the term of this Lease:

- (a) The Tenant, at all times during the Term, is responsible for maintaining self-insurance program covering its property on the Demised Premises.
- (b) The Tenant, at all times during the Term, agrees to maintain a self-insurance program providing general liability coverage, in an amount not less than two million (\$2,000,000) dollars inclusive per occurrence, to protect the Tenant in the event of third party claims for bodily injury, personal injury and property damage arising out of the occupancy of the Demised Premises.
- (c) The Tenant waives its right of recourse against the Landlord with regard to loss or damage to the Tenant's property under this Agreement whether or not the cause of such loss or is the negligence of the Landlord and shall make its insurer, if any aware of this waiver.
- (d) All such policies shall provide thirty (30) days' prior written notice of cancellation or termination. Certificates evidencing the insurance shall be made available to the Landlord upon request.

CLEANLINESS OF THE DEMISED PREMISES:

16. The Tenant shall keep the premises and every part thereof in a clean and tidy condition and not permit waste, pollution, contamination, garbage, or objectionable material to be placed upon accumulate or remain thereon.

RECEIPTS:

17. The Tenant shall produce to the Landlord on request satisfactory evidence of the due payment by the Tenant of all payments required to be made by the Tenant under this Lease.

INSPECTION:

1. I have personal knowledge of the matters hereinafter deposed to, except where stated to be based on information and belief, in which case I verily believe the same to be true.

2. I am a director and officer of the defendant 985842 Alberta Ltd. ("985") and am authorized by 985 to swear this affidavit on its behalf.
3. I have reviewed 985's records relevant to the within application and action and am satisfied that I am possessed of sufficient knowledge to swear this affidavit.
4. The defendant Sarah Moe ("Sarah") is my sister.
5. The defendant Michael Dave ("Michael") is my brother.
6. I am a trained dentist and, at all times material to this action, I have been licensed to practice dentistry in the province of Alberta.

13. Further, at no time did I, 985 or any other entity over which I have or had control:

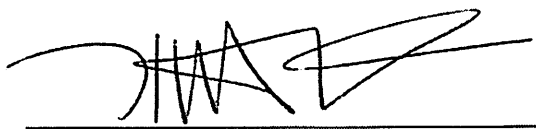
a) Induce or cause Sarah or Moe PC to abandon the Premises (as defined in the pleadings filed in this action.); or

Hi Susy,

I just got off the phone with Dr. Mouhamad. Apparently, a bailiff is at the Red Deer clinic now effecting seizure of various items at the instruction of your office on behalf of RBC. I had a brief discussion with the bailiff and understand that his instructions are to leave the seized items in place under a bailee's undertaking. A couple of things:

1. In order to minimize disruption to the practice, I instructed Dr. Mouhamad to allow the bailiff to do his job. However, I am told that none of the items that are being placed under seizure are owned by the debtor corporations. My understanding is that all of the equipment and leasehold improvements are owned by Michael Dave Management Ltd. ("MDM"). MDM views the seizure of its personal property as wrongful and reserves any rights and remedies it has in relation to that wrongful seizure.

2. Regardless of any disputes concerning the ownership of the seized items, some of what will be placed under seizure is inventory and we will need confirmation that the inventory can be used in the normal course of the clinic's business operations notwithstanding the seizure and bailee's undertaking.
