LOCAL LEADER INC.- IN RECEIVERSHIP Notice of Invitation for Offers to Purchase

INTRODUCTION

On January 31, 2024, Local Leader Inc. ("Local Leader" or, the "Company") made a voluntary assignment in bankruptcy and MNP Ltd. ("MNP") was appointed as the Licensed Insolvency Trustee of the Bankrupt estate.

On March 15, 2024, MNP was appointed as receiver and manager (the "Receiver") of Local Leader pursuant to an order (the "Receivership Order") granted by the Supreme Court of British Columbia.

Local Leader is a federally registered corporation. The Company was named Revoupon Inc. from January 16, 2013, until January 16, 2014. The Company then changed its name to Parkbench Inc. until the name was changed to Local Leader Inc. on January 3, 2023

The Company operated various websites under a subscription-based model and provided marketing services to real estate agents and business owners. The Company's platform enabled users to create profiles and leverage data to promote engagement within specific communities or neighborhoods. MNP in its capacity and Trustee and Receiver has taken steps to preserve the Company's assets and has restored the Company's online platform which is currently being offered to its customers free of charge for a limited period of time. The Receiver is soliciting offers to purchase the Company's intellectual property including the Company's websites and all subdomain names, customer list, databases and website content (the "Assets"). The Assets are being offered for sale as a single lot. The Receiver has prepared a virtual data room for the purpose of due diligence for prospective purchasers. The Receiver will require that prospective purchasers complete a confidentiality and non disclosure agreement prior to obtaining access to the virtual data room.

To facilitate this process, the Receiver has prepared an Invitation for Offers to Purchase (the "Invitation") and the Invitation has been prepared solely for information purposes to assist prospective purchasers in making an evaluation of the Company's Assets. The Receiver does not make any representation or warranty as to the accuracy or completeness of the information in the Invitation and shall have no liability for any representations (express or implied) contained in or for any omissions from this Invitation, or for any other written or oral communications transmitted to purchasers in the course of their evaluation of the Assets.
