PURPOSE OF REPORT

- 1. Pursuant to an Order of the Court of King's Bench of Alberta granted March 21, 2023 (the "Limited Receivership Order"), MNP Ltd. ("MNP") was appointed receiver (the "Receiver") of certain personal property of 1631807 Alberta Ltd. ("163 Alberta") and Radient Technologies Inc. ("Radient") (collectively the "Debtors" or "Companies") described in Exhibit "L" of the Affidavit of Brian Moskowitz dated March 13, 2023 together with any other personal property of the Debtors as may be agreed upon by the Receiver and the Debtors, including all proceeds thereof (the "Equipment"). The Equipment did not include the proceeds of any disposition of chattel property belonging to the Debtors held in trust as of March 21, 2023, by Dentons Canada LLP ("Dentons"). A copy of the Limited Receivership Order granted by the Honourable Justice D.R. Mah is attached as Appendix "A".
- 2. This is the second report to Court filed by the Receiver regarding the administration of the estate of the Companies (the "Second Report"). This report should be read in conjunction with the Receiver's First Report to Court dated May 23, 2023 (the "First Report").
- 3. The purpose of this report is to:
 - Update this Honourable Court with the Receiver's activities since the Receiver's First Report;
 - Assist this Honourable Court's consideration of the Receiver's application for approval of a supplementary auction proposal made by Workingman Capital Corp. ("Workingman") for the auction of the remaining personal property of the Companies (the "Second Auction Sale"), and an amending agreement to the previously approved auction agreement (the "Auction Agreement") to be executed by the Receiver and Workingman subject to Court approval; and,
 - Assist in this Honorable Court's consideration of the Receiver's application to increase the Receiver's Charge as granted in the Limited Receivership Order from \$50,000 to \$100,000.

BACKGROUND INFORMATION

- 4. The Companies are a licensed manufacturer in the cannabis industry operating in Edmonton, Alberta. 163 Alberta is a wholly owned subsidiary of Radient.
- 5. Radient operates out of a facility located in Edmonton, Alberta owned by 163 Alberta. The facility includes a main office and extraction building as well as a partiality complete, vacant warehouse building (the "Facility").
- 6. Francesco Ferlaino, Gougoux Yves, Harry Kaura, Jocelyne LaFreniere, Jan Petzel and Steven Splinter are the directors of Radient which was incorporated on May 22, 2014.
- 7. Harry Kaura is the sole director of 163 Alberta. 163 Alberta was incorporated on September 29, 2011.

INSOLVENCY EVENTS

- 8. Pursuant to a written lending agreement dated May 2, 2018, and various written amending instructions made between June 2018 and April 2022, Moskowitz Capital Mortgage Fund II Inc. ("MCMF") advanced funds and charged agreed upon fees to the Companies.
- 9. The Companies defaulted on obligations owing to MCMF in mid-2022 and were unable to cure such default.
- 10. MCMF commenced mortgage proceedings against the Companies and on January 16, 2023, MCMF obtained a Redemption Order Listing with a 1-day redemption period. The Facility is currently listed for sale pursuant to the Redemption Order Listing.
- 11. As the listing price for the judicial sale of the Facility is significantly less than the current value of outstanding debt owing to MCMF, MCMF deemed it necessary to enforce their security over the Debtors' personal property.
- 12. On March 21, 2023, MCMF applied for and obtained the Limited Receivership Order.
- 13. MNP is only the Receiver of the Equipment described in Exhibit "L" of the Affidavit of Brian Moskowitz dated March 13, 2023, together with any other personal property of the Debtors as may be agreed upon by the Receiver and the Debtor. The Equipment is comprised of

- approximately 168 articles of industrial equipment and miscellaneous inventory, much of which is highly specialized and designed for use in the cannabis or bio-medical industries.
- 14. On April 25, 2023, the Companies and the Receiver agreed to include three crates containing a LC mass spectrometer, TEMA centrifuge and associated parts in the Equipment to be offered for sale.
- 15. On May 30, 2023, the Receiver applied for and obtained an Approval and Vesting Order (Sale by Receiver) (the "Approval Order") authorizing the Receiver to engage Workingman to auction the Equipment (the "First Auction Sale") described in Exhibit "L". A copy of the Approval Order is attached as Appendix "B".
- 16. On June 23, 2023, the Receiver applied for and obtained an Order by consent (the "Consent Order") amending the Approval Order to include a VTA short path distillation plant to be sold by Workingman in the First Auction Sale. A copy of the Consent Order is attached as Appendix "C".
- 17. Workingman inventoried and catalogued the Equipment and posted details online on BidSpotter with the First Auction Sale going live on or around June 12, 2023. On June 26, 2023, Workingman hosted an inspection day at the Facility allowing interested parties to view the Equipment. On June 27, 2023, bidding closed, and the First Auction Sale concluded.
- 18. On June 19, 2023, Steven Splinter, Interim CEO and Director of Radient, advised that operations had been temporarily shut down. The Receiver understands this is still the case as at the date of this Second Report.
- 19. We understand MCMF is seeking to amend the Limited Receivership Order to include the remaining assets of the Debtors so that the Receiver may proceed with the Second Auction Sale of the remaining assets, which are specifically included at Exhibit "A" of the Third Affidavit of Brian Moskowitz of July 10, 2023 (the "Third Affidavit"), along with any assets that were included in the First Sale and Vesting Order but were not sold at the First Auction Sale. A copy of the Third Affidavit is attached as Appendix "D".

RECEIVER'S ACTIVITIES

- 20. Since the First Report, the Receiver has coordinated and supervised the First Auction Sale including assisting with access to the Facility during and after the auction process.
- 21. The Receiver has had various correspondence with Workingman regarding the First Auction Sale, security at the Facility, auction results and asset removal considerations.
- 22. The Receiver has had various correspondence with the Companies and with the Canada Revenue Agency ("CRA") regarding the trust audit, outstanding returns and the balances owing.
- 23. The Receiver has received and reviewed the property claims filed by the CRA.
- 24. The Receiver has had various correspondence with Dentons, counsel to Agriculture Financial Services Corporation ("AFSC"), regarding the AFSC security and balance owing.
- 25. The Receiver has had various correspondence with its legal counsel regarding including the VTA short path distillation plant in the First Auction Sale and obtaining a Consent Order to approve such addition.
- 26. The Receiver has reviewed the listing of the Debtors' remaining assets to be auctioned and requested a proposal from Workingman on auctioning the additional assets.
- 27. The Receiver has had various discussions and correspondence with Workingman regarding the proposed Second Auction Sale and an amendment of the Auction Agreement to include additional equipment.
- 28. The Receiver continues to complete its administrative requirements pursuant to the Bankruptcy and Insolvency Act. The Receiver set up a website to provide information to the Companies' creditors and interested parties and held discussions with creditors regarding the status of the Limited Receivership and the administration of the estate.

THE SENIOR SECURITY HELD BY MOSKOWITZ CAPITAL MORTGAGE FUND II INC.

29. Pursuant to General Security Agreement given by 163 Alberta dated May 2, 2018, and a General Security Agreement given by Radient dated August 31, 2018, MCMF holds a

- charge over all present and after acquired property relating to the business of the Companies (excluding consumer goods).
- 30. Copies of the Personal Property Registry Search Result Reports as at March 9, 2023 for the Companies are attached as **Appendix "E"**.
- 31. The Companies also granted MCMF a mortgage against the title of the Facility as additional collateral security. The real property is excluded from the scope of the Limited Receivership Order.
- 32. The Receiver has obtained a legal opinion from its legal counsel confirming the MCMF security is valid and enforceable, subject to the normal qualifications and assumptions contained in an opinion of that nature.
- 33. As at March 8, 2023, the Companies owed MCMF \$12,067,093, plus interest and costs on the go forward.

PRIORITY CLAIMS

- 34. The Receiver is aware of two claims it believes ranks in priority of the MCMF security:
 - i. CRA deemed trust property claim; and,
 - ii. Funds owed to AFSC.

Canada Revenue Agency

- 35. A trust audit was performed by the CRA for unpaid source deductions and GST.
- 36. CRA has filed a property claim with the Receiver for the following amounts;
 - i. Radient payroll source deductions in the amount of \$204,771; and
 - ii. 163 Alberta goods and services tax ("GST") in the amount of \$21,513.
- 37. CRA has not filed a GST claim for Radient and has advised there are certain GST and corporate tax filings outstanding as at the date of this report. Given the scope of the Limited Receivership Order, the Receiver has sent correspondence to the Companies advising of the outstanding returns and asking that they be filed as soon as possible.

Agriculture Financial Services Corporation

- 38. Pursuant to a Security Agreement dated September 29, 2011, AFSC holds a first charge over all present and after acquired property of Radient.
- 39. AFSC has registered their security at the Personal Property Registry as evidenced in the search results for Radient attached as **Appendix "E"**.
- 40. The Receiver has obtained a legal opinion from its legal counsel confirming the AFSC security is valid and enforceable, subject to the normal qualifications and assumptions contained in an opinion of that nature.
- 41. AFSC has advised the amount owing as of July 14, 2023 is \$326,347 CAD. Dentons, counsel to AFSC, currently holds \$146,286 CAD and \$55,900 USD in a trust account. These funds were derived from the voluntary sale of personal property owned by Radient, subject to AFSC's security, and prior to the granting of the Limited Receivership Order.
- 42. The Receiver will provide updated amounts and further details regarding the priority claims in a subsequent report and application to Court to approve distributions once realizations are complete.

MARKETING AND SALES PROCESS

- 41. Regarding the marketing of the Equipment, the Limited Receivership Order authorizes the Receiver to market it for sale but does not specify a specific process in that regard. The Receivership Order requires the Receiver obtain Court approval for any sale exceeding \$50,000 or the aggregate of all sales transactions exceeds \$200,000.
- 42. As noted in the First Report, the Receiver previously prepared and distributed a Request for Offers to Purchase or Liquidation Proposals (the "ROP"). Five interested parties conducted in depth due diligence and toured the Facility to view the Equipment.
- 43. The Receiver received three auction proposals and one offer to purchase.
- 44. The Receiver reviewed the offer and proposals received, analyzing commission, fee structures and net minimum guarantee amounts. The value of the equipment is believed to be significant and therefore commission and fee structures played a key role.

- 45. The auction proposal from Workingman was determined by the Receiver to be the highest and best value offer. Their proposal included a guaranteed minimum advance, and reasonable commission and auction fee structure. Workingman's proposed timing of completion within 60 to 90 days was also the most favorable.
- 46. Workingman's marketing plan included a comprehensive and global marketing campaign, auctioning each asset via a live webcast auction and highlighting strategic assets to garner attention.
- 47. The First Auction Sale closed on June 27, 2023, and the preliminary results of the auction yielded better results than expected. A fulsome analysis and related sale amounts will be provided in a subsequent report and application to Court to approve distributions.

SECOND AUCTION SALE

- 48. As noted above, MCMF is seeking to amend the Limited Receivership Order to include the remaining assets of the Debtors so that the Receiver may proceed with the Second Auction Sale.
- 49. The Receiver requested and obtained a supplementary auction proposal from Workingman for the Second Auction Sale (the "Supplementary Proposal").
- 50. The Supplementary Proposal is virtually identical, except it contains no net minimum guarantee and the auction costs specific to the Second Auction Sale have been reduced by at least \$4,000. Further details can be found in the initial Workingman proposal included as Confidential Appendix 2 to the Receiver's First Report.
- 51. Workingman has proposed an auction timeline of 60-90 days, with a target auction date within 45 days for the Second Auction Sale.
- 52. We note that given the current status of operations and limited scope of the Receivership, arrangements will need to be made with the Debtors to allow for continued access and supervision at the Facility while controlled substances remain on site. We understand that the Debtors are in the process of removing all controlled substances but do not have confirmation when this will be completed.

- 43. Upon review of the remaining equipment listing and due to Workingman's familiarity with the equipment, and potential purchasers, the Receiver believes Workingman is best suited to complete the Second Auction Sale for the following reasons:
 - i. The Receiver is satisfied with the results of the First Auction Sale:
 - ii. Workingman and its agents remain on site at the Debtors' Facility and are in the process of collecting payment and shipping assets sold in the First Auction Sale;
 - iii. Any assets subject to the First Sale and Approval Order that remain unsold following the First Auction Sale will be included by Workingman in the Second Auction Sale;
 - iv. The Second Auction Sale can proceed without delay; and.
 - v. There are significant efficiencies should the Receiver not need to conduct a new request for proposals process, together with such ancillary matters including but not limited to, reaching terms on a new auction agreement and a further Court appearance.
- 53. MCMF supports Workingman completing the Second Auction Sale.
- 54. The Receiver respectfully requests that this Honourable Court approve the Second Auction Sale to be completed by Workingman and any necessary amendments to the previously approved Auction Agreement between the Receiver and Workingman.

RECEIVER'S CHARGE

- 55. Given the increased scope of the Limited Receivership Order, additional work required to coordinate and complete the Second Auction Sale as well as a further application for distribution and discharge, the Receiver estimates that its fees and the fees of its counsel, will exceed the Receiver's Charge of \$50,000 granted in the Limited Receivership Order.
- 56. The Receiver respectfully requests that this Honourable Court increase the Receiver's Charge to \$100,000.

CONCLUSION

- 57. The Receiver respectfully requests the Court grant an Order:
 - i. Approving the activities of the Receiver as set out herein;
 - ii. Approving the proposed Second Auction Sale to be completed by Workingman;
 - iii. Approving any amendment as necessary to the Auction Agreement between Workingman and the Receiver;
 - iv. Increasing the Receiver's Charge to \$100,000; and,
 - v. Any further direction that the Court wishes to provide to the Receiver.

Service

1. The time for service of the notice of application for this order (the "**Order**") is hereby abridged and deemed good and sufficient and this application is properly returnable today.

Appointment

2. Pursuant to section 243(1) of the *Bankruptcy and Insolvency Act*, RSC 1985, c. B-3 (the "BIA"), and sections 13(2) of the *Judicature Act*, RSA 2000, c.J-2, and 65(7) of the *Personal Property Security Act*, RSA 2000, c.P-7 MNP Ltd. is hereby appointed Receiver, without security, of the personal property of the Debtor's described in Exhibit "L" of the Affidavit of Brian Moskowitz dated March 13, 2023, together with any other personal property of the Debtor as may be agreed upon by the Receiver and the Debtor, including all proceeds thereof (the "Property"). For greater certainty, and without restricting the generality of the foregoing, the Property shall not include the proceeds of any disposition of chattel property belonging to the Debtor held in trust as of the date of this Order by Dentons Canada LLP.

Receiver's Powers

- 3. The Receiver is hereby empowered and authorized, but not obligated, to act at once in respect of the Property and, without in any way limiting the generality of the foregoing, the Receiver is hereby expressly empowered and authorized to do any of the following where the Receiver considers it necessary or desirable:
 - (a) to take possession of and exercise control over the Property and any and all proceeds, receipts and disbursements arising out of or from the Property, which shall include the Receiver's ability to abandon, dispose of, or otherwise release any interest in the Property;
 - (b) to receive, preserve and protect the Property, or any part or parts thereof, including, but not limited to, the changing of locks and security codes, the relocating of Property to safeguard it, the engaging of independent security personnel, the taking of physical inventories and the placement of such insurance coverage as may be necessary or desirable;
 - (c) to cease to perform any contract of the Debtor connected or relating to the use, operation, lease, license, sale, transfer or other disposition of the Property;
 - (d) to engage consultants, appraisers, agents, experts, auditors, accountants, managers, counsel and such other persons from time to time and on whatever basis, including on a temporary basis, to assist with the exercise of the Receiver's powers and duties, including without limitation those conferred by this Order;

- (e) to execute, assign, issue and endorse documents of whatever nature in respect of any of the Property, whether in the Receiver's name or in the name and on behalf of the Debtor, for any purpose pursuant to this Order;
- (f) to initiate, prosecute and continue the prosecution of any and all proceedings and to defend all proceedings now pending or hereafter instituted with respect to the Property or the Receiver, and to settle or compromise any such proceedings. The authority hereby conveyed shall extend to such appeals or applications for judicial review in respect of any order or judgment pronounced in any such proceeding, and provided further that nothing in this Order shall authorize the Receiver to defend or settle the action in which this Order is made unless otherwise directed by this Court;
- (g) to market any or all the Property, including advertising and soliciting offers in respect of the Property or any part or parts thereof and negotiating such terms and conditions of sale as the Receiver in its discretion may deem appropriate;
- (h) to sell, convey, transfer, lease or assign the Property or any part or parts thereof out of the ordinary course of business:
 - without the approval of this Court in respect of any transaction not exceeding \$50,000 provided that the aggregate consideration for all such transactions does not exceed \$200,000; and
 - ii. with the approval of this Court in respect of any transaction in which the purchase price or the aggregate purchase price exceeds the applicable amount set out in the preceding clause;

and in each such case notice under subsection 60(8) of the *Personal Property Security Act*, RSA 2000, c. P-7 or any other similar legislation in any other province or territory shall not be required.

- to apply for any vesting order or other orders (including, without limitation, confidentiality
 or sealing orders) necessary to convey the Property or any part or parts thereof to a
 purchaser or purchasers thereof, free and clear of any liens or encumbrances affecting
 such Property;
- (j) to report to, meet with and discuss with such affected Persons (as defined below) as the Receiver deems appropriate all matters relating to the Property and the receivership, and to share information, subject to such terms as to confidentiality as the Receiver deems advisable;

- to register a copy of this Order and any other orders in respect of the Property against title to any of the Property, and when submitted by the Receiver for registration this Order shall be immediately registered by the Registrar of Land Titles of Alberta, or any other similar government authority, notwithstanding Section 191 of the *Land Titles Act*, RSA 2000, c. L-4, or the provisions of any other similar legislation in any other province or territory, and notwithstanding that the appeal period in respect of this Order has not elapsed and the Registrar of Land Titles shall accept all Affidavits of Corporate Signing Authority submitted by the Receiver in its capacity as Receiver of the Debtor and not in its personal capacity;
- (I) to apply for any permits, licences, approvals or permissions as may be required by any governmental authority in connection with the Property and any renewals thereof for and on behalf of and, if thought desirable by the Receiver, in the name of the Debtor;
- (m) to enter into agreements with any trustee in bankruptcy appointed in respect of the Debtor, including, without limiting the generality of the foregoing, the ability to enter into occupation agreements for any property owned or leased by the Debtor; and
- to take any steps reasonably incidental to the exercise of these powers or the performance of any statutory obligations;

and in each case where the Receiver takes any such actions or steps, it shall be exclusively authorized and empowered to do so, to the exclusion of all other Persons, including the Debtor, and without interference from any other Person (as defined below).

- 4. Notwithstanding anything in paragraph 3 of this Order, the Receiver shall not be empowered or authorized to manage, operate, or carry on the business of the Debtor or to perform any contractual obligation of the Debtor.
- 5. Notwithstanding anything in paragraph 3 of this Order, the Receiver shall provide to any secured creditor who requests information of the Debtor relating to amounts owing by the Debtor pursuant to the *Income Tax Act*, RSC 1985, c 1, or the *Excise Tax Act*, RSC 1985, c E-15, any such information within the Receiver's knowledge at the time of such request.

Duty to Provide Access and Co-operations to the Receiver

6. (i) The Debtor, (ii) all of its current and former directors, officers, employees, agents, accountants, legal counsel and shareholders, and all other persons acting on its instructions or behalf, and (iii) all other individuals, firms, corporations, governmental bodies or agencies, or other entities having notice of this Order including, without limitation, any authorized agent acting on behalf of MCMF in connection with any of MCMF's rights or authority arising from the October 20, 2022, Order granted by the Honourable Applications Judge B.W. Summers in these proceedings (all of the foregoing, collectively, being "**Persons**" and each being a "**Person**") shall forthwith advise the Receiver of the

existence of any Property in such Person's possession or control, shall grant immediate and continued access to the Property to the Receiver, and shall deliver all such Property (excluding Property subject to liens the validity of which is dependent on maintaining possession) to the Receiver upon the Receiver's request.

- All Persons shall forthwith advise the Receiver of the existence of any books, documents, securities, contracts, orders, corporate and accounting records, and any other papers, records and information of any kind related to the Property, and any computer programs, computer tapes, computer disks or other data storage media containing any such information (the foregoing, collectively, the "Records") in that Person's possession or control, and shall provide to the Receiver or permit the Receiver to make, retain and take away copies thereof and grant to the Receiver unfettered access to and use of accounting, computer, software and physical facilities relating thereto, provided however that nothing in this paragraph or in paragraph 8 of this Order shall require the delivery of Records, or the granting of access to Records, which may not be disclosed or provided to the Receiver due to the privilege attaching to solicitor-client communication or documents prepared in contemplation of litigation or due to statutory provisions prohibiting such disclosure.
- 8. If any Records are stored or otherwise contained on a computer or other electronic system of information storage, whether by independent service provider or otherwise, all Persons in possession or control of such Records shall forthwith give unfettered access to the Receiver for the purpose of allowing the Receiver to recover and fully copy all of the information contained therein whether by way of printing the information onto paper or making copies of computer disks or such other manner of retrieving and copying the information as the Receiver in its discretion deems expedient, and shall not alter, erase or destroy any Records without the prior written consent of the Receiver. Further, for the purposes of this paragraph, all Persons shall provide the Receiver with all such assistance in gaining immediate access to the information in the Records as the Receiver may in its discretion require including providing the Receiver with instructions on the use of any computer or other system and providing the Receiver with any and all access codes, account names, and account numbers that may be required to gain access to the information.

No Proceedings Against the Receiver

9. No proceeding or enforcement process in any court or tribunal (each, a "**Proceeding**"), shall be commenced or continued against the Receiver except with the written consent of the Receiver or with leave of this Court.

No Proceedings Against the Debtor or the Property

10. No Proceeding against or in respect of the Debtor concerning or relating to the Property shall be commenced or continued except with the written consent of the Receiver or with leave of this Court and any and all Proceedings currently under way against or in respect of the Property are hereby stayed and suspended pending further Order of this Court, provided, however, that nothing in this Order shall: (i) prevent any Person from commencing a proceeding regarding a claim that might otherwise become barred by statute or an existing agreement if such proceeding is not commenced before the expiration of the stay provided by this paragraph; and (ii) affect a Regulatory Body's investigation in respect of the debtor or an action, suit or proceeding that is taken in respect of the debtor by or before the Regulatory Body, other than the enforcement of a payment order by the Regulatory Body or the Court. "Regulatory Body" means a person or body that has powers, duties or functions relating to the enforcement or administration of an Act of Parliament or of the legislature of a Province.

No Exercise of Rights of Remedies

- 11. All rights and remedies of any Person, whether judicial or extra-judicial, statutory or non-statutory (including, without limitation, set-off rights) against or in respect of the Debtor or the Receiver in connection with or affecting the Property are hereby stayed and suspended and shall not be commenced, proceeded with or continued except with leave of this Court or the express written consent of the Receiver, provided, however, that nothing in this Order shall:
 - (a) empower the Debtor to carry on any business that the Debtor is not lawfully entitled to carry on;
 - (b) prevent the filing of any registration to preserve or perfect a security interest;
 - (c) prevent the registration of a claim for lien; or
 - (d) exempt the Debtor from compliance with statutory or regulatory provisions relating to health, safety or the environment.
- 12. Nothing in this Order shall prevent any party from taking an action against the Debtor where such an action must be taken in order to comply with statutory time limitations in order to preserve their rights at law, provided that no further steps shall be taken by such party except in accordance with the other provisions of this Order, and notice in writing of such action be given to the Receiver at the first available opportunity.
- 13. No Person shall accelerate, suspend, discontinue, fail to honour, alter, interfere with, repudiate, terminate or cease to perform any right, renewal right, contract, agreement, licence or permit in favour of or held by the Debtor in relation to or concerning the Property, except with the written consent of the Debtor and the Receiver, or leave of this Court. All persons having oral or written agreements or arrangements with the Debtor, including without limitation all computer software, communication and other data services, insurance, transportation, maintenance services, other services to the Debtor in connection with the Property are hereby restrained until further order of this Court from discontinuing, altering, interfering with, suspending or terminating the supply of such

goods or services as may be required by the Debtor or exercising any other remedy provided under such agreements or arrangements.

Receiver to Hold Funds

All funds, monies, cheques, instruments, and other forms of payments received or collected by the Receiver from and after the making of this Order from any source whatsoever, including without limitation the sale of all or any of the Property and the collection of any accounts receivable in whole or in part, whether in existence on the date of this Order or hereafter coming into existence, shall be deposited into one or more new accounts to be opened by the Receiver (the "Post Receivership Accounts") and the monies standing to the credit of such Post Receivership Accounts from time to time, net of any disbursements provided for herein, shall be held by the Receiver to be paid in accordance with the terms of this Order or any further order of this Court.

Employees

- 15. The Receiver shall not be liable for any employee-related liabilities, including any successor employer liabilities as provided for in section 14.06(1.2) of the BIA, other than such amounts as the Receiver may specifically agree in writing to pay, or in respect of its obligations under sections 81.4(5) or 81.6(3) of the BIA or under the *Wage Earner Protection Program Act*, SC 2005, c.47 ("WEPPA").
- 16. Pursuant to clause 7(3)(c) of the *Personal Information Protection and Electronic Documents Act*, SC 2000, c. 5, the Receiver shall disclose personal information of identifiable individuals to prospective purchasers or bidders for the Property and to their advisors, but only to the extent desirable or required to negotiate and attempt to complete one or more sales of the Property (each, a "Sale"). Each prospective purchaser or bidder to whom such personal information is disclosed shall maintain and protect the privacy of such information and limit the use of such information to its evaluation of the Sale, and if it does not complete a Sale, shall return all such information to the Receiver, or in the alternative destroy all such information. The purchaser of any Property shall be entitled to continue to use the personal information provided to it, and related to the Property purchased, in a manner which is in all material respects identical to the prior use of such information by the Debtor, and shall return all other personal information to the Receiver, or ensure that all other personal information is destroyed.

Limitations on Environmental Liabilities

- 17. (a) Notwithstanding anything in any federal or provincial law, the Receiver is not personally liable in that position for any environmental condition that arose or environmental damage that occurred:
 - i. before the Receiver's appointment; or

- ii. after the Receiver's appointment unless it is established that the condition arose or the damage occurred as a result of the Receiver's gross negligence or wilful misconduct.
- (b) Nothing in sub-paragraph (a) exempts a Receiver from any duty to report or make disclosure imposed by a law referred to in that sub-paragraph.
- (c) Notwithstanding anything in any federal or provincial law, but subject to sub-paragraph (a) hereof, where an order is made which has the effect of requiring the Receiver to remedy any environmental condition or environmental damage affecting the Property, the Receiver is not personally liable for failure to comply with the order, and is not personally liable for any costs that are or would be incurred by any person in carrying out the terms of the order,
 - i. if, within such time as is specified in the order, within 10 days after the order is made if no time is so specified, within 10 days after the appointment of the Receiver, if the order is in effect when the Receiver is appointed, or during the period of the stay referred to in clause ii below, the Receiver:
 - A. complies with the order, or
 - on notice to the person who issued the order, abandons, disposes of or otherwise releases any interest in any real property affected by the condition or damage;
 - ii. during the period of a stay of the order granted, on application made within the time specified in the order referred to in clause (i) above, within 10 days after the order is made or within 10 days after the appointment of the Receiver, if the order is in effect when the Receiver is appointed, by:
 - A. the court or body having jurisdiction under the law pursuant to which the order was made to enable the Receiver to contest the order; or
 - B. the court having jurisdiction in bankruptcy for the purposes of assessing the economic viability of complying with the order; or
 - iii. if the Receiver had, before the order was made, abandoned or renounced or been divested of any interest in any real property affected by the condition or damage.

Limitation on the Receiver's Liability

18. Except for gross negligence or wilful misconduct, as a result of its appointment or carrying out the provisions of this Order the Receiver shall incur no liability or obligation that exceeds an amount for which it may obtain full indemnity from the Property. Nothing in this Order shall derogate from

any limitation on liability or other protection afforded to the Receiver under any applicable law, including, without limitation, Section 14.06, 81.4(5) or 81.6(3) of the BIA.

Receiver's Accounts

- 19. The Receiver and counsel to the Receiver shall be paid their reasonable fees and disbursements, in each case, incurred at their standard rates and charges. The Receiver and counsel to the Receiver shall be entitled to the benefits of and are hereby granted a charge (the "Receiver's Charge") on the Property, which charge shall not exceed an aggregate amount of \$50,000.00 as security for their professional fees and disbursements incurred at the normal rates and charges of the Receiver and such counsel, both before and after the making of this Order in respect of these proceedings, and the Receiver's Charge shall form a first charge on the Property in priority to all security interests, trusts, deemed trusts, liens, charges and encumbrances, statutory or otherwise, in favour of any Person but subject to section 14.06(7), 81.4(4) and 81.6(2) of the BIA.
- 20. The Receiver and its legal counsel shall pass their accounts from time to time.
- 21. Prior to the passing of its accounts, the Receiver shall be at liberty from time to time to apply reasonable amounts, out of the monies in its hands, against its fees and disbursements, including the legal fees and disbursements, incurred at the normal rates and charges of the Receiver or its counsel, and such amounts shall constitute advances against its remuneration and disbursements when and as approved by this Court.

Funding of the Receivership

- 22. The Receiver be at liberty and it is hereby empowered to borrow by way of a revolving credit or otherwise, such monies from time to time as it may consider necessary or desirable, provided that the outstanding principal amount does not exceed \$50,000.00 (or such greater amount as this Court may by further order authorize) at any time, at such rate or rates of interest as it deems advisable for such period or periods of time as it may arrange, for the purpose of funding the exercise of the powers and duties conferred upon the Receiver by this Order, including interim expenditures. The whole of the Property shall be and is hereby charged by way of a fixed and specific charge (the "Receiver's Borrowings Charge") as security for the payment of the monies borrowed, together with interest and charges thereon, in priority to all security interests, trusts, deemed trusts, liens, charges and encumbrances, statutory or otherwise, in favour of any Person, but subordinate in priority to the Receiver's Charge and the charges set out in sections 14.06(7), 81.4(4) and 81.6(2) of the BIA.
- 23. Neither the Receiver's Borrowings Charge nor any other security granted by the Receiver in connection with its borrowings under this Order shall be enforced without leave of this Court.

- 24. The Receiver is at liberty and authorized to issue certificates substantially in the form annexed as Schedule "A" hereto (the "Receiver's Certificates") for any amount borrowed by it pursuant to this Order.
- 25. The monies from time to time borrowed by the Receiver pursuant to this Order or any further order of this Court and any and all Receiver's Certificates evidencing the same or any part thereof shall rank on a *pari passu* basis, unless otherwise agreed to by the holders of any prior issued Receiver's Certificates.
- 26. The Receiver shall be authorized to repay any amounts borrowed by way of Receiver's Certificates out of the Property or any proceeds, including any proceeds from the sale of any assets without further approval of this Court.

Allocation

27. Any interested party may apply to this Court on notice to any other party likely to be affected, for an order allocating the Receiver's Charge and Receiver's Borrowings Charge amongst the various assets comprising the Property

General

- 28. The Receiver may from time to time apply to this Court for advice and directions in the discharge of its powers and duties hereunder.
- 29. Notwithstanding Rule 6.11 of the *Alberta Rules of Court*, unless otherwise ordered by this Court, the Receiver will report to the Court from time to time, which reporting is not required to be in affidavit form and shall be considered by this Court as evidence. The Receiver's reports shall be filed by the Court Clerk notwithstanding that they do not include an original signature.
- 30. Nothing in this Order shall prevent the Receiver from acting as a trustee in bankruptcy of the Debtor.
- 31. This Court hereby requests the aid and recognition of any court, tribunal, regulatory or administrative body having jurisdiction in Canada or in any foreign jurisdiction to give effect to this Order and to assist the Receiver and its agents in carrying out the terms of this Order. All courts, tribunals, regulatory and administrative bodies are hereby respectfully requested to make such orders and to provide such assistance to the Receiver, as an officer of this Court, as may be necessary or desirable to give effect to this Order, to grant representative status to the Receiver in any foreign proceeding, or to assist the Receiver and its agents in carrying out the terms of this Order.
- 32. The Receiver be at liberty and is hereby authorized and empowered to apply to any court, tribunal, regulatory or administrative body, wherever located, for the recognition of this Order and for assistance in carrying out the terms of this Order and that the Receiver is authorized and

empowered to act as a representative in respect of the within proceedings for the purpose of having these proceedings recognized in a jurisdiction outside Canada.

- 33. The Plaintiff shall have its costs of this application, up to and including entry and service of this Order, provided for by the terms of the Plaintiff's security or, if not so provided by the Plaintiff's security, then on a substantial indemnity basis, including legal costs on a solicitor-client full indemnity basis, to be paid by the Receiver from the proceeds of the Property with such priority and at such time as this Court may determine.
- 34. Any interested party may apply to this Court to vary or amend this Order on not less than 7 days' notice to the Receiver and to any other party likely to be affected by the order sought or upon such other notice, if any, as this Court may order.

Filing

- 35. This Order is issued and shall be filed in Court of King's Bench Action No. 2203-13202.
- 36. The Receiver shall establish and maintain a website in respect of these proceedings at https://mnpdebt.ca/en/corporate/corporate-engagements/radient-technologies-inc the "Receiver's Website") and shall post there as soon as practicable:
 - (a) all materials prescribed by statue or regulation to be made publicly available; and
 - (b) all applications, reports, affidavits, orders and other materials filed in these proceedings by or on behalf of the Receiver, or served upon it, except such materials as are confidential and the subject of a sealing order or pending application for a sealing order.
- 37. Service of this Order shall be deemed good and sufficient by:
 - (a) serving the same on:
 - the persons listed on the service list created in these proceedings or otherwise served with notice of these proceedings;
 - ii. any other person served with notice of the application for this Order;
 - iii. any other parties attending or represented at the application for this Order; and
 - (b) posting a copy of this Order on the Receiver's Website and service on any other person is hereby dispensed with.

(collectively, the "Debtors") described in Exhibit "L" of the Affidavit of Brian Moskowitz dated March 13, 2023, together with any other personal property of the Debtors as may be agreed upon by the Receiver and the Debtors, including all proceeds thereof, for an order approving the proposed auction sale (the "Auction Sale") contemplated by Workingman Capital Corp. ("Workingman") in accordance with a Request for Offers to Purchase or Liquidation Proposals (the "ROP") for the sale of the purchased assets (the "Purchased Assets'), and vesting right, title and interest in and to the Purchased Assets to the end purchasers (the "Purchaser" or "Purchasers"); AND UPON HAVING READ the Limited Receivership Order dated March 21, 2023 (the "Receivership Order"), the Receiver's First Report to the Court and the Affidavit of Service; AND UPON HEARING the submissions of counsel for the Receiver, and those in attendance, and no one appearing for any other person on the service list, although properly served as appears from the Affidavit of Service, filed;

IT IS HEREBY ORDERED AND DECLARED THAT:

SERVICE

1. Service of notice of this application and supporting materials is hereby declared to be good and sufficient and time for service of this application is abridged to that actually given.

APPROVAL OF AUCTION SALE

2. The Auction Sale is hereby approved and the Receiver is hereby authorized and directed to take such additional steps and execute such additional documents, including the auction agreement (the "Auction Agreement") as may be necessary or desirable for completion of the Auction Sale and conveyance of the Purchased Assets to the Purchaser or Purchasers.

VESTING OF PROPERTY

- 3. Upon delivery of a Receiver's certificate to Workingman Capital Corp. substantially in the form set out in **Schedule "A"** hereto (the "Receiver's Closing Certificate"), all of the Debtors' right, title and interest in and to the Purchased Assets [listed in **Schedule "B"** hereto] shall vest absolutely in the name of the Purchasers (or their nominees), free and clear of and from any and all caveats, security interests, hypothecs, pledges, mortgages, liens, trusts or deemed trusts, reservations of ownership, royalties, options, rights of pre-emption, privileges, interests, assignments, actions, judgements, executions, levies, taxes, writs of enforcement, charges, or other claims, whether contractual, statutory, financial, monetary or otherwise, whether or not they have attached or been perfected, registered or filed and whether secured, unsecured or otherwise (collectively, "Claims") including, without limiting the generality of the foregoing:
 - (a) any encumbrances or charges created by the Receivership Order;
 - (b) any charges, security interests or claims evidenced by registrations pursuant to the Personal Property Security Act (Alberta) or any other personal property registry system;
 - and for greater certainty, this Court orders that all Claims affecting or relating to the Purchased Assets are hereby expunged, discharged and terminated as against the Purchased Assets.
- 4. Upon delivery of the Receiver's Closing Certificate, and upon filing of a certified copy of this Order, together with any applicable registration fees, all governmental authorities including those referred to below in this paragraph (collectively, "Governmental Authorities") are hereby authorized, requested and directed to accept delivery of such Receiver's Closing Certificate and certified copy of this Order as though they were originals and to register such transfers, interest authorizations, discharges and discharge statements of conveyance as may be required to

convey to the Purchaser or its nominee clear title to the Purchased Assets subject only to Permitted Encumbrances. Without limiting the foregoing:

- (a) the Registrar of the Alberta Personal Property Registry (the "PPR Registrar") shall and is hereby directed to forthwith cancel and discharge any registrations at the Alberta Personal Property Registry (whether made before or after the date of this Order) claiming security interests in the estate or interest of the Debtors in any of the Purchased Assets which are of a kind prescribed by applicable regulations as serial-number goods.
- In order to effect the transfers and discharges described above, this Court directs each of the Governmental Authorities to take such steps as are necessary to give effect to the terms of this Order and the Auction Agreement. Presentment of this Order and the Receiver's Closing Certificate shall be the sole and sufficient authority for the Governmental Authorities to make and register transfers of title or interest and cancel and discharge registrations against any of the Purchased Assets of any Claims.
- 6. No authorization, approval or other action by and no notice to or filing with any governmental authority or regulatory body exercising jurisdiction over the Purchased Assets is required for the due execution, delivery and performance by the Receiver of the Auction Sale and Auction Agreement.
- 7. For the purposes of determining the nature and priority of Claims, net proceeds from sale of the Purchased Assets (to be held in an interest bearing trust account by the Receiver) shall stand in the place and stead of the Purchased Assets from and after delivery of the Receiver's Closing Certificate and all Claims shall not attach to, encumber or otherwise form a charge, security interest, lien, or other Claim against the Purchased Assets and may be asserted against the net proceeds from sale of the Purchased Assets with the same priority as they had with respect to the Purchased Assets immediately prior to the sale, as if the Purchased Assets had not been sold and remained in the possession or control of the person having that possession or control immediately prior to the sale. Unless otherwise ordered (whether before or after the date of this Order), the Receiver shall not make any distributions to creditors of net proceeds from sale of the Purchased Assets without further order of this Court, provided however the Receiver may apply any part of such net proceeds to repay any amounts the Receiver has borrowed for which it has issued a Receiver's Certificate pursuant to the Receivership Order.
- 8. Workingman and the Purchasers shall not, by completion of the Auction Sale, have liability of any kind whatsoever in respect of any Claims against the Debtor.

- Upon completion of the Auction Sale, the Debtors and all persons who claim by, through or under the Debtors in respect of the Purchased Assets, and all persons or entities having any Claims of any kind whatsoever in respect of the Purchased Assets, shall stand absolutely and forever barred, estopped and foreclosed from and permanently enjoined from pursuing, asserting or claiming any and all right, title, estate, interest, royalty, rental, equity of redemption or other Claim whatsoever in respect of or to the Purchased Assets, and to the extent that any such persons or entities remain in the possession or control of any of the Purchased Assets, or any artifacts, certificates, instruments or other indicia of title representing or evidencing any right, title, estate, or interest in and to the Purchased Assets, they shall forthwith deliver possession thereof to the Purchaser (or its nominee).
- 10. The Purchaser (or its nominee) shall be entitled to enter into and upon, hold and enjoy the Purchased Assets for its own use and benefit without any interference of or by the Debtors, or any person claiming by, through or against the Debtors.
- 11. The Receiver is directed to file with the Court a copy of the Receiver's Closing Certificate forthwith after delivery thereof to Workingman.

MISCELLANEOUS MATTERS

- 12. Notwithstanding:
 - (a) the pendency of these proceedings and any declaration of insolvency made herein;
 - (b) the pendency of any applications for a bankruptcy order now or hereafter issued pursuant to the *Bankruptcy and Insolvency Act*, R.S.C. 1985, c.B-3, as amended (the "BIA"), in respect of the Debtors, and any bankruptcy order issued pursuant to any such applications;
 - (c) any assignment in bankruptcy made in respect of the Debtors; and
 - (d) the provisions of any federal or provincial statute:

the vesting of the Purchased Assets in the Purchaser or Purchaser pursuant to this Order shall be binding on any trustee in bankruptcy that may be appointed in respect of the Debtors and shall not be void or voidable by creditors of the Debtors, nor shall it constitute nor be deemed to be a transfer at undervalue, settlement, fraudulent preference, assignment, fraudulent conveyance, or other reviewable transaction under the BIA or any other applicable federal or provincial legislation, nor shall it constitute oppressive or unfairly prejudicial conduct pursuant to any applicable federal or provincial legislation.

- 13. The Receiver, Workingman, the Purchaser or Purchasers and any other interested party, shall be at liberty to apply for further advice, assistance and direction as may be necessary in order to give full force and effect to the terms of this Order and to assist and aid the parties in closing the Auction Sale.
- 14. This Honourable Court hereby requests the aid and recognition of any court, tribunal, regulatory or administrative body having jurisdiction in Canada or in any of its provinces or territories or in any foreign jurisdiction, to act in aid of and to be complimentary to this Court in carrying out the terms of this Order, to give effect to this Order and to assist the Receiver and its agents in carrying out the terms of this Order. All courts, tribunals, regulatory and administrative bodies are hereby respectfully requested to make such order and to provide such assistance to the Receiver, as an officer of the Court, as may be necessary or desirable to give effect to this Order or to assist the Receiver and its agents in carrying out the terms of this Order.

and service on any other person is hereby dispensed with.





THIRD AFFIDAVIT OF BRIAN MOSKOWITZ

Sworn on July 10, 2023

I, Brian Moskowitz, of the City of Toronto, in the Province of Ontario, SWEAR AND SAY THAT:

- I am the President of the Plaintiff, Moskowitz Capital Mortgage Fund II Inc. ("MCMF"), and as such,
 I have a personal knowledge of the facts and matters hereinafter deposed to except where stated
 to be on the basis of information and belief, and, where so stated, I verily believe the same to be
 true.
- I previously filed an Affidavit of Default, dated December 12, 2022, (the "First Moskowitz Affidavit") and an Affidavit dated March 12, 2023, (the "Second Moskowitz Affidavit") in this action. In this Affidavit, unless otherwise stated, I adopt capitalized naming conventions established in both the First Moskowitz Affidavit and Second Moskowitz Affidavit.
- This Affidavit is filed by MCMF in support of its Application seeking to extend the scope of MNP Ltd.'s (the "Receiver") appointment to deal with certain chattel property assets of the Debtors in these proceedings.
- 4. As is detailed in the First Moskowitz Affidavit and the Second Moskowitz Affidavit, MCMF is a secured lender to the Debtors who defaulted on financial obligations owing to MCMF in 2022. MCMF commenced these proceedings seeking to enforce its security against the Debtors' Lands. In early 2023, MCMF determined that sales proceeds from the forced sale of the Lands would likely be insufficient to retire the Indebtedness owing to MCMF. Accordingly, MCMF obtained a Limited Receivership Order from this Honourable Court on March 21, 2023, pursuant to which the Receiver was empowered to deal with certain of the Debtors' equipment.
- A portion of the Debtors' equipment subject to the security of MCMF was deliberately excluded from the scope of the Limited Receivership Order so as to enable the Debtors to attempt to continue

- to carry on business during the pendency of real and personal property sales processes facilitated through these proceedings.
- On May 30, 2023, the Receiver obtained a Sale Approval and Vesting Order permitting the Receiver to sell the equipment of the Debtors included in the scope of the Limited Receivership Order by auction.
- The sales processes for both the Debtors' Lands and the Debtors' equipment included in the Limited Receivership Order have not yet concluded.
- I have remained in contact with Dr. Steven Splinter ("Splinter"), the Chief Executive Officer of Radient Technologies, subsequent to the granting of the Limited Receivership Order.
- On or about June 15, 2023, Splinter verbally advised me, and I verily believe it to be true, that the Debtors have laid off all but one of their employees.
- 10. On or about June 15, 2023, Splinter further advised me that electrical and water utilities to one of the Debtors' two facilities sited on the Lands would shortly be discontinued due to non-payment. For clarification, the Debtors had long since discontinued payment of utility accounts at the other of the Debtors' two facilities, thus causing MCMF to take over payment of those accounts.
- 11. On or about June 30, 2023, Splinter verbally advised me, and I verily believe it to be true, that the Debtors' only remaining employee is in the process of destroying the remaining inventory of the Debtors' cannabis products.
- Beginning on July 4, 2023, MCMF began directly making payments to the Debtors' remaining utility providers' accounts to prevent the discontinuance of water and electrical utilities.
- On or about July 8, 2023, Splinter verbally advised me, and I verily believe it to be true, that the Debtors have been unsuccessful in obtaining additional financing, despite efforts to do the same.
- 14. In light of the above, MCMF seeks to enable the Receiver to sell the remaining equipment of the Debtors that had been excluded from the scope of the Limited Receivership Order.
- 15. A schedule containing what MCMF understands to be the remaining equipment of the Debtors is attached as Exhibit "A" to this Affidavit. This schedule was generated by MCMF by isolating assets identified in an equipment list previously provided to MCMF by the Debtors that had been excluded by MCMF when it generated the schedule set out in Exhibit "L" to the Second Moskowitz Affidavit.
