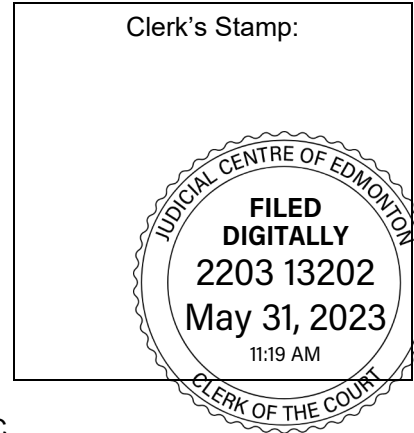

UPON THE APPLICATION of MNP Ltd. (the "Receiver"), solely in its capacity as Court-Appointed Receiver of 1631807 Alberta Ltd. and Radiant Technologies Inc. (the "Debtors"), for an Order, *inter alia*, sealing the Confidential Appendices to the Receiver's First Report to the Court (the "First Report") submitted by the Receiver and dated May 23, 2023 (the "Confidential Appendices"); AND UPON having read the Receivership Order granted March 21, 2023, and all application materials, filed; AND UPON hearing from counsel for the Receiver and all other interested parties present; **IT IS HEREBY ORDERED AND DECLARED THAT:**

1. The time for service of notice of this application is hereby abridged to that given, and service is deemed good and sufficient.
2. The Confidential Appendices to the First Report shall be sealed on the Court file until October 30, 2023, notwithstanding Division 4 of Part 6 of the *Alberta Rules of Court*. The Applicant may apply for an extension of this date in the event the sale of the Debtors' assets does not close or for such other commercially sensitive reason that requires the Confidential Appendices to remain sealed.
3. The Confidential Appendices shall be kept sealed and confidential, and shall not form part of the public record, and the Clerk of the Court is hereby directed to file the sealed Confidential
