**BANKRUPTCY ORDER**

Upon reading the application of The Bank of Nova Scotia, a creditor (the "**Applicant**"), of Richmond Medical Inc., of the City of London, in the Province of Ontario, filed November 19, 2024, and the Affidavit of Cian McDonnell sworn October 24, 2024 and all Exhibits thereto;

And upon hearing submissions of counsel for The Bank of Nova Scotia, no one else appearing although properly served as appears from the Affidavit of Service of Kevin Wilson sworn November 25, 2024, filed;

And it appearing to the Court that the following act of bankruptcy has been committed:

- a) Richmond Medical Inc. has ceased to meet its liabilities generally as they have become due in that, among other things, it has failed to pay its obligations to the Applicant.

1. IT IS ORDERED that the said Richmond Medical Inc., of the City of London, in the Province of Ontario is hereby adjudged bankrupt and a bankruptcy order is hereby made against the said Richmond Medical Inc.
2. IT IS FURTHER ORDERED that MNP Ltd., of the City of London, in the Province of Ontario be and is hereby appointed trustee, without security, of the said bankrupt.

3. IT IS FURTHER ORDERED that the costs of the applicant creditor shall be paid out of the estate of the bankrupt upon taxation thereof.
