THE RECEIVER GIVES NOTICE AND DECLARES THAT:

1. On March 26, 2021, MNP Ltd. was appointed as Receiver (the "Receiver") to the assets of SEC and 9058 (jointly the "Debtors"), pursuant to section 243 of the *Bankruptcy and Insolvency Act*, by an Order (the "Order") rendered by the Honorable Justice Gaetan Dumas, of the superior Court of Quebec for the District and the Division of Saint-François, (the "Court"). I. BACKGROUND

- 2. Société en commandite Industriel-Léger ("SEC") is a limited partnership set up for the purpose of managing and operating real estate holdings located in Magog and Sherbrooke, Quebec.
- 3. 9058-0150 Quebec Inc. ("9058") is the general partner of SEC and is owned by Paul Kanwal.
- 4. On January 28, 2021, Kanwal Inc. and 9058 filed an Application for an Initial Order under the *Companies' Creditors arrangement Act* ("CCAA"). An initial order was rendered on the following day, granting a stay of proceedings in respect of 9058 for an initial delay for 10 days, which was extended subsequently until March 19, 2021. No further extension was granted.



II. ASSETS

5. In virtue of the Order, the Receiver is authorized to take possession of all the property of the Debtors, including but not limited to, the following industrial or commercial buildings:
