

FORM 87 NOTICE AND STATEMENT OF RECEIVER

Subsection 245(1) and 246(1) of the Bankruptcy and Insolvency Act

IN THE MATTER OF THE RECEIVERSHIP OF SOLVAQUA INC.

of the City of Calgary, in the Province of Alberta

THE RECEIVER GIVES NOTICE AND DECLARES THAT:

On August 19, 2022 (the "Receivership Date"), the Court of Queen's Bench of Alberta (the "Court") granted an Order (the "Receivership Order") appointing MNP Ltd. as Receiver and Manager (the "Receiver"), without security, over all of the current and future assets, undertakings and properties of every nature and kind whatsoever, and wherever situate, including all proceeds thereof (the "Property") of Solvaqua Inc. ("Solvaqua" or the "Company"). The Receivership Order was granted following an application by Arnaki Ltd. ("Arnaki"), who has a secured claim of approximately \$7.9 million (the "Arnaki Claim") pursuant to various general security agreements (the "Arnaki Security").

BACKGROUND

Solvaqua was incorporated in the Province of Alberta on June 19, 2019. The Company was in the business of providing proprietary wastewater management solutions based on nanopolymerization technology (the "Technology") that allowed isolated areas to reuse water, thereby decreasing freshwater usage. Solvaqua's business plan involved implementing the Technology in foreign jurisdictions.

At the Receivership Date, Solvaqua had very limited operations and did not have any designated office space. The Company previously operated out of premises located at 300, 340 Midpark Way SE, Calgary, Alberta and had a registered office of 1000 – 250 2nd Street SW, Calgary, Alberta. Mr. Chris Tesarski is the sole director and shareholder of Solvaqua.

ASSETS

At the Receivership Date, the Company was holding the following Property in connection with the Technology:

1. Cash held in financial institutions totaling approximately \$237;

- 2. Equipment and chemicals (the "Equipment"), as further described below1; and
- 3. Scientific research and experimental development tax credits the value of which is currently unknown.

The Equipment consists of three large units and six small units in various stages of completion that are being held at the premises of the equipment manufacturer, Rotating Right, in Leduc, Alberta. One additional small unit was sent overseas for use in a client demo. Economic Development Canada ("EDC") took possession of two additional large units (also held at Rotating Right's premises), pursuant to an insurance settlement with the Company. Rotating Right has indicated that they have a claim for approximately \$560,000 for unpaid work on the Equipment and storage fees for the Equipment (the "Rotating Right Claim"). The Receiver has requested supporting information to further assess the Rotating Right Claim.

The Receiver understands that Solvaqua Inc. has not completed any required Canada Revenue Agency filings. The Company's former principal has advised that Solvaqua may be entitled to claim various SR&ED Credits related to expenditures made in developing the Technology, however, the amount of any eligible SR&ED Credits is unknown.

CREDITORS

On July 27, 2022, Arnaki issued a demand letter and a Notice of Intention to Enforce Security to Solvaqua pursuant to Section 244 of the *Bankruptcy and Insolvency Act (Canada)*, which was successfully served on August 4, 2022 following which the Receivership Order was granted. The Receiver has requested an independent legal opinion with respect to the validity and enforceability of the Arnaki Security, which is currently underway.

In addition to the Arnaki Claim, Solvaqua listed additional unsecured creditors with claims totaling approximately \$1.4 million (including the Rotating Right Claim).

The Receiver understands that Canada Revenue Agency will have a deemed trust claim for unpaid payroll source deductions related to one employee who worked for the Company between October 2021 and February 2022. The amount of this claim is still being determined.

The list of known creditors of the Company is attached as "Schedule 1".

PLAN OF ACTION
