

SOLVAQUA INC. – IN RECEIVERSHIP ESTATE NO. 25-95331 SECOND INTERIM REPORT OF THE RECEIVER AS AT AUGUST 19, 2023

Subsection 246(2) of the Bankruptcy and Insolvency Act

BACKGROUND

On August 19, 2022 (the "Receivership Date"), the Court of King's Bench of Alberta, as it is now known (the "Court"), granted an Order (the "Receivership Order") appointing MNP Ltd. as Receiver and Manager (the "Receiver"), without security, over all of the current and future assets, undertakings and properties of every nature and kind whatsoever, and wherever situate, including all proceeds thereof (the "Property") of SolvAQUA Inc. ("Solvagua" or the "Company").

The Company was in the business of providing proprietary wastewater management solutions based on nanopolymerization technology (the "**Technology**") that allowed isolated areas to reuse water, thereby decreasing freshwater usage. SolvAQUA's business plan involved implementing the Technology in foreign jurisdictions. At the Receivership Date, SolvAQUA had very limited operations and did not have any designated office space.

ASSETS

The Property included various equipment and chemicals used to implement the Technology.

On October 20, 2022, the Court granted an Order approving a sale and investor solicitation process (the "SISP"), pursuant to which the Receiver solicited offers for the sale of the Property, or investment in all or part of the Company's business and approved a transaction (the "Stalking Horse Transaction") contemplated in the stalking horse asset purchase agreement between the Receiver and 2464525 Alberta Ltd.

The SISP has now been completed. The Receiver scheduled an application for July 13, 2023 (the "July 13 Application") to seek, among other relief, approval of the Stalking Horse Transaction, as amended. The July 13 Application was ultimately adjourned to allow for further negotiations between various interested parties related to claims against selected equipment and with respect to the assignability of certain insurance claims, which were included in the Stalking Horse Transaction (the "Disputed Matters").
