



Terms and Conditions: MNP LTD “Starbucks Gift Card Giveaway” Facebook/Instagram/LinkedIn Contest

All winners selected must follow the rules and present a proof of following the [MNP Debt Facebook Page](#) via Facebook direct messaging and following the MNP Debt Instagram Page via Instagram direct messaging. The LinkedIn page via LinkedIn does not require to be followed to be eligible for the contest.

Contest begins on October 1, 2021 and closes October 8, 2021 (the “Contest Period”). All entries must be received by MNP Ltd. (“MNP”) prior to October 8, 2021 by 11:59 pm CST. The winner will be selected on October 12, 2021. No purchase is necessary. Three (3) Starbucks gift cards to be won, two valued at \$100 each, and one valued at \$500.
